On-The-Wall Director Chris Tanner highly recommends *Works in Progress*, a LCAL invitational for artists Anne-Marie Bracken, Leisa Corbett, Leslie Nauta, Melissa Pierson, Linda Rodriguez and Sharon Templeton at the David Adler Center for Music and Art on Libertyville. The opening reception will be February 7 6-8:00 pm, though that may coincide with a snowstorm. Something not to be missed, however, is Gallery Night, February 19 7-8:30 pm. Each artist will stand next to a representative piece and discuss the artistic journey, vision or technique behind it. Gallery Nights are very well attended and bring a lot of exposure to the artists and the art league.

Adler has been doing a February LCAL on and off since 2012 and has recently updated what they call their Gallery Series (6 per year) with these interesting discussions and strong publicity that are bringing in exciting groups of artists. Adler handles all the arrangements and carefully curates the show, and the Lake County Art league general fund covers the \$250 cost of this invitational. About 35 of our members have shown a collection of their work at Adler this way, but these six artists are the first to do a Gallery Night. Competition for this opportunity is so strong that we will not have a chance for another until 2022, and we will need to sell Adler on a compelling theme they can use to draw a crowd. We'll get started on that soon.
