# The Black Market 2026-2027 Season

**\*\* By signing the first page, member acknowledges they are a member of Event Co-Op PMA and having fully read Submission and *The Black Market* rules and the member covenant for the PMA and agrees to abide by all rules pertaining to this event for the entire season. Subsequent reservations in the same season do not need another submission; however, the rules remain in effect for any events member attends during this season. This is a private agreement & covenant between Event Co-Op PMA (the "PMA") and you the Member. It is the intention of the men/women in this Private Agreement to resolve any disagreements pertaining to this agreement & covenant which will be handled privately and are excluded from the law of any other forum, by the laws of the State of South Dakota, without regard to the jurisdiction in which any action or special proceeding may be instituted and free from all suits.**

## **Rules, Agreement & Covenant**

1. **Regular Members:** Regular returning members typically have the first right of refusal for their space each month. Please be sure to reserve those spaces right away or those spaces can be reassigned.
2. **Direct Sales:** Direct sale agents are allowed to be only one per company. If you reserve only a couple event dates and another agent with your company is interested in the entire season, you may lose the space to the other member.
3. **Reservations:** You may reserve more than one month at a time. Booth honorariums are due 30 days in advance or upon reservation. Members may provide booth honorarium on a debit/credit card they can submit to be kept on file for a 4% per booth fee. All members are required to provide a debit/credit card upon submission to be utilized if they fail to arrive to set up at an event and did not provide their honorarium in advance with their reservation.
4. **Cancellations:** Cancellations allowed if we have a minimum 10-day notice prior to the event and members will receive a credit for a future event and will be rolled forward 1 time. After that, cancellations will result in forfeit of your honorarium. We will not send any reimbursements. Booths not already covered for further than 30 days out can be fully cancelled with no honorarium due. All cancellations must be relayed with a phone call!
5. **Space Assignments:** Members (set up at 5+ events per season) may have more consideration when we are assigning booth spaces. Part-time members may choose their space if it does not affect the full-time members. We will do our best to get everyone into a space that is comfortable to them.
6. **Setup:** Members are not allowed to setup beyond designated times and will not be allowed to setup once the event starts. Members that arrive after the start of the event without a prior phone call for permission forfeit their space and are not eligible for reimbursement. This is distracting to all other members.
7. **Teardown/Packing Up:** Teardown must ***be completed by 8PM on Sunday Evenings***. Members must consider what to bring so late teardown is not an issue. Members are not allowed to tear down early on either Sat or Sun. Packing up will begin at 3pm and not a single minute before that. Members violating this rule may not be allowed to setup at any future events. Staying past 8pm will result in a \$50 extra fee.
8. **Parking:** There is designated member parking, violators will receive a \$50 parking notice due that day.
9. **Check or Money Order payable to: Event Co-Op Trust** This is due 30 days prior to the event. We often have a waiting list of members who hope to attend the events, so reserving your space early is recommended. Any member who has not provided the booth honorarium for the event 30 days in advance may forfeit his/her space and may be moved to another spot or the waiting list.
10. **Security:** The Black Market will do our best to keep your objects secure while at our event. However, we are not responsible for lost or stolen objects. We suggest all valuables be removed nightly from the event and brought back with you each day. We also suggest ropes, blankets, and other such things to cover and rope off your booths while you are not present. You are responsible for your objects at this event for the duration of the event.
11. **Non-Sufficient Honorariums [checks]:** Are subject to a \$40.00 additional honorarium and new form of honorarium.
12. **There are NO REIMBURSEMENTS.** However, if you cannot make it to a event, but give a minimum 10-day notice, we will apply your honorarium towards a future event.
13. **No Call No Show:** If a member fails to call or arrive for an event, there is NO reimbursement.
14. **Bad Weather:** In the event of severe weather that prevents members from traveling safely to the events, members need to call to advise they will not be able to setup, but no reimbursement will be given.
15. **Cancelled Event:** If the event is cancelled due to bad weather or for any reason, we will transfer your booth honorarium to next month, or another event date that works in that season.
16. **Object Pricing:** We operate as a private event and do not dictate object pricing for any members. Each member is allowed to decide and price their own objects accordingly. We will not get involved in pricing disputes!
17. **Offensive Objects:** Items displayed must be appropriate for all ages; any materials that are deemed offensive, contain nudity, or are otherwise unsuitable for children are strictly prohibited, or must concealed and only shown to selective individuals. Complaints will be addressed at the event and member agrees to comply.
18. **Refusal of entry/asked to leave:** We have the right to refuse a space or to ask any members to leave the event at any time, for any reason with no reimbursement.
19. **Insurance:** It is hereby agreed and understood that I, the exhibiting member will carry the necessary insurance covering myself, my workers and all items, property displayed, used and possessed by me, the member, in the Expo Building, and or other areas of the W. H. Lyons Fairgrounds during any of 2026-2027 The Black Markets, and hereby exonerates Event Co-Op PMA, the W.H. Lyons Fairgrounds, SE Fair Association, Sponsors, workers, other members, and helpers from any bodily injuries to myself or my helpers/workers, damages, theft or losses while setting up, attending, while in transit to and from, or anytime during any of the 2026-2027 Events.
