Rules:

- ✓ Sēb's Recreation Center is a drop-in program. Sēb's Recreation Center is not a daycare.
- ✓ All participants are not required to stay in the building during drop-in hours.
- ✓ Any child under the age of 12 must be accompanied by a person 18 years of age or older.
- ✓ Any child under the age of 5 must be constantly supervised by a person 18 years of age or older.
- ✓ Any child between the ages of 12-17 may use the center unaccompanied after a parent/guardian 18 years of age or older comes with them to the center and signs a release waiver.
- ✓ Participants are required to follow Sēb's Recreation Center rules. You may request a copy of these rules at any time.
- ✓ Appropriate behavior and dress are expected at all times.
- ✓ If participants do not follow the rules, they will be subject to Sēb's Recreation Center disciplinary actions.
- ✓ Parents may be contacted to pick up their child. If no one is available to do so, the child will be required to wait outside.
