# President's Report

Zug began a discussion about the reinstatement fees that have rolled over to new owners. # **Treasurer's Report**

Deby reported that the revenues for HOA dues at the end of April are \$28,459. We had budgeted \$29,000 which puts us under budget by \$541. The fishing revenues, so far this year, are \$3,105. We had budgeted \$2,900 which makes fishing \$205 over budget. The HOA general fund income to expenditures under budget status includes all capital improvement costs to date.

Deb requested articles by June 1<sup>st</sup> for the next newsletter which will contain Board Member election information. There will be 4 open positions for the SV Board. Biographical information will be needed by June 30<sup>th</sup> for the ballot.

#### **Activities Committee Report**

Roni reported that 43 people turned out for the Fish Stocking, Volunteer Breakfast and Clean Up Day on May 7<sup>th</sup>. There were people busy everywhere. Fallen trees were cut up, trash was picked up around the lakes, vacuuming/dusting in the pavilion and many paint brushes were at work staining the shade structure. There was lots of fun and a good time had by all.

The next activity will be the Smoke Off on June 18<sup>th</sup>. She met with Jeff Perry and Shane Wildeman to make plans and rules for judging. It will be a fund raiser for the Kid's Fishing Derby.
