## OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING DECEMBER 3, 2024

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Dan Materi, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

A "moment of silence" was held to respectfully remember and honor Dennis Hummel who has recently passed away. Dennis Hummel served as Emmons County Commissioner for fifteen years.

State's Attorney, Joseph M. Hanson, administered the Oath of Office to James Gartner, Craig Miller and James Vander Vorst, newly elected members of the Emmons County Commission.

The November, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Materi motioned to approve the minutes of the November 7, 2024 regular meeting with an amendment that Commissioner Eberle was appointed to serve on the Canvassing Board for the General Election. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the agenda. Seconded by Commissioner Materi. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

## Old and Unfinished Business:

Commissioner Miller motioned authorizing the Chairman, County Auditor, States Attorney and Highway Supervisor to sign the North Dakota Department of Transportation annual maintenance certification for county federal aid projects. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Information was received from Tanya Wieler, Independent Human Resource Consultant, regarding policy and procedures in the county's employee handbook for employees who are active volunteer firefighters/EMS, and whether permission be granted to these employees to respond to calls during regular working hours. According to Mrs. Wieler, most county's allow employees to go out on calls; but she highly recommends having a policy in place where she provided a sample policy that the county could implement. If there's no policy in place, the assumption is that employees are allowed to go on calls if the supervisor gives permission, but the time is not paid. Commissioner Miller suggested placing this item on the six county meeting agenda held on December 10, 2024 to see how other counties are handling this. Commissioner Miller also commented that he would like the commission to go through and update the employee handbook.

Commissioner Gartner motioned to submit a claim on behalf of the county to the North Dakota Insurance Reserve Fund in regards to the Daniel Mock equipment damage. Seconded by Commissioner Materi. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Miller motioned to approve the application submitted by Commissioner Materi for a permit to maintain the existing fence at 33 + feet from the center of 89<sup>th</sup> St. SE in Section 28, Township 131, Range 76. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Miller and Vander Vorst. Motion carried. Materi abstained from voting due to conflict of interest.

Commissioner Materi motioned to deny the voucher in the amount of \$840.00 from Mark Bruun for mowing the right of way within the City of Braddock. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

### New Business:

Commissioner Materi motioned authorizing the Chairman and the County Auditor to sign the County Deed conveying the county's interest in tax deed property as follows:

Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the plat to replace the easement that was vacated and replat Lot U of that plat into smaller lots to be deeded to adjoining lot owners. Part of the NW ¼ of Section 28, Township 130, Range 75 West, Emmons County, ND. Seconded by Commissioner Materi. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

At 9:30 A.M., a motion was made by Commissioner Miller to enter into executive session for attorney consultation and to discuss attorney work product and the ongoing adversarial administrative proceeding in ND Public Service Commission Case No. PU-22-391 and the appeal filed by Emmons County in Burleigh County District Court, Case No. 08-2024-CV-00624, and other potential related appeals and actions pursuant to N.D.C.C. 44-04-19.1 and 44-04-19.2. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The executive session adjourned at 10:05 A.M. and the meeting reconvened in regular session.

Russell Lawler, Road Superintendent, reported on activities for the county road department.

Discussed restructuring road department employees to stretch resources. No action was taken as the 2025 budget has already been finalized and adopted, and an equipment operator position still needs to be filled.

The interviewing committee consisting of Russell Lawler, James Gartner and Dan Materi will conduct interviews for construction engineering for road project BRJ-0015(021), PCN 23706, replacement of Structure No. 15-131-31.1 located three miles north and nine miles east of Strasburg, ND, Section 4 & 5, Township 131, Range 74 at 9:00 A.M. on December 30, 2024.

Michael R. Rivinius, PE and Jon Martin, PE, representing Wold Engineering, P.C., appeared to discuss road projects, and the contractors pay estimate for the structure replacement project at the Wolbaum Pit Road. Contractor, Midwest Contracting, LLC, is requesting a time extension for this project due to the availability of the 16' X 12' RCBC which affected the time frame of completion. After discussion, Commissioner Vander Vorst motioned to waive 100% of the liquidated damages for road project CP 15-121-03.0. Seconded by Commissioner Materi. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

James Woodland appeared to discuss the section line road on the NW ¼ of Section 7, Township 136, Range 78. This road always ran straight through on 55<sup>th</sup> St. SW, but over the years the road became blown shut and washed out and the citizens are now driving on his property instead of the original road. Mr. Woodland asked for permission to run a fence where the section line road ran originally to keep the citizens from encroaching on his property. According to GIS Coordinator, Josh Odden, there are no easements nor right of ways recorded on this road. The commission concluded to table this matter pending further information.

GIS Coordinator, Josh Odden, gave a demonstration on the new tax program for tax statements on ITax.

The board reviewed appointments of Officials and Board Members with expiring terms effective January 1, 2025.

The Six County Commission meeting hosted by Logan County will be held on December 10, 2024 at 10:00 A.M. at the White Maid in Napoleon.

Commissioner Vander Vorst motioned to approve the applications and issue liquor licenses to South Central Threshing Association, Linton Country Club and Mike Kelsch d/b/a Cattail Resort. Seconded by Commissioner Materi. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the application for abatement of taxes for parcel #52-0006-00418-000 for tax year 2024. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to grant a raffle permit to the Linton Country Club. Seconded by Commissioner Materi. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to enter into an agreement with Burleigh County for providing emergency management services for Emmons County. This agreement is for one year beginning upon the effective date of January 1, 2025 and terminating on December 31, 2025.

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The October, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Eberle motioned to approve the minutes of the October 1, 2024 regular meeting and the October 18, 2024 special meeting. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Miller motioned to approve the agenda with the addition of road issues. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

# Old and Unfinished Business:

There was no old and unfinished business.

# New Business:

At 9:15 A.M., a public hearing was held on the appraisals of property acquired by the county through tax deed proceedings. Any objections to the minimum sale price would have to be made by Officials of Cities/Township in which the property is located. No one appeared to object to the minimum sale price as determined by the County Commissioners.

Tabled was the Annual Maintenance Certification for county federal aid projects.

Commissioner Materi motioned to respond to the USDA Farm Service Agency with written notification that Emmons County requires county producers who plan to construct grain storage bins on their farmsteads and owned land are required to obtain building permits and site plans with our local authority. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the building permit for Lyle Kenner (Northern Veterinary Service) for a 50 X 100 attached addition on the west side of existing building on 2.80 A Tract in the NW ¼ of Section 17, Township 132, Range 76. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the application and issue a liquor license to Cody Schulthess/R Place By The Bay LLC. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

The Commission reviewed the hydraulic analysis and recommendation for a culvert replacement installation by Wold Engineering, P.C. Following discussion, Commissioner Materi motioned to attempt to repair the bridge. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried. Present was Mike Schwab.

Reported was damage to Dan Mock's farm equipment where he hit a rock and ruts in the field which he claims to be caused by the road department while working on the temporary grade raise road project on 17<sup>th</sup> Ave SE., Section 13, Township 136, Range 75. Auditor Ohlhauser will contact the county's agent for North Dakota Insurance Reserve Fund.

Commissioner Hulm motioned to table the application submitted by Commissioner Materi for a permit to maintain an existing fence at 32+ feet from the center of 89<sup>th</sup> St. SE in Section 28, Township 131, Range 76. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum and Miller. Motion carried. Materi abstained from voting due to conflict of interest.

### OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING OCTOBER 1, 2024

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present.

The Pledge of Allegiance was recited.

The September, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Hulm motioned to approve the minutes of the September 3, 2024 regular meeting and the September 5, 2024 special meeting. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the agenda with the addition of survey information, road department step/grade salary discussion, intersection on 7<sup>th</sup> Avenue SE and 89<sup>th</sup> Street SE, other road gravel maintenance and ditch mowing. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

#### New Business:

Chairman Magrum brought forward the cutting of regrown grass in the ditches suggesting that the county be lenient on the October 1<sup>st</sup> deadline due to the windy and dry weather, and the landowners use caution and make their own judgements on getting the ditches mowed in the next week or two.

Commission Materi presented a survey by Wold Engineering, P.C. dated September 20, 2024, showing the location of the two fences located between Sections 28 and 33 in Township 131, Range 76, 5<sup>th</sup> P.M. Commissioner Materi received a letter from the county in October, 2021 asking him to remove his fence due to encroaching on a 75-foot right-of-way. The fence was not removed by Commissioner Materi because there are records filed in the Recorders office that show that there's a 60-foot right-of-way easement on this road, and he also has documentation dated back in 2006 where the county commissioners supported for the fence to be allowed within the sixty-foot right-of-way.

Commissioner Materi reported that Burleigh County Commissioner, Brian Bitner, has agreed to speak to the commission regarding a permit or variance that Burleigh County created for fence encroachments along natural lakes and creeks. The NDDOT has a process for allowing encroachments for areas where there's a creek or lake to bring the fence up out of the right-of-way, but not in the clear zone. Derek Pfeifer, NDDOT Local Government Engineer, suggested asking the county to issue a permit as it was approved back in 2006, and file the permit with the survey. No action was taken. The Commission will consult with the States Attorney.

As advertised, at 9:15 A.M. a public hearing was held to consider the Petition for discontinuance of the road beginning at a point on the Northwest corner of the Northwest quarter (NW ¼) of Section Three (3), thence due East 1,584 feet, thence due South 5,280 feet, sixty (60) feet wide along the old road approximately in the middle of Section Three (3), Township One Hundred Thirty-Three (133), Range Seventy-Seven (77), Emmons County, North Dakota. An Easement on the Northeast quarter (NE ¼) of Section Ten (10), beginning at a point from the Southeast corner of the Northeast quarter (NE ¼) of Section Ten (10), thence due northwesterly sixty (60) feet along the old road 2,640 feet of Section Ten (10), Township One Hundred Thirty-Three (133), Range Seventy-Seven (77), Emmons County, North Dakota. Present for the hearing was Therese Beitelspacher. With no other comments having been received, nor appearances either in favor of or opposed to the discontinuance of the road, Chairman Magrum closed the public hearing at 9:30 A.M. The commission agreed to consult with States Attorney, Joseph M. Hanson, for an opinion before they make any ruling.

Commissioner Materi motioned to transfer the county's NDIRF and State Fire and Tornado insurance policies to Hazelton Insurance Agency for the years 2025-2026. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

VA Officer, Brad Huber, appeared and gave his quarterly report.

Commissioner Eberle motioned to enter into a Joint Powers Agreement with the North Dakota Association of Counties (NDACO) for collection and distribution of 9-1-1 fees. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Materi and Miller. "NO": Magrum. Motion carried. Present for discussion was Sheriff Gary Sanders, Aaron Birst, NDACO Executive Director, and Jason Horning, Next Generation 9-1-1 Program Manager for NDACO.

Russell Lawler appeared to update the Commission on road project SC-1536(061), culvert replacement located 0.5 miles north and 5 miles east of Strasburg, ND, and also asked the Commissioners if his employment start date as Road Superintendent could be extended due to the November 1, 2024 completion date of this road project. The Commission agreed to extend the employment start date to November 4, 2024.

Francis Krumm, Francis Gabriel and Ken Werlinger appeared for clarification of the road project on 22<sup>nd</sup> Ave SE and 97<sup>th</sup> St. SE, Township 129, Range 74 as discussed at the September 3, 2024 Commission meeting.

According to Francis Krumm, there were eight culverts replaced, instead of nine, as indicated at the September 3, 2024 meeting. Two culverts were replaced going south on 22<sup>nd</sup> Ave SE, two culverts were replaced going east on 97<sup>th</sup> St. SE, and four culverts were replaced south on 22<sup>nd</sup> Ave SE. Through an open records request for the road department time cards made by Francis Krumm, records show that these eight culverts installed only took two and a half days, instead of two and a half weeks as indicated at the September 3, 2024 Commission meeting. The time card records showed that on March 19, 2024, four employees worked five hours for a half day. On April 22, 2024, three employees worked ten hours and on April 23, 2024, three employees worked another ten hours for a total of two and a half days.

Francis Gabriel reported that in the fall of 2014, the county road on 22<sup>nd</sup> Ave SE, Township 129, Range 74 became very difficult to travel due to lack of maintenance, large rocks, and water running over the road, so he attended the county commissioner meeting on February 3, 2015 along with Russell Schumacher to request maintenance on the road. At the March 3, 2015 county commission meeting, the commissioners approved a motion to repair the county road in between section 2 and 3, extending in section 11 and in-between sections 13 and 14 in Township 129, Range 74. During the summer of 2015, the road department employees pulled up the shoulders and Francis Gabriel did many hours of disking and digging out large rocks. He also removed trees growing in the ditch and on the shoulders next to his property. The road department returned to put a crown on the road. Francis Gabriel stated that he was told that the culverts would be replaced the following year, but due to other primary roads needing attention and lack of time, they didn't get replaced until 2024.

County Extension Agent, Acacia Stuckle, provided a quarterly narrative report.

Commissioner Miller addressed the intersection on 7<sup>th</sup> Avenue SE and 89<sup>th</sup> Street SE where there's a sixinch drop with piled up stone. The intersection on 3<sup>rd</sup> Avenue SE and 92<sup>nd</sup> Street SE was also addressed due to a drop in the road.

There was some discussion relative to the grade/step salary structure for the road department where the commission suggested to wait for the new road superintendent to come on board for further discussion.

The list of real estate property forfeited to the county due to delinquent taxes, pursuant to NDCC 57-28-10 was reviewed by the board. Commissioner Materi motioned to set the minimum sale price for each property for the amount of the total taxes due. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to adopt the following Resolution:

### RESOLUTION APPROVING AGREEMENT WITH THE COUNTY OF EMMONS AND LEWIS AND CLARK REGIONAL DEVELOPMENT COUNCIL FOR THE PURPOSE OF REGIONAL LIVESTOCK PLANNING GRANT ACCEPTANCE

WHEREAS, the County of Emmons on behalf of its County Commission desires to enter into an Agreement with the Lewis and Clark Regional Development Council to apply for a Regional Livestock Planning Grant which the County is eligible. The Agreement further provides the County with identification of suitable locations for rural economic development, including animal feeding operations, agricultural processing and storage facilities and other agriculture related development.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Emmons County, North Dakota as follows:

- 1. Following completion of the site analysis process the county will review county and township zoning and land use regulations. The county may update any zoning or land use regulations based on recommendations of site analysis process. Additionally, the county will provide information to townships of said county so they may review and update zoning and land use regulations as they see fit.
- 2. That Erin Magrum, the Chair of the County of Emmons, and Marlys Ohlhauser, the Auditor, are authorized to sign the Agreement.

Commissioner Eberle motioned to change the November regular meeting date to November 7, 2024. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the building permit for CHS, Inc. for addition of 1.6M bushel covered ground pile storage and receiving pit, Section 27, Township 131, Range 76. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the building permit for Jay Bren to move a 32 X 28 pole barn onto property for cold storage located at Triangle Tract in the NW ¼ of Section 29, Township 133, Range 76. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

David Moch and Stephanie Doolittle were present and provided a handout with information on Ballot Measure #4.

The board recessed until 5:30 P.M.

At 5:30 P.M., a public hearing was held on the proposed preliminary budget for calendar year 2025 at which time written or oral comments from the public will be considered concerning the proposed annual budget.

## OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S SPECIAL MEETING SEPTEMBER 5, 2024

Chairman Erin Magrum called the meeting to order at 8:00 A.M., with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The reason for the meeting was to discuss the road superintendent position.

Present was Russell Lawler who stated that the commission came with an offer of an annual salary of \$78,073.00, and his initial thought was that the position should be at \$85,000.00. After visiting with Tanya Wieler, Independent Human Resource Consultant specializing in working with local governments, who assisted Emmons County with the interviewing process, he agreed to accept \$80,000.00 and the use of the company pickup for driving back and forth to work. The reason for wanting to use the pickup is because currently there is no office space at the county shop for the road superintendent, so the county pickup basically becomes their mobile office. Another convenience is in case of an emergency situation, it would save time for the road superintendent by being able to drive directly to the emergency site.

There was some discussion in regards to installing GPS in all the county vehicles.

Chairman Magrum stated that recently the commission held discussions about how the county vehicle should be going to the shop at night and not leaving again until the morning, unless there's a special circumstance. Also mentioned was with a probation process, you have the opportunity to understand if the newly hired employee is a fit for the position, and this usually means some kind of pay restriction should be part of the probation period. The original motion approved on September 3, 2024 was to offer Russell Lawler \$78,073.00, and we should stick to that motion. After the six-month probation period, the board can rediscuss the salary.

Commissioner Hulm motioned to accept Russell Lawler's counter offer of \$80,000.00 annual salary with permitted use of the county vehicle in accordance with the employee handbook. Seconded by Commissioner Miller. There was discussion regarding the grade/step salary structure that was adopted by the commissioners last fall for the road department, and trying to stay consistent with this structure for all the employees. The commission telephoned Tanya Wieler for her opinion where she commented that because she works with pay plans often, she always thinks that it's wise to take a number directly from the grade/step compensation plan. She suggested a grade ten, step five at an annual salary of \$79,634.00, which is the closest step to the offer of \$80,000.00. It's always best to maintain the integrity of the pay plan to use the number directly if you can, rather than using a rounded number. There's no right or wrong answer, it's a matter of moving forward and begin to build some consistency. Following this discussion, a roll call vote was taken. Roll Call "NO": Eberle, Hulm, Magrum, Materi and Miller. Motion failed.

Following discussion, the commission voted on the motion. "NO": Eberle, Hulm, Magrum, Materi and Miller. Motion failed.

Commissioner Hulm motioned to offer the position of road superintendent to Russell Lawler for an annual salary of 79,634.00, which is a grade ten, step five of the compensation pay plan, with permitted use of the county vehicle in accordance with the employee hand book. Seconded by Commissioner Materi. Roll Call "YES": Hulm, Materi, and Miller. "NO": Eberle and Magrum. Motion carried.

Russell Lawler accepted the employment offer and will begin employment on October 7, 2024.

Commissioner Miller motioned to approve the claim voucher for Comstock Construction, Inc. for the courthouse project in the amount of \$267,439.50. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the claim voucher for Karen Hulm for salary in the Clerk of Court/Recorders office in the amount of \$1,348.23. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

There being no further business before the board, Chairman Magrum adjourned the meeting. The meeting adjourned at 9:15 A.M.

### OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING SEPTEMBER 3, 2024

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The August, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Miller motioned to approve the minutes of the August 6, 2024 regular meeting and the August 20, 2024 special meeting. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the agenda with the addition of road issues. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Discussion was held regarding the public nuisance on 8080 Highway 83 South, Linton. The Commission and States Attorney, Joseph M. Hanson, reviewed photos of the property after the clean up by Arrow Service Team and agreed that the Judgment has been satisfied. The matter was closed.

#### New Business:

Lewis & Clark Development Group Executive Director, Brent Ekstrom, appeared to provide an update on programs. The Lewis and Clark Development Group is the umbrella organization for four entities that provide opportunities to develop North Dakota's economy and communities through flexible financing and support for businesses and affordable housing. The Group is the go-to resource for business lending, affordable housing, and community building in North Dakota. Brent Ekstrom touched on the meat and poultry intermediary lending program (MPILP) that provides low interest loans for meat and poultry processing businesses. Another program introduced was the Regional Livestock Development and Planning Grant Program through the North Dakota Department of Agriculture that assists counties with livestock development planning, including animal feeding operations, agricultural processing and storage facilities and other agricultural related development.

Commissioner Materi motioned to appoint Lyle Kenner to serve on the Emmons County Public Health Board. Term is effective August 1, 2024 for a five-year term. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the Utility Permit for South Central Regional Water District to install one-inch rural waterline crossing on 12<sup>th</sup> Ave SE from NW ¼ of Section 18, Township 133, Range 75 to the NE ¼ of Section 13, Township 133, Range 76. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the Utility Permits for BEK Communications to bury fiber optic cable on 74<sup>th</sup> St. SE and 9<sup>th</sup> Ave SE and to bury fiber optic cable on 83<sup>rd</sup> St. SE and 84<sup>th</sup> St. SE. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Miller reported that he received a phone call from a landowner regarding water hemlock weed, so he asked Emmons County Weed Officer, CJ Pearce, to provide some information on this weed to the Commission. CJ Pearce reported that water hemlock is a perennial wetland plant that is native to North America and doesn't believe that the weed is a problem in Emmons County. The stems and leaves of the weed increase in palatability immediately after being sprayed with herbicide. The most poisonous part of the plant is the root system, particularly the tubers. Cattle graze in the lower part of the plant and this is where the highest concentration of poison is found. If ingested by cattle, they can die from seizing and their respiratory system could collapse. There's no treatment for this. CJ Pearce has had conversations with the Emmons County Weed Board who are weighing options on putting water hemlock on the list of noxious weeds.

Nancy Deis, Extension Agent, Agricultural and Natural Resources, reported that she contacted the weed specialist at NDSU to find out more information on water hemlock. The specialist stated that water hemlock could be found in every county if you looked hard enough; but, no other county in ND has made the plant a noxious weed yet. The specialist explained that a noxious weed is considered a weed that causes economic harm and she didn't feel that water hemlock was doing that. Nancy Deis suggested that the Weed Board create a cautious weed list and allow landowners to cost share from the cautious weed list versus making water hemlock a noxious weed. The weed is controllable with 2, 4-D, glyphosate control or DuraCor herbicide.

Discussion (by phone) was held with Tanya Wieler, Independent Human Resource Consultant specializing in working with local governments, who assisted Emmons County with the interviewing/hiring for the road superintendent position. Tanya Wieler reported that the committee interviewed five candidates that varied in terms of their experience with roadwork and management. The committee narrowed the candidates down and one candidate they felt rose to the top. The commission asked Tanya Wieler to reach out to that candidate to make an employment offer, contingent upon a quality reference check, and base the salary off of the grade/step compensation structure. Later in the meeting, Tanya Wieler telephoned into the meeting and reported that the candidate that the committee would be recommending to the commission for hire is Russell Lawler, who seemed to really have the best combined background of an equipment operator experience and management experience overall. Tanya Wieler performed reference checks and received three very positive feedbacks on his job performance from the three references that were contacted.

Commissioner Hulm motioned to offer Russell Lawler the position of Road Superintendent using the grade and step compensation structure at a grade ten, step four salary of \$78,073.00, with a six-month probationary period and the salary being reviewed upon this probation period. Seconded by Commissioner Miller. Roll Call "YES": Hulm, Magrum, Materi and Miller. "NO": Eberle. Motion carried. During discussion, Chairman Magrum addressed a letter placed in Russell Lawler's file that doesn't concern him with his creditability; but the concern is that the commission created a precedent that the county is not supposed to hire people that have any imperfections in their employee file, and now there's someone with an imperfection in their file. This happened with the previous road superintendent. "He was a candidate who came with a letter in his file at his previous employment and now we have the same issue." Chairman Magrum stressed that "so long as this is understood and agreed upon that it's about the consistency."

Commissioner Eberle brought forward the fence on 89<sup>th</sup> Street SE on the S ½ SW ¼ of Section 28, Township 131, Range 76 where he had conversations with Brandon Beise and Paul Benning from the Local Government Division who said that the fence is not acceptable, and the county should take measures to get the fence off the right-of-way. Commissioner Eberle also talked to an Insurance Underwriter with NDIRF who also felt that the fence should be moved.

Comments were made by Commissioner Hulm and Commissioner Miller regarding other fences that are encroaching throughout the county; but, Commissioner Eberle commented that beings the fence was surveyed, and an encroachment was found, it's on public record.

States Attorney, Joseph M. Hanson, stated that there might be other encroachments in the county; but, according to an Attorney Generals' opinion, the county doesn't have a duty to examine every single right-of-way. It's one thing if the county isn't aware of an encroachment, but once the county has become aware, then there's a potential for liability to the county. If there was an accident and it showed that the fence contributed to the damage or the injury, and the county allowed the fence to be on the right-of-way of the clear zone, more than likely the county would assume some liability. Hanson stressed that the liability questions are not black and white as it would depend on the facts.

Joseph M. Hanson also stated that there are records going back to 2006 in the county commission meeting minutes regarding this fence, and Dan Materi had a letter from an engineering firm where they outlined how the fence could be allowed by the Commission. The Commissioners back then did not approve a variance nor report anything, there was just some discussion held in the meeting.

Commissioner Miller suggested tabling the matter until more information is gathered.

Commissioner Materi asked Commissioner Eberle if he's traveled on the state highways and observed where there are creeks, lakes or waterways and how the fences are on those wetland areas? "According to the state, they grant variances to those landowners because there's no other way for them to fence down in those wetland swamps."

Commissioner Materi read encroachment exceptions from an email that was sent by Brandon Beise, Local Government Division, that stated "on rare occasions the county could permit encroachments within the right of way. The NDDOT suggests that the county draft a document with the State's Attorney and get signatures from all parties. The document should clearly explain the location, conditions, and responsibilities of the parties involved."

Chairman Magrum asked Joseph M. Hanson if he has any verification that the fence is encroaching and Hanson replied that he doesn't have any proof. Chairman Magrum stated that in his opinion there's going to have to be some kind of verified proof that the fence is encroaching, and then find out if there was any reason for it to be encroached and if anything was recorded.

Commissioner Eberle made a motion that Dan Materi remove his fence off the right-of-way. Motion died due to lack of second.

Chairman Magrum suggested that the matter be tabled until Commissioner Eberle or Commissioner Materi produce the survey from Wold Engineering, P.C., and to verify if there was a valid variance issued.

Commissioner Miller inquired about blading the road between 56<sup>th</sup> Street SE and 3<sup>rd</sup> Avenue SE as the pasture cannot be accessed. The commission concluded that it's not the responsibility of the county to maintain the quality of this road as they only maintain certified roads.

Commissioner Hulm brought forward a road matter on Township 129, Range 74 which he checked into after receiving some reports. The road located on 22<sup>nd</sup> Ave SE going south off the highway, the first mile is on a section line where there were three (3) culverts installed. The road then turns and goes east about a quarter of a mile and then south another mile where there were six (6) culverts installed. Overall, there was a total of nine (9) culverts installed on this two and a quarter mile stretch. This road project was constructed in April of 2024. Commissioner Hulm shared his frustration and stated that the only commissioner that knew about this project was commissioner Eberle. The other four commissioners were never made aware of this road project. "How can one commissioner go ahead and have the right to approve a project like this?" Commissioner Hulm stated that it took several county employees to complete this project in April of 2024 when they should have been blading the roads.

Commissioner Eberle commented that this road was brought up at commissioner meetings before when Michael Lawler was road superintendent where he promised the landowners that he would install those culverts, and this was never done. This road was brought up again when Francis Krumm was road superintendent and the culverts didn't get installed. Commissioner Eberle then mentioned this road matter to Skyler Prellwitz who looked into this road.

Chairman Magrum received requests for installing a culvert on the intersection of 74<sup>th</sup> St. SE and Center Avenue as water runs over the road when it rains. This culvert installation will be put on the project list for the new road superintendent.

Commissioner Materi motioned to approve the building permit for Billy Stubbs for adding (6) antennas, (6) RRUS, and (2) HCS 2.0 hybrid/COCPs at the 285' CL. Proposing a 10 X 15 lease area with an 8 X 10 platform included inside the lease area on Section 25, Township 131, Range 76. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the building permit for Loren VanderVorste to erect a 200 X 60 storage building on the NW ¼ of Section 20, Township 129, Range 76. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the building permit for Joseph R. Nowers for grading, prep site for a mobile home to be moved in and to erect a 30 X 30 detached garage on .69 A Tract in W ½ SW ¼ NW ¼ SE ¼ SE ¼ & E ½ E ½ SE ¼ NE ¼ SW ¼ SE ¼ of Section 8, Township 130, Range 79. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the building permit for Gerald and Denise Van Beek to construct a 75 X 35 home with a 28 X 28 attached garage on Lot 9 of the Rice Lake Subdivision located in the N ½ of Section 4, Township 129, Range 75, West of the Fifth Principal Meridian. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Materi and Miller. Motion carried. Magrum abstained from voting due to conflict of interest.

Commissioner Materi motioned to approve the building permit for Bill Geiger/Bev Anton to place a 20 X 8 shipping container that will be sided on Lot 1 of Beaver Bay Subdivision, Section 23, Township 132, Range 79. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Chairman Erin Magrum called the meeting to order at 9:00 A.M., with Commissioners Gary Hulm, Dan Materi and Craig Miller being present. Absent was Don Eberle. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The reason for the meeting was to discuss a plan of action on repairing the Cattail Bay road on 89<sup>th</sup> St. SE. There was discussion on having a couple of road department employees (David Krumm and David Ellingson) repair some soft spots and shoulder pulling to the road starting next week with an estimated time line of two weeks. One concern addressed was the timing may interrupt potato harvesting with Sea View Farms as they plan on starting harvest on September 5<sup>th</sup>. After discussion, Commissioner Materi motioned to hire Dennis Glass and Brian Rudy as part time seasonal temporary employees to assist in the maintenance of the Cattail Bay road, 89<sup>th</sup> St. SW, for a wage of \$26.00 per hour. Seconded by Commissioner Miller. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to appoint Garlin Schmidt as project manager on the Cattail Bay Road, 89<sup>th</sup> St. SW, maintenance repair project. Seconded by Commissioner Miller. Roll Call "YES": Hulm, Materi and Miller. "NO": Magrum. Motion carried.

Commissioner Hulm motioned to hire outside trucking services for gravel hauling as long as they provide proof of a valid CDL and valid insurance at a compensation rate of \$150.00 per hour, and to appoint John Ibach to be the project manager/contact person. Seconded by Commissioner Miller. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the Plat of Tracts 16-1, 16-2, 16-3 & 16-4, parcels of land in the SE ¼ of Section 16, Township 131, Range 76 of the Fifth Principal Meridian, Emmons County. Seconded by Commissioner Miller. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The July, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Miller motioned to approve the minutes of the July 2, 2024 regular meeting. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the agenda with the addition of right-of-way discussion. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Discussion was held regarding the public nuisance on 8080 Highway 83 South, Linton. States Attorney, Joseph M. Hanson, presented a cleanup proposal from Arrow Service Team in the amount of \$23,600.00 for labor and equipment to clean up all debris around the residence yard and haul off for disposal, and \$3,000.00 for full-service tow and haul away including three autos total.

Commissioner Eberle motioned to hire Arrow Service Team to clean up the property at 8080 Highway 83 South, Linton. Motion died due to lack of second.

After further discussion, Commissioner Eberle motioned to accept the cleanup bid for \$23,600.00 from Arrow Service Team to clean up the property at 8080 Highway 83 South, Linton. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried. Noted was this motion excluded the tow and haul away of the three vehicles.

#### New Business:

Commissioner Hulm motioned to approve a Water Access and Use Easement between Steven B. Lowery and Doris J. Lowery and Emmons County for the use, access, and electricity needed to serve the water utility provided for county business and public use at Langelier's Bay for a sum of \$300.00 per year for three (3) years (2024, 2025, 2026). Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to enter into a contract with CREA for Superintendent of Schools Services for land annexations and other duties as listed in the NDCC. Term of the agreement is from July 1, 2024 through June 30, 2025. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Jim Wagner reappeared regarding road maintenance on the Cattail Road (89th St. SW).

Skyler Prellwitz resigned his position as Road Superintendent for Emmons County with his last day of employment being on August 2, 2024. The position will be advertised with the application deadline of August 19, 2024. The board reviewed the job description and made some necessary changes. Interviews will be conducted by Tanya Wieler, Dakota Dynamics Human Resources Consultant for Local Government, Commissioner Materi and Commissioner Miller.

Stephanie Doolittle appeared asking to be part of the road maintenance discussion and reported that 68<sup>th</sup> Street, near 12<sup>th</sup> Avenue SE is used heavily by numerous landowners and needed maintenance and gravel. At the end of June this year, the road department moved in and started repairing areas between 12<sup>th</sup> Avenue SE and 14<sup>th</sup> Avenue SE where they spent days laying in a nice layer of gravel. On June 27, 2024, they received over an inch of rain. Ten minutes after the rain stopped, they heard equipment move pass their farm. A semi-trailer was heading west to highway 83 on the newly repaired road. The road was a complete mess and the county had to repair the deep ruts that were made. Mrs. Doolittle expressed that users of these county roads need to use common sense and we all need to do our part too. "We all need to work together with county leadership to come up with solutions for maintaining 1,200 miles of roads." Mrs. Doolittle stated that she's grateful for the Emmons County Commissioners that we have and with the extra hours spent beyond monthly meetings researching issues.

Stephanie Doolittle also addressed the petition being circulated to recall Chairman Magrum and respectfully asked that those collecting signatures reconsider. Mrs. Doolittle expressed how Chairman Magrum's knowledge of the Constitution and responsibilities of local government are vital to this Commission as our private property rights are being challenged daily. Magrum's leadership and the work of the Commission has made sure that maximum setbacks were placed to protect the safety of property owners living near wind towers. A solar moratorium was put into place by the Commissioners to protect concerned landowners from a company trying to secure 5,000 acres of land west of Linton. The Commission amended their Industrial Conditional Use Permit application to protect landowners from eminent domain. They approved a setback distance of 1.5 miles from a residence and 3 miles from a city to protect citizens from a high-pressure CO2 pipeline carrying hazardous and deadly gas through our county. "Chairman Magrum has proven his commitment to Emmons County and it's

residents through his years on the Commission." "With all that is going on in our country, we cannot afford to compromise our leadership!"

David Moch was present to support Chairman Magrum and the Commissioners on the road issues and mentioned that he served on a board for years and realizes how tough it is to put up with people, problems and taking the heat for things. Mr. Moch talked about his road that hadn't been graveled for ten years and two years ago the road was getting down to the black dirt. After calling the county and talking nice and having excellent communication and patience, the road was graveled. Everyone is guilty of pulling a horse trailer, semitrailers or SUV. We're speeding and throwing gravel in the ditches. The roads will all get graveled eventually, we all need to be patient. Also suggested was for the road superintendent to inform the public of where they are working by posting information on the county website or social media.

David Moch complimented Chairman Magrum for getting the county through some hard times and stressed how lucky the county is to have someone young on the board to fight for us. "We need more young people on boards. Magrum has done more than what people realize and the rest of the board stands up for our property rights."

Winston Heifort, construction manager for Comstock, explained the change proposal for additional masonry work to the front steps of the courthouse. The original plan that was drawn included the main steps and the left side of the steps, but did not address the right side of the steps where the masonry is giving away. After discussion, Commissioner Hulm motioned to approve the contractor's proposal for changing the contract price for the front steps of the courthouse. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve Comstock's contractor proposals to change the contract price for door infill and stage lighting for the courthouse project. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Bridgette Gullickson along with several other landowners appeared to discuss road maintenance. Bridgette Gullickson commented that they only see a blade in their area once a year and according to other county road superintendents that she spoke with are able to make six to seven rounds with the blade on their county roads between the months of April – October. Landowners questioned what changed over the years because the road are deteriorating and there's grass and weeds growing in the middle of the roads. Landowners are looking for a solution or a plan from the county.

The board recessed for lunch and reconvened at 1:15 P.M.

Tony Holzer and Deloris Volk appeared on behalf of the Kidder Emmons County Senior Meal Program. Tony Holzer explained that Emmons and Kidder have held a partnership for many years and recently there was a dispute regarding Linton employee's hours, which led to Kidder County cutting off services to Emmons County on July 31, 2024 without giving any notice.

Deloris Volk stated that the dispute was a matter of the employee hours that were cut, and when the Linton employees asked for their hours back, Kidder County said no, packed up all the food, computer, fax machine and the food sealer, and had plans on coming back to get the appliances. Tony Holzer then changed all the door locks.

Conversations were held with the State and also with Burleigh County. In the midst of trying to figure out if Emmons County wants to join Burleigh County or go on their own with meals on wheels and offering meals to the seniors, Kidder County called a meeting wanting Emmons County to meet with them this Thursday at 1:30 pm in Steele, ND.

Tony Holzer explained the reason for appearing before the Commissioners is because there are tax dollars involved and also some money in the bank that only Kidder County has control of. Mr. Holzer and a few others from the Linton Senior Center are going to the meeting on Thursday to meet with Kidder County to try and reason with them. Chairman Magrum stated that he will be attending this meeting also.

Discussion was held on compensating Skyler Prellwitz for unused annual and sick leave where the consensus of the board was to follow the employee handbook.

Commissioner Eberle motioned to appoint John Ibach as the Project Manager for road project number SC-1536(061), culvert replacement .5 mile north and 5 miles east of Strasburg. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

The Commissioners agreed to extend the time for the contractor to haul gravel for the county for another week or two.

Commissioner Miller motioned to approve the renewal building permit for One Way Wireless Construction on behalf of T-Mobile for adding six antennas, six RRUS and two HCS 2.0 hybrid/COVPs at 285' CL Ground. Proposing a 10 X 15 lease area with an 8 X 10 platform included inside the lease area on the NE ¼ NW ¼ RW on Section 25, Township 131, Range 76. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the building permit for Randy and Nancy Bosch to build a 60 X 40 storage building on Tract A, Section 14, Township 132, Range 79. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the Utility Permit for South Central Regional Water District to install a 10-inch rural waterline crossing 78<sup>th</sup> St. SE, Section 33, Township 133, Range 74 onto the west side of 19<sup>th</sup> Ave SE, NW ½ of Section 5, Township 132, Range 74. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Miller motioned to approve the building permit for Nate Keller to construct a 300 X 80 farm shop for Sea View Farms on Section 4, Township 130, Range 79. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the building permit for Ryan Nagel to erect a 42' grain bin on Section 30, Township 134, Range 76. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the building permit for John Colton Beck and Madison Shae Vander Vorst for building a basement and placing a modular home on the SE ¼ of Section 14, Township 133, Range 77. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the building permit for Billy Stubbs for removing three antenna's, one hybrid cable, one COVP and adding three antenna's, one hybrid cable and three RR to the existing wireless facility on the SW ¼ of Section 25, Township 135, Range 77. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the application and issue a Liquor License to the Quencher Bar for a one-day event held on August 18, 2024 at the Strasburg Rodeo Grounds, portion SW ¼ of Section 36, Township 131, Range 76. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the building permit for Brandon and Nicole Sehn to erect a 64 X 50 residence with a 28 X 34 attached garage on the N ½ of N ½ of SE ¼ on Section 11, Township 132, Range 78. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the Utility Permit for KEM Electric Cooperative to install facilities on the county right-of-way on Section 23, Township 132, Range 79, from intersection of Sturgeon Alley and Beaver Bay TRL SW, west 240 feet to a point where KEM will trench across Sturgeon Alley north to south. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to approve the Utility Permit for South Central Regional Water District to install a two-inch rural waterline crossing 69<sup>th</sup> St. SE from N ½ Section 20, Township 134, Range 77 to S ½ Section 17, Township 134, Range 77. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle brought forward his concerns about the liability pertaining to right-of-way encroachments and stated that according to the state, fences are to be off the county right-of-way or landowners are breaking the law and causing a liability to the county and the tax payers.

Commissioner Eberle motioned to grant permission to Extension Agent, Acacia Stuckle, for traveling out of state to attend the 2024 National Association of Extension 4-H Youth Development Professionals Annual Conference on October 13-18, 2024. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

The board reviewed a preliminary budget proposal for the year 2025 prepared by County Auditor/Treasurer, Marlys Ohlhauser, for the general fund and each special revenue fund with detailed breakdown of estimated revenues and expenditures for the preceding year, current year and ensuing year and the appropriations requested. Commissioner Hulm motioned to approve the preliminary budget for the year 2025 with an amendment to apply the maximum number of mills to the emergency levy and the capital project levy. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

### UNOFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING JULY 2, 2024

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The June, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Hulm motioned to approve the minutes of the June 3, 2024 regular meeting. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the agenda. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Discussion was held regarding the public nuisance on 8080 Highway 83 South, Linton. Chairman Magrum reported that Advanced Cleaning and Restoration looked at the property, but never responded back. The Commission reviewed photos shared by Kevin Evenson showing his clean up progress. Chairman Magrum suggested asking the City of Linton about assisting the county road department on cleaning up the property. Present for the meeting was James Gartner who stated that he would visit with Tyler Gross, Linton City Director of Public Works.

#### New Business:

Commissioner Miller, speaking on behalf of David Moch, asked that the road department keep an eye on the half mile road leading to the Braddock Cemetery in order for it to be usable during funerals. Chairman Magrum suggested that communication take place with the road department whenever there's a funeral.

Bob Bauman appeared to request that the county rip/rap and gravel the access road on the section line dividing Sections 27 and 26, Township 131, Range 75 for approximately 400 feet. According to Bob Bauman, his dad, sister and himself signed an agreement for the county to fix the road; but in his opinion only half of the work was completed where the county hauled some rock and put two loads of gravel on the road. Mr. Bauman presented photos of the road where the Bauman's hired Russ Lawler Construction for rip/rapping and graveling their portion of the access road to the residence, and also shared photos of the road that the county fixed where it washed away. Mr. Bauman asked that the Commissioners fix the road as promised, or he will hire a contractor and bill the county.

Previous Road Superintendent, Francis Krumm, was present and provided a history of what took place with this road. The county contracted with an engineer to determine the elevation the road should be to match the elevation of the residence. The access road should be raised approximately 4.5 feet in elevation. Because the estimate costs for building up the road was \$60,000.00, the Commissioners and Bauman's agreed to rip rap the west side of the access road from 88<sup>th</sup> St. SE to the residence, and add 2" of gravel to the road surface. The county was responsible for rip/rapping and graveling the portion of the access road that is located on the section line (approximately 400 feet). The Bauman's were responsible for rip/rapping and graveling the remaining of the access road to the residence as this becomes a private drive. The county hauled in thirteen loads of rock and applied a gravel base on top. The county did the west side which is county right-of-way, the county did not do the private drive. The west side is a deep lake that takes the bulk of the wind and the bulk of the water at an angle. Within a month, water was going over that road. Per the Agreement with the Bauman's, the county agreed to do a partial fix as agreed by both parties.

Also referenced was a letter sent by States Attorney, Joseph M. Hanson, to Sidney A. Gross on April 19, 2021 where Hanson stated that he advised the commission that the county has no duty or obligation to maintain a private road at public expense nor does the county have the duty to improve or maintain any road, which is not part of the designated county road system.

Next item on the agenda was road issues in the southern part of Emmons County where citizens came from all areas of the county to address their concerns. Commissioner Eberle stated that he's been getting a lot of phone calls as the citizens don't feel that the roadwork is getting done throughout the county. Commissioner Eberle has been asked by the citizens to do something about the roads so he decided to bring everyone together.

Commissioner Eberle heard comments about the management where the citizens feel that if the Road Superintendent was living in Emmons County, he could associate with the people more. When Skyler Prellwitz was asked if he's going to move to Emmons County, his reply was "no".

Jim Vander Vorst was present and commented that the roads have been declining the past few years and are becoming unpassable.

Other comments and concerns addressed by the citizens was that they haven't seen a blade for some time and the roads only get bladed once or twice per year. First Responders are unable to get to their calls due to the condition of the roads. Roads are not passable for the Ambulance. School bus routes should be first priority for the safety of the children. Comments were made about the possibility of hiring contractors to help with the

blading. Questions regarding state mandates for gravel specifications were asked. Concerns were addressed regarding lack of leadership for the equipment operators. Another concern addressed several times was the county pickup used for traveling to and from Bismarck/Mandan for picking up parts where Commissioner Materi expressed that this stops immediately.

Several citizens made suggestions to the commissioners that there needs to be a plan for the roads and it needs to be followed through.

Present was Danielle Stoppler who addressed her opinion on the matter and stated that the last several years there's been no accountability by the commissioners and no accountability for any of the workers. "When Skyler was hired he was asked to move to Emmons County and the commission did not enforce this. Over the last two years, Skyler's been driving the county pickup continuously to and from Bismarck. He's been told by the commission that he's not to drive this vehicle to go back and forth to work. Every parts place in Bismarck has a route coming to Emmons County. We have an overpriced parts runner in a \$60,000 to \$70,000 pickup that the tax payers are paying fuel for. Skyler Prellwitz was given extra money when he was hired so that he drives his own personal vehicle. Nobody is holding anyone accountable. The commission took Prellwitz off of probation and gave him a raise."

Commissioner Materi instructed the road superintendent that he should not let the blades sit idle. When the blades are stopped and the operators are being pulled off the blades to help with a culvert project, the employees working in the shop need to step up and get in those blades and run the routes.

Troy Roemmich was present and voiced his opinion towards the road superintendent stating that he's not respectful to the county residents and he's driving the county vehicle to and from work.

There was some discussion regarding the salary for David Krumm, seasonal highway maintenance worker, where some citizens felt that his salary should be increased. Later in the meeting, Commissioner Eberle motioned to increase the salary of David Krumm from \$26.00 per hour to \$35.00 per hour effective immediately. Motion died due to lack of a second.

Road Superintendent, Skyler Prellwitz, reported on the activities for the county road department. Provided was an update on 17<sup>th</sup> Ave SE, temporary grade raise road project. Prellwitz also reported that Scherbenske, Inc. was hired to gravel the roads at \$150.00 per hour.

Commissioner Eberle motioned to mandate that Skyler Prellwitz move to Emmons County and establish a residency by August 1, 2024. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Materi and Miller. "NO": Magrum. Motion carried.

The board recessed for lunch and reconvened at 1:30 P.M.

VA Officer, Brad Huber, appeared and gave his quarterly report.

Commissioner Hulm motioned to appropriate \$2,000.00 from the abandoned Cemetery fund towards an approach, culvert and miscellaneous road work to the Tiraspol Cemetery. Commissioner Miller motioned to appoint Don Eberle to serve on the Canvassing Board for the 2024 Primary Election. Seconded by Commissioner Materi. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

A per publication, at 9:15 A.M., the County Board convened as a Board of Equalization to take up matters of Equalization of Assessments.

Reviewed was the true and full values and sales ratio adjustment worksheet for residential, lakeshore, commercial and vacant lots. The 2024 values are based on market values which fluctuate with general economic

conditions. By North Dakota state law, as property values change in the market place, those changes must be reflected in the assessor's estimated market values.

Total sales ratio of all residential and lakeshore properties sold in 2023 showed a median ratio of 91.9%. There were 34 residential/lakeshore usable sales. The true and full market value ratio after local equalization is 91.3% for 2024. Commissioner Hulm motioned to approve the residential and lakeshore true and full values and to equalize the assessments for 2024. Seconded by Commissioner Materi. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Total sales ratio of all commercial and vacant lots sold in 2023 showed a median ratio of 91.44%. There were 28 commercial and vacant lot usable sales. The true and full market value ratio after local equalization is 95.2% for 2024. Commissioner Miller motioned to approve the commercial and vacant lots true and full values and to equalize the assessments for 2024. Seconded by Commissioner Materi. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Per North Dakota Century Code 57-02-27.2, agricultural land is assessed in accordance with North Dakota laws where values are based on the soil type and productivity index. The 2024 value per acre for Emmons County as calculated by NDSU is \$655.25. The value per acre as equalized by the county is \$602.83. Emmons County is maintaining a 92.0% tolerance level for agricultural land values which is following the North Dakota State Board of Equalization ruling that counties must maintain a tolerance level between 90% - 100%. Commissioner Miller motioned to approve the agricultural land values for 2024. Seconded by Commissioner Hulm. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the Homestead Property Tax Credits and Veterans Tax Credits for the 2024 tax year. Seconded by Commissioner Materi. Roll Call "YES": Hulm, Magrum, Materi and Miller. Motion carried.

Road Superintendent, Skyler Prellwitz, stated that the project will be done in house with the exemption of hauling gravel where a contractor will be hired. This two-week project will start sometime next month.

Commissioner Eberle motioned to grant permission to Loren Vander Vorste to tile the intersection of 98<sup>th</sup> St. SE and 7<sup>th</sup> Ave. SE on his own property, at his own expense, and to be supervised by Skyler Prellwitz to make sure the land is reclaimed properly. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Graveling road discussion was held where suggestions were made to spot gravel the bad spots instead of graveling the entire road which would be more economically feasible.

Discussion was held regarding a request from Chris Ryckman to cut down trees on the county rightof-way on 100<sup>th</sup> St. SE and 3<sup>rd</sup> Ave. SE, and have the county grind the tree stumps and fix the road. Further discussion will be held on the June 3, 2024 Commission meeting.

Brad Stoppler is requesting gravel on 3<sup>rd</sup> Ave SE. The Commission concluded to only gravel the county road and not the private drive.

Commissioner Hulm motioned to adopt the following Resolution:

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The April, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Miller motioned to approve the minutes of the April 2, 2024 regular meeting and the April 17, 2024 special meeting. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Miller motioned to approve the agenda. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Discussion was held regarding the public nuisance on 8080 Highway 83 South, Linton. Joseph M. Hanson stated that he wasn't able to get a hold of Trash, Inc. to see if they had any interest on cleaning up the property. Commissioner Miller commented that he knows of someone interested in the cleanup, but wants to look at the property first. Chairman Magrum informed Kevin Evenson that he's parking his vehicles south of the access road that is privately owned property and not a public right-of-way.

County vehicle policy discussion was held. Chairman Magrum stated that after reviewing the employee manual, the decision on how to handle the situation of what's going on with the county vehicle driven by the road superintendent is not a policy violation; instead, it's an interpretation of the policy.

Commissioner Miller reported that a company vehicle has been seen parked at the Dollar General where the employees are buying snacks on county time, and this should be done after hours. Later in the meeting, Skyler Prellwitz confirmed that the road department shops locally and purchases shop supplies at the Dollar General.

Commissioner Hulm stated that when Skyler Prellwitz was hired as road superintendent, the Commissioners agreed to increase the salary by \$3,000.00 annually for using his personal vehicle for commuting back and forth to work, and this is recorded in the minutes. Skyler Prellwitz was also supposed to fulfill his residency in Emmons County. "This was all thrown out the window".

Commissioner Materi questioned where the commissioners go with a policy as far as this pickup being driven back and forth, stressing that he wants to stop this vehicle from being driven back and forth to Bismarck overnight.

Commissioner Eberle suggested that the road superintendent use his personal vehicle and be compensated for mileage whenever he picks up parts for the county.

No action was taken.

### New Business:

Troy Roemmich appeared to address some county issues that included the severe decline in the quality of the road conditions, stressing that with a small amount of rain (less than an inch), he's unable to get to his home. This has been the case since August of 2023. Mr. Roemmich complained about the interview process when the commission hired for the road superintendent position, pointing out that a reference check with previous employment was not completed. Also addressed was the use of the county vehicle driven to and from Bismarck by the road superintendent, and taking Mr. Prellwitz off of probation without fulfilling his residency in Emmons County.

At 9:50 A.M., a County Park Board meeting was held. Present were Commissioners Don Eberle, Gary Hulm, Erin Magrum, Dan Materi and Craig Miller; County Park Board Member, Dean Weiss. Absent was County Park Board Chairman, Andy Reis. Also present was Korlene Schmidt representing Kintyre Park Board, Rosalie Rambough representing Braddock City Park Board, Phil Volk representing Hague City Park and Becky Thatcher-Keller representing Linton City Park.

Erin Magrum called the meeting to order. Dean Weis motioned to approve the minutes of the May 2, 2023 meeting. Seconded by Erin Magrum. All members voting "YES". Motion carried.

County Auditor, Marlys Ohlhauser, presented the following county park budget information to the board:

Board members read a letter from Ann M. Moch, Kintyre Park Board, providing a summary of the park's activities and projects. Becky Thatcher-Keller, grant writer for the Linton City Park Board, provided an update on several of the Park's projects. Other City Park representatives provided updates on their park's projects as well, and requested funding to help with maintenance costs for mowing, light bill, etc.

Don Eberle motioned to allocate \$3,000.00 to Linton City Park, Hazelton City Park, Braddock City Park, Hague City Park and to the park in Kintyre; and to allocate \$1,500.00 to the Strasburg City Park and \$1,500.00 to the Strasburg Park Expansion. Seconded by Craig Miller. Roll Call "YES": Don Eberle, Gary Hulm, Erin Magrum, Dan Materi, Craig Miller and Dean Weiss. Motion carried.

Dean Weiss motioned to adjourn. Seconded by Dan Materi. The meeting adjourned at 10:15 A.M.

At 10:15 A.M., the Board of County Commissioners reconvened in regular session.

Herman Jahner was present and addressed concerns about the condition of the gravel road on 6<sup>th</sup> Ave

SE.

County Extension Agent, Acacia Stuckle, provided a staffing update informing the board that Ashley Praus resigned her position as Administrative Assistant with May 3, 2024 being her last day of employment. The position is currently being advertised.

Jon Martin, PE, Wold Engineering, P.C., appeared and stated that an application was submitted for a grant through the NDDOT Flexible Transportation Fund Program where Emmons County was approved for the construction engineering and the twenty percent county cost share of the project for culvert replacement on 88<sup>th</sup> Street Southeast. This project will be bid on Friday, May 10, 2024. Commissioner Eberle motioned to enter into a construction engineering services agreement with Wold Engineering, P.C. for road project SC-1536(061) – culvert replacement located 0.5 miles north and 5 miles east of Strasburg, ND. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Emmons County was also awarded a grant through the NDDOT Flex funding for the preliminary engineering costs for the grade raise project on 17<sup>th</sup> Avenue Southeast. Commissioner Hulm motioned to enter into a preliminary engineering services agreement with Wold Engineering, P.C for road project CP-1523(025) grade raise 1 mile east and 3.5 miles north of Braddock, ND. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried. Discussion was held to come up with a feasible plan for a temporary slightly grade raise. Further discussion will be held at a special meeting scheduled for May 21, 2024.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

Discussion was held for the road department employees to consider rotating work schedules from Monday – Thursday and Tuesday – Friday, and work some Saturdays if needed.

Skyler Prellwitz presented an estimate for chip seal projects and a 2024 graveling location map.

Wesley Mastel appeared to request approval for a building permit for erecting a 72 X 100 farm shop with a 73-foot set back from the road on 20<sup>th</sup> Avenue SE. Emmons County's zoning ordinance requires a minimum setback of 100 feet from the centerline on all minor county and township roads. After discussion, Commissioner Eberle motioned to approve the building permit for Wes Mastel to erect a 72 X 100 farm shop on the SW ¼ of Section 4, Township 129, Range 74, and to grant a variance for a 75-foot set back from the center of the road on 20<sup>th</sup> Avenue SE. #### OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING APRIL 2, 2024

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The March, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Miller motioned to approve the minutes of the March 5, 2024 regular meeting. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the agenda with the addition of the public nuisance located on 8080 Highway 83 South, Linton, ND, Squatter rights, and discussion on the bridge replacement project located on 20<sup>th</sup> Ave SE, South of 85<sup>th</sup> St. SE. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Commissioner Miller received another proposal for GPS Tracking from GPS Insight for five vehicles at an annual service cost of \$1,197.00.

Commissioner Eberle suggested that instead of spending thousands of dollars on GPS Tracking, try to resolve the problem by having the road superintendent drive his personal vehicle to work, and reimburse him for mileage whenever he picks up parts for the county.

Commissioner Materi made the statement that citizens are questioning why this pickup is being driven to Bismarck, and felt that this problem needs to be resolved before the county purchases a GPS tracking system. Referenced was the county employee handbook, section 8.2, use of equipment and vehicles, that outlines that employees are not permitted to use county vehicles in place of personal vehicles for transportation to and from the workplace, nor to fill or charge gas or fuel to the county for their private vehicles. Commissioner Materi stated that everyone should comply with this policy and if parts are being picked up by an employee with their personal vehicle, bills should be submitted to the county for mileage reimbursement. Noted was that there's five common carriers that drive down from Bismarck, and also that shipping parts is cheaper than depreciation on the county vehicle.

Commissioner Hulm stated that the county already has a policy in place regarding the use of county vehicles, and unless the commissioners are going to amend this policy, we need to abide by it.

Human Service Director, Michelle Masset, was present and stated that social service employees do not take the zone vehicles home because it's against the county policy. There's one employee that drives back and forth from Bismarck everyday with her personal vehicle.

Commissioner Miller commented that sometimes new laws need to be made to enforce existing rules or laws.

Chairman Magrum suggested that the county enforce the current employee handbook policy, and if there's an alternative to the current policy, then a new law will need to be re-created. Further discussion was held later in the meeting with Skyler Prellwitz present where the board concluded to review the handbook at the May Commission meeting, making any necessary changes, and then enforce the policy.

Discussion was held regarding the public nuisance on 8080 Highway 83 South, Linton, ND. Chairman Magrum stated that according to Jared Reis, he's been busy and is getting booked up. Joseph M. Hanson will reach out to Trash Inc. and report back to the board.

## New Business:

Marcy Sanders appeared on behalf of KEM Electric to present a Good Neighbor Agreement between KEM Electric Cooperative, Inc. and Emmons County. This agreement is one of the requirements in order for KEM Electric to submit a grant through the federal government for a resiliency electric grid project. The county is not responsible for any of the local cost share of the grant. Commissioner Hulm motioned to enter into a Good Neighbor Agreement between KEM Electric, Inc. and Emmons County. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

County Extension Agent, Acacia Stuckle, provided a quarterly narrative report.

Dennis and Tena Weber appeared for discussion regarding the road that runs through Lot 25A, Beaver Bay Subdivision, Section 23, Township 132, Range 79. This road was forfeited to the county due to delinquent taxes in 2018. Dennis Weber explained that the road used to be a dirt trail that went through the trees, but over the years the road has widened. The Weber's would like to sell the property; but the road is taking up one third of the lot.

Suggestions were made for the county to remove the trees and move the road back to where it should be, or purchase the lot at the asking price of \$40,000.

Questions and concerns were addressed about the description of the property when it was acquired by the county, and whether the entire road actually belongs to the county? Josh Odden confirmed that the description of the property when acquired by the county was roadways in Beaver Bay Subdivision.

Commissioner Eberle motioned to approve the agenda with the addition of Summit Carbon Pipeline safety discussion, public nuisance on 8080 Highway 83 South, Linton, ND 58552, and the Airport Apron Rehabilitation Project. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Mariam Ghanem, GPX Intelligence, appeared remotely (by Zoom) and provided a demonstration of their dashboard and platform for GPS data tracking. Discussion on county vehicle policy for GPS tracking will be discussed at the April 2, 2024 commission meeting.

#### New Business:

Commissioner Hulm motioned to adopt the following Resolution:

#### **EMMONS COUNTY, NORTH DAKOTA**

RESOLUTION TO SHIFT THE SOON TO BE EXPIRING 5.00 MILL FARM TO MARKET/FEDERAL AID ROAD LEVY NO. 1212 TO COUNTY ROAD & BRIDGE FUND LEVY NO. 1204

WHEREAS, the Emmons County Highway Department along with the Emmons County Board of Commissioners are charged with maintaining the roads and bridges in Emmons County for the safety of its residents, and

WHEREAS, Emmons County currently levies 5.00 mills for maintenance, repair and upkeep of 177 miles of farm to market and federal aid roads under levy No. 1212, and currently levies 10.00 mills for County Road & Bridge repair and upkeep under levy No. 1204. The 5.00 mill Farm to Market/Federal Aid Road Levy will be expiring in December, 2024; and

WHEREAS, the Emmons County Highway Department will not be able to maintain or repair current farm to market/federal aid roads plus county roads and bridges (total of 1,191 miles) with the 10.00 mills allowed for levy number 1204, it is therefore proposed that the Emmons County Commission shift/move those 5.00 mills lost from Farm to Market levy No. 1212 to County Road and Bridge levy No. 1204, moving that levy from 10.00 mills to 15.00 mills as allowed by the approval of the voters of Emmons County per North Dakota Century Code Chapter 57-15-06.7(5); and

NOW THEREFORE, BE IT RESOLVED that the Emmons County Board of Commissioners requests authority from the Emmons County electors to shift the revenue eliminated from the County Farm to Market Road Levy (5.00 mills) to the County Road and Bridge Levy, thereby decreasing the Farm to Market Fund from 5.00 mills to 0.00 mills and increasing the County Road and Bridge Levy from 10.00 mills to 15.00 mills, and directs that the following measure be placed on the county ballot for the statewide Primary Election scheduled for June 11, 2024 to become effective January 1, 2025.

## **Emmons County Measure No. 1**

The 2015 Legislature, through SB2144, eliminated the County Farm to Market Road Levy (5.00 Mills) effective in 2024. Therefore, per NDCC 57-15-06.7(5), shall the governing body of Emmons County shift those mills to the County Road and Bridge Levy moving that fund from 10.00 to 15.00 mills? In summary, this will decrease the Farm to Market Fund from 5.00 mills to 0.00 mills, and increasing the County Road and Bridge Levy from 10.00 mills to 15.00 mills.

Commissioner Materi stated that whenever there's retirements or resignations, there's a true opportunity for the county commissioners and the departments to take a serious look to see if we really need to continue operating with the same amount of staff, by taking a look at the activity that goes through that office per day, week, and month to see if we can justify a fulltime employee. Commissioner Materi suggested that the hiring of a fulltime deputy recorder be put on hold to see if we really need a fulltime employee or can get by with a part time employee instead. Further discussion was held later in the meeting.

After some discussion, Commissioner Eberle motioned for the county to blade 87<sup>th</sup> St. SW, between Highway 1804 and 6<sup>th</sup> Ave SW, and to add this road to the blade route. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Materi and Miller. "NO": Magrum. Motion carried.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

Noted was that the Westfield Church will tar the parking lot themselves.

Discussion was held on building of a road on 93<sup>rd</sup> St. SW, Section 14, Township 130, Range 79. Skyler Prellwitz will work with Wold Engineering, P.C. to come up with a plan.

There was some discussion relative to the gravel road owned by the county in Lot 25A, Beaver Bay Subdivision, Section 23, Township 132, Range 79. The consensus of the board was to table the matter pending discussion on what the county options are with States Attorney Joseph M. Hanson.

The board reviewed a 2024 to 2025 paved road plan and countywide pavement marking cost estimates presented by Skyler Prellwitz.

Commissioner Eberle motioned to approve the Road Maintenance Agreement between Campbell Township and Emmons County for the following services:

> Road Grading Services - \$350.00 per certified mile Road Snow Removal - \$200.00 per hour

Agreement is effective April 1, 2024 and shall continue until March 31, 2025. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

The board recessed for lunch and reconvened at 1:15 P.M.

At 1:30 P.M., a motion was made by Commissioner Eberle to enter into executive session pursuant to NDCC 44-04-19.1 to discuss options involving county ordinances in regards to the Summit Carbon Solutions pipeline and Public Service Commission hearings. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

The executive session was called to order by Chairman Magrum at 1:30 P.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller in attendance along with States Attorney, Joseph M. Hanson. The Commissioners engaged in Attorney consultation with Braaten Law Firm.

Commissioner Materi motioned to adjourn the executive session. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried. The executive session adjourned at 2:30 P.M.

Commissioner Miller motioned that the Board vote to waive the potential conflict of interest as outlined in the representation agreement presented by Braaten Law Firm. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to direct Braaten Law Firm to appeal the decisions related to the Emmons County ordinance in the ND Public Service Commission's Case No. PU-22-391. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Materi motioned to continue having Braaten Law Firm represent Emmons County Commission with regard to ND Public Service Commission's Case No. PU-22-391 and any appeals and other proceedings requested by Emmons County Commission, and to sign the proposed representation agreement. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

The Commissioners referenced the email from Emergency Manager, Mary Senger, stating that Summit Carbon Solutions hosted a "Pipeline Information Session for First Responders" on January 24, 2024 and she did receive a draft Emergency Response Plan that was very preliminary. The plan will not become more specific until they start construction; therefore, Mary Senger will not be able to provide monthly updates to the County Commission. Commissioner Materi questioned whether Summit Carbon Solutions released a plume model at the training, and Sheriff Gary Sanders stated that the training was more informational with basic information.

States Attorney Joseph M. Hanson provided an update on the property located at 8080 Highway 83 South, Linton, ND and provided a copy of the Judgement that authorized the county to enter the property to abate the nuisance by removing and disposing items as listed. Commissioner Eberle motioned to mitigate the nuisance as the Judgement reads. Motion died due to lack of a second. After further discussion, Commissioner Materi motioned to seek bids on cleaning the Evenson property at 8080 Highway 83 South, Linton, ND. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm brought forward the Linton Municipal Airport Apron Rehabilitation Project and expressed that the airport benefits the entire county and motioned that the County contribute \$30,000 towards the project. Motion died due to lack of a second.

Commissioner Eberle motioned to enter into a Court Services Contract between the State of North Dakota, Emmons County, and the City of Hazelton. Term of this agreement is for one (1) year from March 1, 2024 through February 28, 2025. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Clerk of Court/Recorder, Kathleen Dosch, re-appeared for further discussion on the hiring of a deputy recorder and stated that at this point she didn't feel that the office could run with less people because the work load hasn't dropped, and she doesn't think it would be a wise choice to go from a fulltime position to a part time position. After further discussion, Commissioner Materi motioned to table the hiring of a fulltime person in the Clerk of Court/Recorder's office for 60 days. Seconded by Commissioner Eberle. Roll Call "YES": Materi. "NO": Eberle, Hulm, Magrum and Miller. Motion failed.

Commissioner Eberle motioned to approve the application for abatement or refund of taxes for parcel #53-0002-00123-000 for tax year 2023. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Miller motioned to approve the building permit for Anthony LaFond for adding a 10 X 20 "lean to" addition to the west side of existing structure on Auditor's Lot A, Section 2, Township 136, Range 78. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the building permit for Bob Kramer to replace metal on the existing pole barn located on Lot B of the SE ¼ of Section 18, Township 132, Range 76. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Miller motioned to approve the Plat of Outlot "A" located within the SW Quarter of Section 26, Township 130, Range 77, 5<sup>th</sup> P.M., Emmons County, ND. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING FEBRUARY 6, 2024

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The January, 2024 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Eberle motioned to approve the minutes of the January 2, 2024 regular meeting. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Eberle motioned to approve the agenda with the addition of discussion on local emergency planning updates to the commissioners, and discussion relative to the newspaper article published by Francis Krumm. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Commissioner Miller provided an update on vehicle GPS tracking. Verizon Wireless quoted a monthly per unit fee of \$15.95 for a tracking device that plugs into the vehicle's computer. This device gives more information, including camera's, which Commissioner Miller didn't feel was necessary. GPX Intelligence quoted a monthly rate of \$10.50 per unit for a tracking device that reports the location of the vehicle. The Commission will further continue its research.

Commissioner Materi referenced the article in the Emmons County Record regarding Local Emergency Planning Committee meeting where the group discussed state requirements on hazardous materials, and that Summit Carbon Solutions will be working with Emmons County Emergency Management to schedule a meeting with Emmons County first responders to discuss its project overview, including dispersion modeling. Commissioner Materi requested that the commission be notified on what Summit Carbon Solutions is doing in the county with certain departments, and have those departments provide monthly updates to the commissioners.

Commissioner Eberle brought forward the attorney fees paid to Braaten Law Firm, requesting that the Auditor/Treasurer provide a running total to the commission every month. Commissioner Eberle also commented on the lawsuit of Krumm vs Emmons County where the court ordered the county to pay \$15,695.10 towards attorney fees.

#### New Business:

Clerk of Court/Recorder, Kathleen Dosch, introduced Robin Mosset, Deputy Clerk of Court, to the board.

Roger Martin, Airport Authority Board Member, appeared to answer questions of the board, and to continue requesting funding for the Airport Apron Rehabilitation Project. The amount of funding that the Airport is requesting from the county is \$120,000 over a two year period. Discussion was held regarding board member requirements, proposing a county airport mill levy on the county ballot, establishing a county airport board, rental for hanger space, and charging the sprayers/farmers. Roger Martin stated that the Airport Authority is a government entity and not a private business. The Airport is a service and is not there to make a profit; instead, it's there to provide a place for people to make a profit. The Airport is an entity that allows businesses to come in and provide service to the farmers and to the City of Linton and Emmons County. Since 2015, the Airport had forty (40) medical flights with eight (8) of those flights occurring this past month.

Director of Tax Equalization, Wayne Ehley, appeared to present the 2024 agricultural land valuations provided by the Agribusiness and Applied Economics Department of the North Dakota State University. NDSU calculated the statewide average values per acre with the following results:

Cropland	\$908.33
Non-cropland	\$161.57
All agricultural land	\$674.04

Emmons County's average value per acre for the year 2024 is as follows:

Cropland	\$894.44
Non-cropland	\$164.12
All agricultural land	\$655.25

North Dakota Century Code ruling requires County's to be within a tolerance level of 90% - 100% on their agricultural land values determined by the North Dakota State University Agricultural Economics Department. Commissioner Hulm motioned to maintain a 92% tolerance level to keep the county average in compliance with state requirements. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Pete Gesellchen appeared for some discussion concerning the Historical Society mill levy funds and questioned why some of the funding isn't sent to Hazelton and Braddock. It was confirmed that the mill levy collections are sent to the Emmons County Historical Society who have their own board membership. States Attorney Joseph M. Hanson will check the NDCC to determine how the Historical Society board members are chosen and how mill levy funds can be appropriated.

Sheriff Gary Sanders introduced Deputy Taylen Mendoza who started her employment with Emmons County on January 1, 2024.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

Newly hired road equipment operators, Wayne Nelson, Loren Vaughn and Travis Schafer appeared to be introduced to the Commissioners.

The road department will close the road and clean out the cattle guard on 3<sup>rd</sup> Avenue, near Section 28, Township 132, Range 77.

Skyler Prellwitz brought forward the road requested by Dave Twardoski on 93<sup>rd</sup> St. SW, Section 14, Township 130, Range 79 where discussion was held for creating a special district. Further discussion will be held at the March meeting.

Brought forward was the gravel road owned by the county that's on Dennis and Tena Weber's property in Lot 25A, Beaver Bay Subdivision, Section 23, Township 132, Range 79. After discussing the options of moving the road or the county purchasing the Lot, Chairman Magrum will talk to the Weber's and report back to the board.

Commissioner Eberle motioned authorizing Chairman Magrum to execute the Langelier's Bay Annual Management Program, Statement of Receipts and Expenditures for calendar year 2023 and the Annual Management Program and budget for 2024. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING JANUARY 2, 2024

County Auditor, Marlys Ohlhauser, called the reorganizational meeting to order at 9:00 A.M., with Commissioners Don Eberle, Gary Hulm, Erin Magrum, Dan Materi and Craig Miller being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

County Auditor, Marlys Ohlhauser, opened nominations for the 2024 Chairman. Commissioner Eberle nominated Commissioner Magrum and Commissioner Miller seconded the nomination. Auditor Ohlhauser called for further nominations. There being no further nominations, Commissioner Magrum was elected Chairman for 2024 by all Commissioners voting "YES".

Chairman Magrum opened nominations for the 2024 Vice Chairman. Commissioner Materi nominated Commissioner Hulm. Chairman Magrum called for further nominations. There being no further nominations, Commissioner Hulm was elected Vice Chairman for 2024 by all Commissioners voting "YES".

Commissioner Eberle motioned to approve the minutes of the December 5, 2023 regular meeting. Seconded by Commissioner Materi. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

Commissioner Hulm motioned to approve the agenda with the addition of discussion regarding the fence on the section line right-of-way near 22<sup>nd</sup> Avenue SE and 90<sup>th</sup> St. SE. Seconded by Commissioner Miller. Roll Call "YES": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

#### **Old and Unfinished Business:**

Commissioner Hulm motioned to appoint Randall Meidinger to serve on the County Committee Board. Motion died due to lack of a second.

The board reviewed the Court Order authorizing Emmons County to enter the property on 8080 Highway 83 South, Linton, ND 58552 which constitutes a public nuisance under the North Dakota Century Code chapter 42-01 and 23-35. Chairman Magrum suggested that the board work on an Ordinance that would reference laws and guidelines, defining what compliance is, in order to be consistent with all properties.

Commissioner Eberle confirmed that the fence that was on the section line right-of-way near 22<sup>nd</sup> Avenue SE and 90<sup>th</sup> St. SE was taken down by the road department employees, and moved off the right-of-way.

Commissioner Miller reported that he received a bid for GPS data tracking from GPX Intelligence. The bid included a one-time purchase price of \$1,566 for transmitters with an annual cost of \$1,100 for tracking eight vehicles. The board agreed to continue looking into GPS tracking alternatives.

Commissioner Materi nominated Elmer Brandner to serve on the Emmons County Weed Board for a four-year term effective January 1, 2024. Receiving no other nominations, a unanimous ballot was cast for Elmer Brandner.

Commissioner Eberle nominated Glen Geffre to serve on the Emmons County Water Resource Board for a three-year term effective January 1, 2024. Receiving no other nominations, a unanimous ballot was cast for Glen Geffre.

Chairman Magrum nominated Lyle Kenner to serve on the Emmons County Public Health Board for a five-year term effective August 1, 2024. Receiving no other nominations, a unanimous ballot was cast for Lyle Kenner.

Chairman Magrum nominated Melvin Jahner to serve on the Emmons County Housing Authority Board for a five-year term effective January 1, 2024. Receiving no other nominations, a unanimous ballot was cast for Melvin Jahner. Chairman Magrum nominated JoAnn Humann to serve on the County Committee for School District annexation, dissolution and reorganization for a three-year term effective January 1, 2024. Receiving no other nominations, a unanimous ballot was cast for JoAnn Humann.

Commissioner Materi nominated Bernice Keller to serve on the County Committee for School District annexation, dissolution and reorganization for a three-year term effective January 1, 2024. Receiving no other nominations, a unanimous ballot was cast for Bernice Keller.

Human Service Director, Michelle Masset, appeared and inquired about observing Friday, July 5, 2024 as a Holiday. After discussion, Commissioner Materi motioned for Emmons County to observe July 5<sup>th</sup> as a holiday in 2024. Seconded by Commissioner Hulm. Roll Call "YES"": Eberle, Hulm, Magrum, Materi and Miller. Motion carried.

VA Officer, Brad Huber, appeared and gave his quarterly activity report.
