**Summary Annual Report for
Indiana Laborers Defined Contribution Trust Fund Plan**

This is a summary of the annual report for Indiana Laborers Defined Contribution Trust Fund Plan, EIN 46-5396452, Plan Number 001, for the period May 1, 2018 to April 30, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust. Total plan expenses were \$830,520. These expenses included \$160,574 in administrative expenses and \$669,946 in benefits paid to participants and beneficiaries. A total of 10,607 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$13,716,981 as of April 30, 2019, compared to \$8,803,466 as of May 1, 2018. During the plan year the plan experienced a change in its net assets of \$4,913,515. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$5,744,035 which included employer contributions of \$5,128,687, income from investments of \$613,209 and other income of \$2,139.

Paperwork Reduction Act Statement
