

# ASTRONOMICAL RAPTURE

## END OF THE TETRAD SERIES

### *Numerical Calculations and Prophetic Implications*

The purpose of this study is to investigate the Astronomical patterns based on the remaining eclipses for 2015 since the Equinox eclipse of Nissan 1. The backdrop of this pattern is taken into consideration because the eclipses occur either in Pisces or Virgo, thus a possible Astronomical Rapture depiction. The calculations will start with the Equinox eclipse of March 20, 2015 that this study suggests could have implications to the timing of when the end of the Church Age is to conclude and thus the Rapture of the Bride of Christ. This unique type of solar eclipse is only the 9th one to occur on the Equinox and that is total since Christ. What makes this one in particular unique is that it occurs when there is a Super Moon and on YHVH's religious New Year, amazing. The prior 8 eclipses that have been total and, on the Equinox, have not had this unique signature that this study suggests is thus prophetic.

This study will show that the religious New Year eclipse of March 20, 2015 is in phi ratio of time to the civil New Year partial eclipse of September 13, 2015 on Rosh HaShana, 5776 and has peculiar day count associations. The solar eclipses are also tied to the timing of the last 2<sup>nd</sup> and 3<sup>rd</sup> Blood Moons of the Tetrad, the last in the series of 3 since 1949. One other peculiarity about the eclipse patterns is that the 3<sup>rd</sup> Blood Moon occurs in the constellation of Virgo and the last or 4<sup>th</sup> Blood Moon occurs in Pisces. The partial solar eclipse occurs in-between Virgo and Leo and on YHVH's New Year. The New Year eclipses also have a phi ratio relationship to time as it pertains to the 365-year count and precisely accents the Jubilee on Yom Kippur of September 23, 2015.

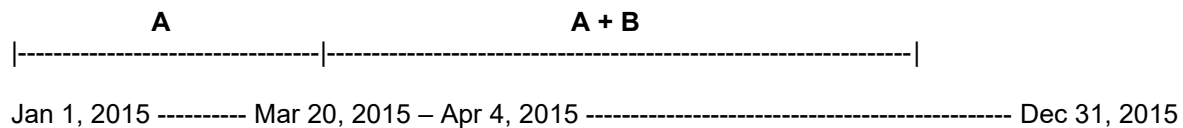
These 2 New Year's solar eclipses mirror each other by time. Within this timeframe, perhaps the notion of a beginning and an end is to occur prophetically. Could these eclipse patterns allude to the conclusion of the Church Age and/or the Rapture of the Bride of Christ? For illustration, the chart accompanying this study will center on the celestial Rapture that is depicted by the constellations of Pisces and Pegasus. This study will rely heavily on the constellation depiction and Biblical interpretation per E.W. Bullinger. The constellation of Pegasus with Andromeda and the adjacent 2 Fish of the constellation Pisces make up the entire segment of the Mazzaroth that encompasses the Astronomical Rapture. The Rapture of the Bride of Christ is not only foretold in the Bible that will occur, but it is edged in the very stars of the heavens as a sure sign.

## Prophetic Times of Phi

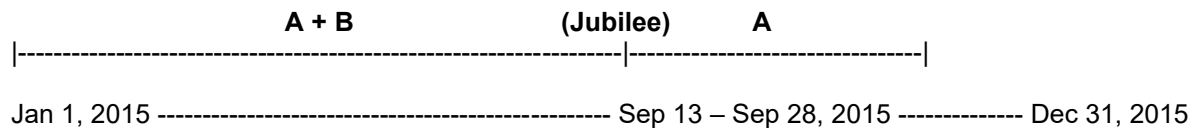
One unique observation that this study seeks to illustrate is that the whole timeline of the eclipses, both solar and lunar are pegged to its phi ratio proportion of time when they occur. This mathematical variable is a constant and occurs with all other relationships of planets' positions and even the construct of the constellations. The notion of time and space existing and manifesting in a phi ratio of progression is suggested to be a primary factor of how time, space and motion are developed and were created. The phi ratio for the entire year of 365 days for 2015 is as follows. From January 1, 2015, the phi ratio spiral corresponds to the center point in-between the time of the March 20, 2015 Equinox eclipse to the 3<sup>rd</sup> Blood Moon of April 4, 2015.

A+B: A= A:B

A+B = 365 Days: A = 225.582 B= 139.417



The reversed phi ratio count from December 31, 2015 to January 1, 2015 renders the opposite day count where Yom Kippur on September 23, 2015 approximates the focal point of the phi ratio spiral. This depiction is transposed onto the timeline that is illustrated in the chart. Thus, the symmetrical New Year solar eclipses are complimentary in more ways than one, astronomically, mathematically and prophetically. This same phi ratio pattern can be scaled down and applied from the 3<sup>rd</sup> Blood Moon on April 4, 2015 to Yom Kippur of September 23, 2015 as well.



The focal point of this phi ratio spiral is in-between the May 14 Independence/Ascension Day and Pentecost on May 24, 2015. What this shows is that such eclipses are not random events without intelligent design. As noted in previous studies, the phi ratio is the invisible 'code' of Creation. The following are some observations of key date to year timeframes.

Mar 20 to May 23 = 09 weeks  
 Mar 20 to Sep 13 = 178 days (including end date)  
 Mar 20 to Sep 23 = 188 days (including end date)

Equinox eclipse to Pentecost  
 Equinox to Rosh HaShana  
 Equinox to Yom Kippur

Apr 04 to May 23 = 49 days (7 weeks)  
 Apr 04 to Sept 28 = 178 days (including end date)

3<sup>rd</sup> Blood Moon to Pentecost  
 3<sup>rd</sup> Blood Moon to Sukkot

May 23 to Sep 13 = 03 months 21 days (3-2-1)  
 May 23 to Sep 23 = 123 days

Pentecost to Rosh HaShana

In ascertaining the possible condition and timing of the Rapture of the Bride of Christ, it might well be tied to particular Feast dates of YHVH and/or in tandem with particular timing of eclipses, either solar or lunar. How the timing of the end of the Church Age is to be calculated could thus be based on the pattern of Equinox eclipse or the like. It is assumed that the Equinox Eclipse is the 'last' one of the Church Age to signal perhaps the end of its commission; it is only speculative at this point. The reason being that unlike the 8 previous ones since Christ, none appear to occur on YHVH's religious New Year and on a Super Moon. This is also stipulated on the notion that there is a comprehensive 7000-year pattern of history patterned after the Creation Week.

#### *Peculiarity of the Equinox Eclipse of March 20, 2015*

- 1. On the Equinox*
- 2. On a Super Moon*
- 3. A Total Solar Eclipse*
- 4. On YHVH's religious New Year*
- 5. Only the 9th since Christ*
- 6. A reversed 27-19-19-year pattern*

There is a subsequent Equinox eclipse 19 years later in 2034 but does not occur on a Super Moon nor a Feast or appointed time of YHVH. The nearest one after 2034 is in 2406. This study suggests that this date is not particularly of any prophetic significance related to the end of Daniel's prophecy of the consummation of the Ages. It is a time that well exceeds the timeframe of a generation, a Jubilee, and any Blood Moon Tetrad. The point is that anything beyond 2022 does not have the wealth of celestial signs that appear to be specifically synchronized to YHVH's Feast days now as in New Years and eclipse patterns, to include Equinox eclipse and Blood Moon patterns.

This pattern and/or sequence of the Equinox eclipse pattern approximates that the time for the Rapture of the Bride of Christ is at hand because the pattern of the Equinox eclipses, for one appear to mark-off the limits of how long the Church Age is to last based on the typology and superimposed Sign of the Piscean constellation onto the timeline since Christ's ascension. This study is not emphatically asserting that 2015 will be the year of the Rapture but that it is at the door. If the year 2034 is the outer limit of the Church Age, perhaps which would mean that those 7 years prior to that time would be no later than 2027. This would only mean that from 2015, there would be at the most some 12 years left to go for the Church Age to end. The point is that the next subsequent Equinox eclipse does not happen until 2406 AD, some 400 years later.

## **Astronomical Clockwork**

This study does assume that the rebirth of Israel, although not in faith is a progressive restoration process that started the countdown in 1948. This prophetic countdown is in tandem with the Blood Moons, the Jubilee since the 6-Day war which will be Jerusalem's first since the Temple Mount was liberated from the Muslims. This prophetic completion of Daniel's 70<sup>th</sup> week of years will culminate in the rebuilding of the 3<sup>rd</sup> Temple and the full restitution of Israel at Jesus' 2<sup>nd</sup> Coming. This rebirth of Israel is believed to be the fulfilment of the parable of the Fig Tree and thus it is the central most prophetic factor and fulcrum of what is to occur very soon if that is the case based on such patterns as the Equinox eclipse and Blood Moon patterns are indeed prophetic.

Many believe as this study strongly suggests and with a book entitled, *The Tetrad and the Temple*, that there is a reverse decree of judgment by the LORD occurring at this present time. This prophetic sequence as disclosed by the Olivet Discourse pronounces the sequence of Israel's judgment and End Times restoration; in the reverse order. Jesus foretold that the Temple, the City, and the Nation would be destroyed because they rejected His Messiahship and did not recognize the time of His visitation as clearly calculated by the Prophet Daniel. It is presented that this restoration is prophetic in that the restoration of the Nation, the City and eventually the Temple are coming to pass and are in approximate tandem with the Blood Moon and Jubilee phenomena. Moreover, the 3 series of Blood Moons occur in a phi ratio of spacing of time.

### *End of Tetrad Series*

- 1) 1949-50: Tetrad = Nation
- 2) 1967-68: Tetrad = City
- 3) 2014-15: Tetrad = Temple?

The peculiarities of several of the number-to-date associations of the remaining eclipses since the Equinox eclipse are very intriguing. For example, there are 15 days from the Equinox eclipse of March 20, 2015 to the 3<sup>rd</sup> Blood Moon of April 4, 2015. This is exactly 360 hours. This has a connotation of circle or that of a complete revolution. Perhaps it also is connected to the very cycles of the Moon's rotation. Then there is the time span of 10 days from the anniversary of Israel's Independence on May 14, 2015. This date in 2015 happens to also synchronize to that of the Ascension of Christ per the western calendar. This 10-day period is the same as 14,400 minutes.

This time clearly has overtones of the 1400,000 Holy Spirit sealed Jews that are to be the chosen Evangelists during the Tribulation period as the Church commission comes to a close. It has a connotation of a 'code' of a Rapture as it was 10 days prior to Pentecost in which the ascension of Jesus occurred. Jesus did warn the Church of Smyrna that they were to experience 10 Days of Tribulation. Thus, such timings of Blood Moons and eclipses have within its very DNA the imprints of prophetic time; as it has been in the past that will occur in the future. There will be 7 main dates for 2015 starting with the Equinox eclipse. Each is related to YHVH's schedule. the last 2 remaining Blood Moons to conclude the Tetrad series Sukkot on September 18, 2015.

The chart will show that from this Equinox eclipse and the Blood Moons there are unique numerical associations to include the factor or the phi ratio that could be prophetic. As it has been noted, the 15-day difference from the religious New Year Equinox eclipse of March 20 to the April 4 Blood Moon on Passover is 15 days. The Anniversary of Israel's Independence on May 14 that is also Ascension Day to May 24, the 1st day of Pentecost is 10 days. Then from the civil New Year of Rosh HaShana on September 13 to the last Blood Moon of the Tetrad on Sukkot in September 28 is another 15 days.

*Mar 20 to Apr 04 = 15 Days = 360 hours*  
*May 14 to May 24 = 10 Days = 14,400 minutes*  
*Sep 13 to Sep 28 = 15 Days 360 hours*

If one adds these 3 variable differences of a 15-10-15 count, the summation is 40. Again, in prophetic language, this number has a Biblical connotation of testing. Perhaps it is a code that Israel is about to go into an evaluation as it was in the Wilderness, of a 'time' to test its faith. This study subscribes to the theory that the Church Age's 40 year type of testing through the nearly 2 millennia of tribulation would have come to a close by this time, whenever it is. The point is that if what the numeration of such astronomical nuances and events are depicting, it is within this very generation and soon.

Another very unique inference to sacred numbers has to do with the infamous comet ISON. This comet was named the Hanukkah Comet because it reached its perihelion or closest approach to Earth on the eve of Hanukkah in 2013. That date from November 28, 2013 to the 1st day of Yom Kippur 2015 is exactly 666 days, including the end date. Could this be significant or perhaps coincidental? Nothing is inconsequential in YHVH's timeline. As to the ramifications, that remains to be seen but the synchronization of this timing is unsettling because Yom Kippur of 2015 is by many to be the calculated time of the Jubilee.

It is rather intriguing that the coming of the AntiChrist is to occur in the Jewish year of 5776 by some estimations. This reckoning of the prophetic time of the Jubilee is based on a 1966 set time and liberation of the Old City of Jerusalem from the Muslims. What might be ominous and is that the year 5776 is speculated by some that study End Time prophecy to be the year the 3<sup>rd</sup> Temple is to be built and by the unveiling of the AntiChrist that will initiate its reconstruction. Subsequently, this same AntiChrist will enforce his mark, that of a 666 on every human that will require full allegiance in every way, even to the point of forfeiting ones' soul and eternal salvation.

## **Prophetic Echoes of What has Been**

There is that age old debate as to whether the Tribulation will be 3.5 years or 7 years. Many believe that it is a 3.5-year span of time and not a 7-year cycle because of one possible interpretation of the Daniel 9:27 verse. The subject is the 'He' that is 'cut off' in the midst of the week may or may not be inferring to Jesus but the AntiChrist. There are those that emphatically exclaim that it is referring to the AntiChrist, others that it was Christ but that since He was 'cut off' in the middle of the week, the 7 year long prophetic week of Daniel has been shortened to only 3.5 years and that the Rapture of the Bride of Christ will go through the Tribulation but not the 'wrath' part. This study holds to the interpretation that the Daniel 9:27 verse is a multi-layered prophecy as most are and it has a connotation of the type and antitype encoded within its makeup. The prophecy also has an immediate rendering and a continual unveiling throughout time.

It speaks of Christ and the AntiChrist. Christ Jesus was 'cut off' or crucified in the midst of the week, Wednesday, a High Day Sabbath and resurrected on the Sabbath. His ministry is said to have been 3.5 years, but some even question this amount of years. Obviously, there could not have been a 7-year long time continuum for Jesus from the start of His ministry. If this is the case, where are the 2<sup>nd</sup> 3.5 years? Those that ascribe the Daniel 9:27 prophecy to only that of the AntiChrist assert that it will only be at the halfway point when the AntiChrist turns on Israel and ceases the Temple oblations that the 'wrath' commences. This is interpreted based on the word 'after the tribulation of these days', etc. Such misinterpret the context that Jesus was addressing Israel, not the Church. This would correlate to the 2<sup>nd</sup> half of the Tribulation, whenever that starts as it will be 'great'. This study strongly suggests that the wrath is all conclusive and compressive of a 7-year prophetic cycle since the 1<sup>st</sup> breaking of the Seals of Judgment.

The missed mark is that the purpose of the whole tribulation period is to 'test the inhabitants of the world' and to finish Israel's discipline as it was given 70 prophetic years, or 7 times 10 cycles of discipline. There are many instances of a 3.5 year pattern of times but when it occurs, it is always in the context and confines of a 7 years period of time. Thus, this study suggests that where Jesus left off, prophetically the antitype, that is the Antichrist will pick up from there on one level of interpretation. One has to consider the patterns and typology in that Jesus' halfway mark was in the context of a 7-day week, not 7 years. The halfway mark for the AntiChrist will be at the midway point of a 7-year Sabbatical cycle of time. The Seal judgments are opened in the Judicial courts of Heaven when the Bride of Christ has to be present to face her Accuser, Lucifer.

The Seal judgments are basically Lucifer's sentencing that is in tandem with the judgment of the world. Such prophetic judgments have reverberated throughout history on multiple levels as there have been prophetic patterns of the Spirit of AntiChrist, false peace, war, famine followed by death and hell, etc. Specifically, the first 4 seals have been applicable throughout the Church Age for example. The point is that it will not be until the true Rapture of the Bride that the literal manifestations of the 7-7-7-fold Seal judgments are fulfilled. This will be in the context of the coming literal AntiChrist with the Covenant and the subsequent wars, famines, death, and astronomical calamities, etc.

## **End Times Ramifications**

To many the world is headed to a final confrontation. It is clear that radical Islam for example has declared war on the civilized world and particularly against YHVH's spiritual people, the Church and Earthly people, Israel. It would seem unlikely that the world could survive at most another 400 years without a nuclear war. This is especially true of the Islamic Republic of Iran if and when it will acquire the Bomb. Unlike Pakistan that is Sunni Muslim or Arabia that has purchased Chinese ICBMs, Shi'ite Iran's eschatology calls for the destruction of Israel in an Armageddon type scenario. This order out of chaos will demand their 12<sup>th</sup> Imam to appear and lead Islam to victory against the Jews and Christian, and with Isa's or Jesus' help. Jesus did state that if He did not interfere, no flesh would be left alive as the time coming up quick will be as none other has been or will be; it is that dire.

As Iran has been at war with Israel through their proxy wars at Israel's borders, according to Bible Prophecy, Iran will not take part in the 1<sup>st</sup> Inner-Ring of nations that many speculate will constitute the Psalm 83 War. Iran will reserve its attack directly against Israel when it exercises its military pact that it has already made with Russia. This will be the Gog-Magog War 1 that is to occur with the Outer-Ring of Muslim nations. Daniel's prayer was delayed due to this demonic Prince of the Air. He is so powerful that the Arch Angel Gabriel had to call Michael to help him and that in the Last Days, they would return to finish the job.

It is rather interesting that according to the Islamic eschatology of End Times, it will be the Mahdi that will make the peace pack for 7 years. It is suggesting that Islam will be part of the prophetic type in the last days rendering of the statue of Daniel that was composed of a mixing of clay and iron. It could be Rome on one side and the Caliphate of Istanbul (Constantinople) on the other. To many it is becoming very clear that the last Beast Empire will be of such a composition, Chrislam. If this prophetic pattern is valid and reliable it would suggest then that the Papacy would constitute the personage of the False Prophet that many Muslims believe will be taken for Jesus as the coming Prophet. To the Muslims, whoever is to negotiate with the Jews after an event to allow for the Temple and a peace to occur, to them that will be the Mahdi. If a division of the land of Israel is to occur, that remains to be seen.

As it stands now, the onslaught of ISIS will eventually turn its attention to Israel. Many are suggesting that it will be the catalyst for the united Muslim coalition against Israel as it has encompassed Israel at all its borders. A possible trigger of a preemptive strike by Israel could be if and when ISIS eventually overruns Damascus and seizes the stockpiles of biological and chemical weapons. They will use that against Israel. This intelligence and timing would have Israel destroy Damascus in a day as the reelection of Netanyahu essentially guarantees war with the Muslims. Netanyahu has vowed not to have Israel experience another Holocaust by not heeding to credible threats to destroy Israel made by such entities as Iran, Hezbollah, Hamas, the Muslim Brotherhood, ISIS and on and on. The fallacy of such threats is qualified in that the Ayatollahs of Iran distinguishes the 'Zionist' state from the 'people' of Israel; this is pure double-speak.

## **Astrological Types of Bible Prophecy**

According to the Bible Codes Netanyahu will be the one who makes the deal on behalf of Israel dealing with the confirmation of the Covenant. This is not far-fetched as Netanyahu has been all about the Biblical Covenant that alludes to the Land Grant given by YHVH to the Israelites. Israel is the only nation on Earth that the Creator has delineated borders of Earth for a particular people. This is why the enemies of YHVH, heavenly and Earthly cannot stand this decree. More so, to have Israel resurrected as a nation in 1948 after 1,948 years from 2018 validates the Bible in that YHVH is not done with Israel and Islam is not god's last and true witness and final revelation. This would make Mohammad thus a false prophet. The Bible Codes even say that Netanyahu is still involved somehow in the coming years. If based on the patterns and calculations, it will be Netanyahu that will be at the Table involved in the Confirming of the Covenant.

There is even a theory that Netanyahu himself will be the AntiChrist, but it is unlikely as he is hated of the Muslims for one. The AntiChrist will have to fulfill all 3 eschatological frameworks of end time prophecy for the Jews, Christians, and Muslims. To the Jews, whomever gives permission to rebuild the 3rd Temple will be the long-awaited Messiah as he would be the only one 'authorized' to decree such an endeavor. To the Christians, this 'Messiah' would be the anticipated AntiChrist that will beguile Israel into entering a 'Covenant of Death'. To the Muslims, he will be the Mahdi that will ultimately destroy the Jews and Christians in a ploy of the practice of appeasing the enemy by a peace treaty only to devour and destroy him at an opportune time; as in 3.5 years after maybe?

To reiterate, the premise of this study is that there is an Astronomical Rapture depicted in the constellations. It is part of the overall 'story of the stars' that convey the Gospel of Jesus Christ. This is what was alluded to by the Apostle Paul in Romans that the Heavens declare the Glory of the LORD without saying a word. Moreover, astonishing is that this 'witness' is what will condemn those ignoring it for not taking heed of its message to the point as Paul declared, man is without an excuse. What this study has attempted to present are some unique mathematical relationships and inferences that could be prophetic related to when the end of the Church Age is to occur and perhaps that it might be tied to some astronomical eclipse or Feast of YHVH based on observable and repeating astronomical patterns. It is also very intriguing about the September 23, 2015 date is that it is precisely in phi ratio to the entire year of 365 days.

It is also other unique day counts that occur in reverse. For example, the day count of the September 13 date is in phi ratio to Sukkot on September 28 as is the March 20, 2015 to the 3rd Blood Moon on April 4 date in which it is its mirror New Year, literally. It appears that from May 23 the eve of Pentecost to Rosh HaShana, a 3-2-1 is a reverse of the May 23 Pentecost to Yom Kippur of 123 days. Also interesting is at on the eve of the Equinox eclipse on the 19<sup>th</sup> will be the reversed date of September 13<sup>th</sup> one when the other partial solar eclipse occurs on Rosh HaShana and the stock market collapse is to occur. The partial solar eclipse is on the civil New Year, a time of an end and a beginning as was the eclipse on the religious New Year of YHVH. It would appear that it is a perfect analogy of God declaring the end from the beginning and the beginning from the end.



Also interesting is that Pentecost on May 24th is the 144th day of the year that has echoes of the 144,000 that will be sealed by the Holy Spirit for the purpose of being witnesses to Israel and the world after the Bride of Jesus is Raptured away. These Jewish men will consist of men from every tribe of Israel. Perhaps it will be like a Pentecost experience of how the Church was commissioned on Pentecost and sent out to how it is foreshadowing what is to come with the word of the Holy Spirit during the Tribulation period. Based on the astronomical patterns, the association of the Rapture to Pisces and/or Virgo could be a clue as to what time of the year the Blessed Hope could occur. This study suggests that the Pisces constellation in this correlation to the Equinox eclipse pattern could be marking the time segments of the progression of the Church Age throughout time since Jesus Christ's ascension.

On one level of interpretation, the constellation of Pisces will be likened to the trajectory of the resurrection of Jesus Christ as one of the Fish of the constellation that is going up. The other Fish depiction will be likened to that of the Church Age going out. On the other hand, the Fish mounting Pegasus can be likened to the Bride of Christ that takes swift flight. The other Fish of Pisces will be that of Israel that will remain and subsequently will be the focus and attention of YHVH's final discipline and fulfillment of prophetic time. Thus, the notion of an Astronomical Rapture is tied more so to the pattern of the Equinox eclipses that occurs, specifically in Pisces. It is rather interesting also that Pegasus and Andromeda are directly connected to Pisces. In one level of possible interpretation, the direction of the flight that Pegasus is taking the Raptured Church, i.e., the Chained Woman is towards the Golden Gate.

Perhaps this is the Gate of the Sheep that Jesus alluded to. This portal or gate is at the Galactic center where the Galactic Plane and the Ecliptic intersect and is in-between Sagittarius and Ophiuchus. In a Stereographic rendering of the universe using Stellarium, it is rather interesting that the depiction of Pegasus and Andromeda take center stage in-between the 2 celestial gates. The Astronomical Rapture is center from that of the Golden Gate, the Gate of GOD and the Silver Gate, the Gate of Man. This astronomically interpretation of a possible celestial Rapture gate is speculative but possible as the Rapture does not necessitate such a rendering. The Bible only depicts that the Bride will meet the LORD first in the air.

This though is just the rendezvous place for the Dead in Christ that are raised up first and then those that are alive are caught up together. There is no lagging of 40 days as some assert that the raised 'Dead' will be witnessing to loved ones after the Resurrection of the Dead. There is a secondary level of possible interpretation as one of the Fish of Pisces mounts up on Pegasus and the other does not. This 2nd interpretation has to do with what is going to occur at the point of the Rapture as some interpret the Bible's typologies. This has to do with Elijah and Elisha. The LORD sent the celestial limousine, the fiery horse chariot for Elijah as his commission was completed. As the 2 men of YHVH were walking along, it was understood that a 'translation' was about to occur. Nonetheless when the 'Pegasus' came for Elijah as a type of a trodden down and weak 'Andromeda', it was he that went up, the 1st Fish.

It was Elisha that stayed with the Mantle of Elijah, the 2<sup>nd</sup> Fish of Pisces. Elijah was considered the Weeping Prophet because he witnessed to Israel, YHVH's people during a time of great apostasy and mistreatment; just like today. Elijah's vindication was the Rapture. Thereafter Elisha witnessed to Israel and with a double portion. It will be at this time that a transference of the 'Mantle' occurs from the Church back to Israel. Perhaps a double portion can be likened with the 144,000 and the 2 Witnesses of which one is to be Elijah of all things. It will be because the Church's Royal Commission is completed, much like Elijah and the recalling home of the King's Ambassadors occurs just before war is declared. Christ will be declaring war on the Earth.

This is what He told specifically to the Church of Philadelphia that they were to be kept from the 'hour' ...of the Tribulation period that was to come to test those in the world and to discipline Israel and finish Daniel's 7th prophetic week of years. The Church Age is a parenthetical time period often referred to as the Mystery Age, the Age of Grace, of the time of the Gentiles in-between the 69th and the 70th prophetic week of Daniel. Jesus stipulated that the Age of the Church Age would end one day. This means that the commission of His Gospel thus is to be thereafter transferred over to the 144,000 Jewish Evangelists and the 2 Witness for the purposes of the last prophetic week of Daniel to conclude Israel's discipline as foretold by the LORD Jesus on the Olivet Discourse.

This is one reason why this study suggests that the Church cannot be present during this same time period of overlapping commissions of the 144,000 and/or the 2 Witnesses at any point of the Tribulation, even if pre-wrath. This overlap would correlate to having Elijah still being present during Elisha's ministry and witness. A transference of the Mantle of Prophecy and Testimony to Jesus is what will occur at the time of the Rapture of the Bride of Christ as the Rapture will be the vindication of the Bride of Christ. She that has been weak and broken at times throughout the Church Age will take flight by the one who is coming from afar, a Pegasus, the LORD Jesus.
