Smith also requested that the Board adopt a resolution declaring Rainbow Lake a no-wake lake until the water level has receded. Hansen will add this item to the March 9, 2020 meeting agenda.

The meeting was paused at 8:31 PM to allow members of the public not wishing to stay for the remainder of the meeting to leave. The meeting resumed at 8:45 PM.
