

ORDINANCE No. 1970-2

AN ORDINANCE ANNEXING TERRITORY TO THE
TOWN OF CLOVERDALE, INDIANA

SECTION I: BE IT ORDAINED by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described territory outside the Town of Cloverdale, Indiana, but adjacent thereto and within the County of Putnam, be and the same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana, to-wit:

Beginning at a point on the North corporation line of the Town of Cloverdale, which point is on the West right-of-way line of Indiana State Road #43 as said right-of-way line exist 1 January 1970, said point being in the Southwest fractional quarter of Section 31, Township 13 North, Range 3 West; thence Northwesterly with the aforesaid West right-of-way line to the South line of the North half of the Northeast quarter of ~~Section 36~~ ^{Section 36} ~~thence West with said South line to the East right of way line of the Monon Railroad; ~~thence~~ ^{Range 4 West}~~ Northwesterly with said East right-of-way line to the North right-of-way line of Interstate Highway 70, the said point being in the Northeast quarter of the Southeast quarter of Section 26, Township and Range aforesaid; thence Northeasterly with said North right-of-way line to the East line of the Southwest quarter of Section 25, Township and Range aforesaid; thence North to the Center of said Section 25; thence South 89 degrees 30 minutes West 314.48 feet; thence North 0 degrees 54 minutes 30 seconds East 415.54 feet; thence North 89 degrees 30 minutes East to the East right-of-way of Indiana State Road 43 as it now exist; thence Northwesterly with said East right-of-way line to the intersection of said East right-of-way line with the West right-of-way line of Indiana State Road as it existed in 1965; thence North 58 degrees 39 minutes 55 seconds East 30.67 feet to the centerline of said former location of State Road 43, thence South 33 degrees 56 minutes 05 seconds East 493.9 feet with said centerline to the North line of the Southeast quarter of said Section 25, thence East to the Northeast corner of the West half of said Southeast quarter; thence South with the East line of said West half-quarter and the East line of the West half of the Northeast quarter, of Section 36, Township and Range aforesaid; to a point which is 200 feet East of the East right-of-way line (when measured at right angles) to said right-of-way line of State road 43 as it now exist; thence Southeasterly on and along a line parallel to said East right-of-way line and 200 feet from said right-of-way line to the existing corporation line located in the West fractional half of Section 31, Township 13 North, Range 3 West; thence Westerly with said corporation line to the point of beginning containing 270 acres, more or less.

SECTION II: That this ordinance shall be in full force and effect from and after its passage at approval of the Board of Trustees, and legal publication and notification according to law.
