- Delivery of Art: Saturday, July 28 between 4:30-6:00 pm**
 - Exhibit Dates: Thursday August 2 - Saturday August 25
 - Reception: August 11 – 4:00 and 6:00 pm
 - Retrieval of Art: Saturday, August 25, 3:00-4:30 pm***
- ** Special accommodations can be made by contacting Wayne Arts at least 1 week ahead by email/telephone.

ELIGIBILITY:

- This is a judged show open to all Members of Wayne County Council for the Arts.
- All work must be original by the artist.
- Works that have previously been in the Wayne Arts Members' Show are not eligible.

CATEGORIES:

- Paintings/Drawings: Oil, watercolor, acrylic, mixed media, collage, pen and ink, pencil, pastel, photography are accepted mediums.
- Other 2-D Art - etchings, graphic art, prints, including but not limited to lithographs, intaglio, drypoint, engraving, screen, linoleum and wood cut prints.
- Photography: all types of photography are welcome as long as the finished piece begins with a photograph.
- 3-D Art: Sculptures, ceramics, fiber art, collage, assemblage,

ENTRY FEES:

- For Wayne Arts Members the fee is \$20 for up to three pieces.
- Make checks payable to Wayne County Council for the Arts. Credit cards may be accepted.
- *All fees are non-refundable.*

PRESENTATION SPECIFICATIONS:

2-D Art (Paintings and Photographs):

- All 2-D Art must be "installation ready" *wired for hanging so the wire does not show when hung.*
- Works on canvas must be neatly wrapped with staple free edges.
- Framed works larger than 18 x 24" must be framed using plexiglass/acrylic, not regular glass, due to weight.
- Frames and any mats used need to be clean and in good repair.
- Works must not exceed 72 United Inches *including framing* (1 length + 1 width, e.g. 16 x 20" piece is 36 UI).

3-D Art (Sculptures, Ceramics, etc):

- Art work should not exceed 40 pounds in weight unless approved by the Show Chair.
- Pedestals may be available for use depending on size of sculpture. Check with Wayne Arts before entering.

**Wayne Arts reserves the right to reject any art that does not meet Presentation Specifications.*

COMMISSION:

- A commission of 25% will be charged for the sale of work.
- Works do not have to be for sale. They will be marked NFS.
- Monies will be paid to the artist at the end of the show. All sales are handled through Wayne Arts Gift Shop. Wayne Arts will assume responsibility for paying the sales tax.
- *All work must remain on exhibit for the entire show including work sold.*

AWARDS: Cash prizes will be awarded. Only one award may be given to an individual. Award winners must be present or represented at the opening. Award recipients will be notified by the Show Chair.

* *The decision of the juror is final.*

ABOUT OUR JUROR:

Roland "Chip" Stevens is one of the noted watercolor artists in the Rochester, NY area today. His continuous growth and development as a Plein-Air painter in his pursuit of watercolor has enabled him to be accepted into, and win awards in numerous National, State, and Regional juried exhibitions over the last 25 years. He is a "Signature Member" of the Transparent Watercolor Society of America, National Watercolor Society, Philadelphia Watercolor Society, Pittsburgh Watercolor Society, Niagara Frontier Watercolor Society, Central New York Watercolor Society, Rochester Art Club, and Whiskey Painters of America. While all reasonable care will be taken in handling work WCCA does not carry insurance for submitted works and will not assume responsibility for any damage to the artwork during delivery, installation, exhibit and de-installation including, but not limited to normal wear and tear, such as minor nicks to frames or scratches to Plexiglas. It is suggested that an artist wanting more protection insure his or her own art (some homeowner's policies may include protection and should be checked).

All entrants agree that any art they submit to the Wayne Arts' Annual Members Show may be photographed and used for marketing and promotional purposes directly related to the Wayne Arts' Members' Show. This use may include publication in any Wayne Arts' publications, printed materials, advertisements, or electronic media, including but not limited to the Wayne Arts' website, newsletter, and gallery shows. *Any image used by the Wayne Arts shall carry a credit line of the artist. Copyright and all other rights remain that of the artist.*

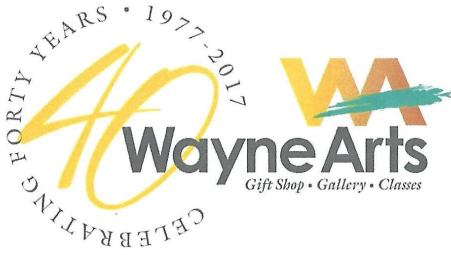
