Life Patterns Inc. is currently working on getting a new communication messaging system in place to better interact with our families. This will help families to be aware of upcoming changes to policies and to the continuous AuthentiCare updates. It will also have text messaging abilities for individual communication that is personalized.

#### **KanCare Waiting List to be Shortened**

The State of Kansas has long had limited funds for those that need Home Community Based Services on the IDD waiver, causing individuals to be placed on a waiting list until there is an opening for services to be available to them.

The State of Kansas has recently granted funds to get approximately **800 individuals** off of the waiting list!

Life Patterns Inc. will try to meet the demand of those individuals and get those with PCS Hours enrolled and set up with a worker as soon as we can.

We will be extremely busy during this time, so please understand if there is a slight delay in response time.

## **AuthentiCare Changes**

Effective May 23, the AuthentiCare call-in system started asking for a "service code" when clocking in. This allows the worker to simply enter in the service code, and not have to listen for correct service in the long list of services. Below is the list of services that families with Life Patterns Inc. would need to be using to clock in and out and the corresponding Service Code.

#### Common issues with AuthentiCare

- \* The new prompt states "If you know your service code, press 1. Otherwise, press #."
- \* Listen **entirely** to this prompt. Then, enter 1 and then # to continue.
- \* Listen to the prompts carefully before selecting the options and be patient. Clocking in and out correctly ensures that workers are being paid.

## Rate Increases Starting July 1st, 2024
