Community Development Report for City Commission Provided by Susan Wettstein June 5, 2019

The Garnett Remembers patriotic banner project kept the month of May busy. The total number of honorees ended up being 216 this year, after accepting 3 more banner applications beyond the deadline. I would like to close this project by the end of this year where we will no longer accept banner applications until such point the banners deteriorate and need to be replaced, but accept donations to help with maintenance, as the brackets holding the banners up may break, etc., from time to time. I have already received 4 banners after the Celebration of Service. However, the number of banner applications have dwindled from the usual 40-50 per year to 21 this year. With over 200 banners it was all the electric crew could do to get them up in time with the weather we have been experiencing. It takes them up to 2 weeks to accomplish this now when there are other electric projects to get done.

Due to the weather we had to move the Celebration of Service inside. We appreciate Principal Krista Headrick and her staff for allowing us to use Garnett Elementary Center for the ceremony, as well as the Jana Havens and the Garnett Area Community Band, and the participation by the American Legion, VFW and American Legion Riders. Also, my sincere appreciation to Administrative Assistant Kris Hix for all her help on this project, and city staff for helping the evening of the event.

We have a great community, and many people showed up at following a storm that passed through the evening of May 24th in which several American flags blew down at the cemetery. It is quite a feat to put up over 300 of those flags on their tall poles, all to have approximately one-third of them blow down, some with poles broken. Members of the Garnett Fire Department went out to retrieve them. City Manager Weiner and Parks Department Superintendent Brian Maloan and some of his employees showed up to take care of the issues. The Parks Department, with the help of City Manager Weiner, packed the flags back out and put them up Saturday morning and Brian continued to check them throughout the weekend. I don't think anyone knows what Mr. Maloan has done over his many years of serving this city in tasks like this. He just does it. I appreciate employees that do it, not because it's their job but because they know it has to be done, and Brian is one of those people.

Also, regarding the cemetery, the Park Department will be pouring a new base for the flagpole located at the cemetery. The flagpole itself is in bad shape and needing to be replaced. A new aluminum flagpole will replace it thanks to the donation of the pole by Tom Adams and Don Wettstein, and partial donation of labor and materials by Mr. Wettstein to transform the pole into a flagpole.

There were approximately 70 entries in this year's Southland Cruisers Car Show. The weather held off and it was a great day in Garnett, thanks to the organizers. The Southland Cruisers have donated \$100 to Libertyfest from the proceeds of their event. We will be launching a fundraising effort for Libertyfest this week encouraging donations to be given to the Garnett Community

Foundation for this purpose. The fireworks are purchased with these donations. No tax dollars are used to pay for the fireworks. Libertyfest will be held Saturday, July 6th with the rain date of July 7th.

The Airport received notice of receiving the KDOT Grant that was submitted in the amount of \$40,500. The 90/10 matching grant means the City would need to pay \$4,050 in order to receive \$35,450 for crack sealing. We are waiting to see if we received any grants from FAA. In other airport news, thanks to the work of Airport Advisory Board Chairman Pat Schettler, the Kansas Air Tour will be making a stop in Garnett on Thursday, September 26th. There will be approximately 40 to 50 aircraft visit that day as part of a tour across Kansas. Pat has been visiting with me on what we can do to encourage the citizens and students from area schools to be a part of the Kansas Air Tour visit and learn about aviation at their local airport, but kudos are definitely due to Mr. Schettler.

The American flags that you see down the highway and on 4th Avenue that have been put up on display for holidays and special events in the past by volunteers of the American Legion and VFW are now, and have been for a little while, being installed by city employees from both the electric and refuse departments. In recognition of "D-Day" on June 6th, city crews are putting the flags on display. I just wanted to inform the Commission and citizens of this.

We are hosting the Kansas Leadership Center Summer Tour stop in Garnett on Tuesday, June 11, from 12 to 1 p.m. at the Dutch Country Café. Lunch is provided for those that attend and it is a free event, but advance registration is required online. A link can be found on our website's bulletin board. Thanks goes to Jennifer Brummel, who encouraged that I submit for this. We will bare no expense on this, only to help encourage the community to attend.

The Chamber Players Community Theatre begins their 29th season on Thursday, June 6th. City employee Ken Amaya is performing in this play.

Economic Development is hosting Jon Shallert for a Destination Business workshop on June 25th. We have been helping to market and promote this event focused on helping small businesses.

Kris has been learning the ropes of what we do in adding information to the <u>www.travelks.com</u> website and Kansas Visitors Guide listings. She is doing very well at picking up the ball and running on projects and is always up for the challenge. She is approaching her one-year anniversary with the City and the Chamber.

Lieutenant Governor Lynn Rogers has selected Garnett, as well as 10 other communities as a part of the Office of Rural Prosperity Summer Listening. The date of Monday, July 22 has been selected for this visit. The Lt. Governor, members of his staff and some state department secretaries will tour a variety of locations in Garnett and Anderson County and engage with citizens during a special Listening Session to be held at the Anderson County Jr.-Sr. High School beginning at 6 p.m. Julie Turnipseed, Director of Economic Development, Kris Hix, Executive Director of the Garnett Area Chamber of Commerce and myself have been designated by the Lt. Governor's Office as the hosts for this event. We will be coordinating with state staff the tour itinerary and helping with publicity.

We welcome the Kansas City Karting Association to Lake Garnett as they host sprint track races this weekend, June 8 & 9. This is the second year for this organization to use this park facility.

The summer issue of Town Talk will be printing soon for mailing out to everyone in the 66032-zip code the end of June.

Due to the weather, the landscaping planned for City Hall and the 5th Avenue meridian is now underway.

GPD Monthly Report for May, 2019.

May 1, 2019, GPD was dispatched to the 200 Blk of W 11th Ave for a physical altercation between two individuals. After an investigation a 19-year-old male was issued a citation for Disorderly conduct and a 27-year-old male was issued a citation for Battery and Disorderly conduct. The case was sent to the City Attorney for review.

May 3, 2019, GPD was dispatched to an auto accident in the 100 Blk of N Cedar. Once GPD and Anderson County Sheriff Office arrived. They were able to determine that the driver appeared to be under the influence of alcohol. The driver fled the scene. Once the driver was contacted by L.E.O. a struggle ensued with LEO and the suspect was tased. The 27-year-old male was arrested and charged with 3rd time DUI, Battery on a LEO, Driving while habitual violator and several other charges. This case was turned over to the Anderson County Attorney office for review.

On May 6, 2019. GPD officer arrested 34-year-old female on a Linn County warrant.

On May 7, 2019, GPD was dispatched to the Dollar Store in Garnett for theft. 17-year-old female was processed and issued a Notice to Appear. This case was turned over to the Anderson County Attorney office for review.

On May 16, 2019, GPD was dispatched to 1000 blk of S Hayes for a past vehicle burglary. The victim reported that the car they had for sale was broken into and the title to the car was stolen. The case is still under investigation.

On May 21, 2019, GPD was dispatched to the 202 E, 2nd for a suicidal person. Once we arrived, we discovered the subject was under the influence of methamphetamine. An investigation was conducted. 26-year-old male was arrested for possession of methamphetamine, marijuana and drug paraphernalia.

On May 22, 2019, GPD was dispatched to 300 Blk of W 9th for a past vehicle burglary. The victim reported that his license plate, registration and proof of insurance was stolen. This case is under investigation currently.

On May 23, 2019, GPD was working the STEP program also known as Click it or ticket ⁴⁸ and conducted a traffic stop for a driver not wearing his seatbelt. A records check was conducted on the driver and found the 25-year-old male driver had suspended drivers license. The driver was arrested, and the case was turned over to the City Attorney.

On May 24, 2019, GPD was on patrol at 1:00 A.M, and notices several individuals at a closed business and one of the individuals was a 16-year-old male. The 16-year-old was issued a citation for curfew violation.

On May 24, 2019, GPD officer was working STEP and noticed a 25-year-old female in the 300 block of W 6th Ave that had active Anderson County Warrant. The female was arrested on the warrant and was found to also be in possession of methamphetamine and marijuana at the time of her arrest. The female was booked into the Anderson County Jail. This case was turned over to the Anderson County Attorney office for review.

On May 24, 2019, GPD officer was working STEP and conducted a traffic stop and the driver, a 50-year-old female, had a Garnett municipal Court arrest warrant. The driver was arrested and taken to the Anderson County Jail.

On May 27, 2019, GPD officer was advised by the Anderson County Sheriff Deputy that he was trying to catch two motorcycles coming into Garnett on US-59 HWY South bound that were checked on radar doing 104 MPH. GPD officer observed two motorcycles near the 300 Blk of North Maple at speed of 51 MPH in a 30 MPH zone. The GPD officer attempted to try and stop the motorcycles one of them stop the other fled from officers. The officer attempted to catch up to the fleeing motorcycle and the motorcycle crashed at the roundabout. The driver of the motorcycle was taken to the Anderson County Hospital in stable condition. This case will be turned over to the Anderson County Attorney office once the investigation is completed.

On May 28, 2019, GPD officer was working STEP and conducted a traffic stop for no seatbelt. The 18-year-old driver had an active warrant, was suspended, had no insurance, and was in possession of drug paraphernalia. During the traffic stop, the officer noticed several irregularities with the driver's story about where they were coming from and living. The officer went to the residence the driver had just left. Based on the investigation from the car stop, this led to the arrest of two other individuals with multiple felony warrants from Miami County, Kansas and Johnson County, Kansas. A search warrant was conducted on the residence for drugs and drug paraphernalia. A large amount of methamphetamine and evidence of sales was located during the search warrant. This case was turned over to the Anderson County Attorney office for review.

On May 28, 2019, GPD took a report of a burglary and theft of a wallet from a vehicle. The owners debit card was being used in Garnett. GPD investigated the incident and suspect(s) have been identified. The case is still under investigation.

On May 29, 2019, at 3:06 A.M, GPD was dispatched to the area of the 800 block of N. Maple for a naked female trying to flag down traffic. GPD was able to find the female in the area. The female then fled from officers on foot and was apprehended and charged with interference with LEO and disorderly conduct.

On May 29, 2019, GPD officers were dispatch to a domestic disturbance in the 200 blk of W 6^{th} Ave. Once officers investigated, it was determined that an adult son and father got into a physical altercation and the father was arrested for domestic battery. This case was turned over to the Anderson County Attorney office for review.

On May 29, 2019, GPD officer was working STEP and conducted a traffic stop. The driver, 26-year-old male had a suspended drivers license. He was arrested and transported to the Anderson County Jail. The case was sent to the City Attorney for review.

On May 30, 2019, GPD was asked to assist the Colorado Highway Patrol by conducting an interview with individuals that were involved/witnessed a multi car crash in Colorado. Interviews were conducted, and reports were forwarded to the Colorado Highway Patrol.

For the month of May, GPD took a total of 240 calls for service, conducted 99 traffic stops, and had 29 calls of service for animal control.

Public Works Report

The department of Gas and Water Distribution welcome two new Public Works employees, Bryan Grissell and John Rogers. I wish them luck as they begin the process of learning about our gas and water distribution system, becoming operator qualified, and performing the duties required on a daily basis.

Mr. Lyle Powers from the K.C.C. will be here June 11-13, 2019 for our annual gas system inspection. Raymond and I have been ensuring all records, inspections and surveys of various system components, and equipment calibrations are up to date.

The Street Department has their hands full repairing roads, both in town and out at the Cedar Valley Reservoir. Alleys are also requiring a lot of continual maintenance with each passing storm. Tree limb removal from storms remains a constant chore at this time. Stormwater runoff has caused a lot of issues throughout the entire town in regards to ditches and waterways, and will be dealt with as fast as time and resources allow.

Jake and I will start taking bids this month on the street repair plan that was just recently approved by the Commission. I would like to thank them for supporting our plan. Our goal is to start as soon as possible and we will keep everyone updated as we move forward.

Thanks also to Jake for helping me replace and replumb the pump at the swimming pool pumphouse.

Met with engineers to discuss possible routes we might take to repair the bridge out at the North Lake that is currently closed. Whether or not the bridge should remain closed until it is fixed is not even in question, as the whole northern end of it has crumbled away. Any further amount of heavy rain and possible flooding will only speed up the process of total collapse. It's also been brought to my attention, by Brian Malone, that we should probably start planning on the same issue arising at another bridge on the northeastern portion of the lake.

We are due this year for our triannual Lead and Copper sampling and testing, and I will be carrying out the gathering of said samples and delivery to the KDHE before the month is up.

Thanks to Tyler Reynolds for tackling the replacement of the 06' International trash trucks power steering gearbox. We recently just received the 89' Ford back, brakes repaired, and will be scheduling the rear seal replacement of the 17' Freightliner.

Finally, I would like to thank all of the various departments personnel that answered their phones at night during the past month to deal with all of the storm and flooding issues, from making sure the clear wells were protected from flooding, barricading roads, unblocking drains, removing debris from roadways, locking down facilities, and a number of other issues outside of their normal job descriptions. I personally appreciate your efforts.

Power Plant monthly report for May 2019

Mowed and cleaned up yards around town for Pat Tate. Basement flooded twice due to heavy rains. Had to pump it out and repair pumps. We ordered a new bigger pump to help keep this from happing again.
