## ORDINANCE NO. 82-6

AN ORDINANCE PROVIDING FOR THE ANNUAL TAX LEVY FOR THE FISCAL YEAR COMMENCING ON MAY 1, 1982, AND ENDING ON APRIL 30, 1983

WHEREAS, the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, did, on the 2nd day of June, A.D., 1982, pass and adopt the Appropriation Ordinance for said Village for the fiscal year commencing on the 1st day of May, 1981, and ending on April 30, 1982; that said Ordinance appropriated the total sum of Four Hundred Three Thousand Two Hundred Dollars (\$403,200.00) for comporate purposes and that said Ordinance was duly published on the \_\_\_\_\_\_\_ day of June, A.D., 1982.
