## Leadership Changes

The COVID-19 Pandemic has affected the leadership of RMGA. For various reasons, three members of the Board of Directors have resigned. I have been appointed president from my previous position as Director at Large.

The remaining Directors welcome these members who have volunteered to fill vacancies on the Board of Directors – J. Mark Blaising, Vice President; Deanna Scott, Secretary; and David White, Director at Large. J. Mark Blaising will also serve as the Program Committee Chair.

According to the Bylaws, these appointments must be approved by a vote of the members at the next regularly scheduled membership meeting. For a successful vote, a quorum of members (20% of members entitled to vote, or  $56 \ge 20\%$ ) – 11 – must cast ballots.

Additional vacancies of Committee Chairs have occurred. Members are encouraged to volunteer to lead these committees:

- Certification
- Education
- Email Blasts

Like many businesses and organizations, the COVID-19 Pandemic is negatively affecting Rocky Mountain Guides Association. Methods of operation that were successful in the past are no longer viable. Long-time members will likely retire from the industry due to the lack of business, leaving more recent members to take up the leadership mantle. RMGA members need to determine in what ways the organization is beneficial to them, then join to actualize that vision.

RMGA faces unprecedented times with the resignations of three officers in 2020 during the traditional nonmeeting season of the summer months. To fill the officer positions within the rules set forth in the RMGA Bylaws, the following chain of events will need to occur:

After the Membership Committee canvassed the RMGA membership, three members volunteered to fill vacancies on the Board of Directors -J. Mark Blaising, Deanna Scott, David White. Deanna Scott specifically volunteered to fill the Secretary vacancy.

During an online vote on August 22, 2020, among the three remaining officers, enough to constitute a quorum, the three members were approved to fill the officer vacancies. The quorum consisted of Ethan Magusin, President; Wendy Pickering, Treasurer; and Mike Pearl, Director at Large.

On Monday, October 5, 2020, a regularly scheduled meeting of the Board of Directors will be held via teleconference at a time to be determined. At this meeting, Ethan Magusin's resignation as President will be accepted. Mike Pearl, Vice President, will succeed Ethan according to the Bylaws, and be installed as President. J. Mark Blaising will be appointed and installed as Vice President.

A few takeaways:


- The economic impact to mountain and rural communities has been better than expected this summer because of the number of visitors from both Colorado and out-of-state.
- The motto "Forge Ahead" expresses the grit of our forbearers. We will get through this.

- Denver International Airport is doing better as compared to other US airports. It had fewer flights cancelled because most of its business is domestic and it is a hub. All international flights were cancelled; hopefully these will resume in November. There is concern about layoffs when the CARES act expires at the end of September. On Labor Day, TSA in Denver had more person contacts than any airport. Planes have never been cleaner.
- African Americans feel more comfortable coming to Colorado since Marijuana was legalized. Colorado tries to be as authentic Colorado as possible. There is a need to recognize issues to be able to welcome all people:
  - Denver is different from the rest of Colorado
  - Minorities see open carry with guns
  - There is a history of strong Klan presence
  - Strong history of racism
  - There is an openness to learn about issues
- The Great American Outdoor Act was a tremendous help in the preservation of our National Parks and Monuments.
- The overall message was things will get better; however, there will be challenges ahead. There needs to be more support from Congress; we need to reimagine Colorado Tourism (what changes, such as street closures or requiring reservation need to become permanent), evaluate what is the true cost of tourism regarding the need for additional housing, electricity, trash removal, water, and asking what do the citizens want. Overtourism is an issue.
- The future will be road trips, local travel, fewer conferences, events, business trips.
- The U.S. Travel Association is working to secure relief and protection by educating law makers by explaining 50% of industry employees lost jobs, how industry will be harmed and the impact to families. The first round of relief helped. Now there needs to be another round of relief.

The 2021 Gov. Con is set to take place Sept. 22–24, 2021, at The Westin Snowmass Resort.


