GOOD NEWS: YOUR VOICES ARE HEARD!

The following is from Mary Kaarmaa, the Orange County Child Care Regional Manager of Child Care Licensing, who came to speak to the members of OCCCA at our September General Meeting:

"I wanted to let you know the issue that one of the providers raised at the September meeting regarding concerns about the Large Family Child Care Home provider's address being on the new Department website has been raised by other licensees also – the Department has listened to these concerns that large FCCH providers don't want to be treated any differently than the small. They are all operating out of their private homes and have a need to protect their privacy, and address, also the safety issue for children is the same for large providers as the safety of children in small family homes. The Department is changing the transparency database information. The Department is removing the street address from large family child care homes in the database and replacing it with "street address unavailable and there will not be a display map location for large family child care facilities."

FROSTED REINDEER COOKIES

By Doing it Right January 04, 2007

INGREDIENTS

1 (16 1/2 ounce) packages refrigerated sugar cookie dough
1/4 cup all-purpose flour
1 cup vanilla frosting
64 small pretzel twists
64 semi-sweet chocolate chips (about 1/4 cup)
16 gumdrops, cut in half

DIRECTIONS

Pre-heat oven to 350 degrees.

In a large bowl, break up cookie dough, and work flour into dough until well blended.

Shape dough into triangle-shaped log. (If dough is too soft, place in freezer for 30 minutes).

With a thin sharp knife, cut dough into 32 (1/4 inch) triangular slices.

Place 2 inches apart on ungreased cookie sheet.

Bake 7-11 minutes or until set.

Cool completely on rack

Frost cookies with frosting.

Place 2 pretzel twists at the top , near the corners for antlers.

Lightly press 2 chocolate chips into each cookie for eyes and 1 halved gum drop for the nose.

Store in between sheets of waxed paper in an airtight container.

SPECIAL BOARD MEETING RESULTS

Linda Zoelle has asked me to post the results of the Special Meeting that was called on September 15, 2014. The meeting was held to discuss the dissolution process of OCCCA if there were no volunteers to run for the Executive Board. I am happy to report that we were able to fill all of the positions and there will be no need to disband the Orange County Childcare Association. We are still in need of people to shadow-train with the current Board, should there be a need for someone else to step in. According to our By-Laws, when a Special Meeting is called, especially one that could dissolve OCCCA, it is to be announced to the Membership at large. Thank you to all of those who stepped up and are doing their part to keep OCCCA going. Thank you to all for all your patience and understanding during this most difficult time.

Cold and Flu season is upon us. It is best to be informed and prepared. We thought the following article on Enterovirus D68 would be of interest to you and your families.

Enterovirus D68 (EV-D68) is one of more than 100 non-polio enteroviruses. This virus was first identified in California in 1962.

What are the symptoms of EV-D68 infection?

EV-D68 can cause mild to severe respiratory illness.

Mild symptoms may include fever, runny nose, sneezing, cough, and body and muscle aches.

Severe symptoms may include wheezing and difficulty breathing. See [EV-D68 in the U.S., 2014](#) for details about infection occurring this year.

Anyone with respiratory illness should contact their doctor if they are having difficulty breathing or if their symptoms are getting worse.

How does the virus spread?

Since EV-D68 causes respiratory illness, the virus can be found in an infected person's respiratory secretions, such as saliva, nasal mucus, or sputum. EV-D68 likely spreads from person to person when an infected person coughs, sneezes, or touches a surface that is then touched by others.

What time of the year are people most likely to get infected?

In the United States, people are more likely to get infected with enteroviruses in the summer and fall. Cases are likely to decline later in the fall.

How common is EV-D68 in the United States?

In general, a mix of enteroviruses circulates every year, and different types of enteroviruses can be common in different years. Small numbers of EV-D68 have been reported regularly to CDC since 1987. However, this year the number of people reported with confirmed EV-D68 infection is much greater than that reported in previous years. Who is at risk?

In general, infants, children, and teenagers are most likely to get infected with enteroviruses and become ill. That's because they do not yet have immunity (protection) from previous exposures to these viruses. We believe this is also true for EV-D68. Adults can get infected with enteroviruses, but they are more likely to have no symptoms or mild symptoms.

Children with asthma may have a higher risk for severe respiratory illness caused by EV-D68 infection.

How is it diagnosed?

EV-D68 can only be diagnosed by doing specific lab tests on specimens from a person's nose and throat.

Many hospitals and some doctor's offices can test ill patients to see if they have enterovirus infection. However, most cannot do specific testing to determine the type of enterovirus, like EV-D68. CDC and some state health departments can do this sort of testing.

CDC recommends that clinicians only consider EV-D68 testing for patients with severe respiratory illness and when the cause is unclear.

What are the treatments?

There is no specific treatment for people with respiratory illness caused by EV-D68.

For mild respiratory illness, you can help relieve symptoms by taking over-the-counter medications for pain and fever. Aspirin should not be given to children.

Some people with severe respiratory illness may need to be hospitalized.

There are no antiviral medications currently available for people who become infected with EV-D68.

How can I protect myself?

You can help prevent yourself from getting and spreading EV-D68 and other respiratory illnesses by following these steps:

Wash hands often with soap and water for 20 seconds. See [Handwashing: Clean Hands Save Lives](#).

Avoid touching eyes, nose and mouth with unwashed hands.

Avoid close contact such as kissing, hugging, and sharing cups or eating utensils with people who are sick.

Cover your coughs and sneezes with a tissue or shirt sleeve, not your hands.

Clean and disinfect frequently touched surfaces, such as toys and doorknobs, especially if someone is sick.

Stay home when you are sick.

There are no vaccines for preventing EV-D68 infections.

What should people with asthma & children suffering from reactive airway disease do? Children with asthma are at risk for severe symptoms from EV-D68 and other respiratory illnesses. They should follow CDC's guidance to maintain control of their illness during this time.

CDC recommends:

Discuss and update your [asthma action plan](#) with your primary care provider.

Take your prescribed asthma medications as directed, especially long term control medication(s).

Be sure to keep your reliever medication with you.

Get a flu vaccine when available.

If you develop new or worsening asthma symptoms, follow the steps of your asthma action plan. If your symptoms do not go away, call your doctor right away.

Parents should make sure the child's caregiver and/or teacher is aware of his/her condition, and that they know how to help if the child experiences any symptoms related to asthma.

HOLIDAY CRAFT: CRAFT-STICK HOLIDAY TREE

What You Need for each Tree

Green, yellow and brown paint and paintbrushes

Craft sticks: 2 large, 3 medium, and 2 small

Wooden star cutout or small die-cut star

Decorations: glitter, stickers, sequins, and foam cutouts

Craft glue

What You Do

Take a large craft stick and place it vertically, to make a base for the other sticks.

Glue a craft stick across the bottom of the first, leaving just enough room to form a tree trunk.

Glue the three medium-sized sticks horizontally above the large stick.

Next, glue the small sticks above the medium sticks, leaving enough room for a star on top.

Paint the tree trunk brown and the branches green -- or whatever colors they are inspired to use!

Set aside to dry.

Paint the star yellow, or use glitter and glue to jazz it up. Set aside to dry.

After all elements are dry, glue the star to the top of the tree.

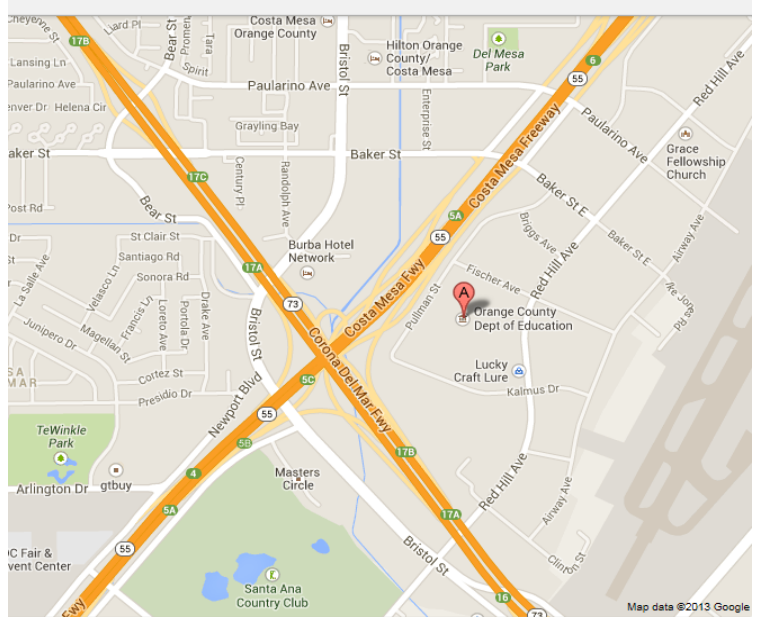
