A RESOLUTION TO PROCEED AND SUBMIT THE QUESTION OF LEVYING A TAX OUTSIDE THE TEN-MILL LIMITATION CURRENT OPERATING EXPENSES FOR THE VILLAGE IN VILLAGE OF RICHWOOD, UNION COUNTY OHIO, AND DIRECTING THE FISCAL OFFICER TO CERTIFY AND TO FILE THE NECESSARY DOCUMENTS WITH THE BOARD OF ELECTIONS.

The Richwood Village Council, Village of Richwood, Union County, Ohio, met in special session on 1/30/2025, at the Village of Richwood Hall, 153 N Franklin Street., Village of Richwood, 43344, with these members present: Wm Reddy Brown, Von Beal, Brad Plotner and Donald Ridgeway,

 Von Beal introduced this resolution and moved its passage:

WHEREAS, on January 13, 2025, the Village of Richwood’s Village Council passed a resolution declaring the necessity, for the purpose of current operating expenses for the village, to levy a tax in excess of the ten-mill limitation under R.C. §5705.19(A) at the rate of 1.2 mills for each one dollar of taxable value for five (5) years; and

WHEREAS, on January 21, 2025 the Union County Auditor has certified to the Village of Richwood Council this information as required by R.C. §5705.03(B)(2)

- The total current tax valuation of the Village of Richwood village is (\$45,042,800.00);
- the amount of tax to be generated per \$100,000.00 of the county auditor’s appraised value is \$23.50;
- the estimated annual collections based on the current tax list for Village of Richwood Village, Union County, Ohio is \$30,850.00

THEREFORE, BE IT RESOLVED BY THE VILLAGE OF RICHWOOD COUNCIL, UNION COUNTY, OHIO, THAT:

The council, two-thirds of all members elected thereto concurring, that the council desires to proceed with submitting the question of a renewal tax levy for the purpose of current operating expenses under R.C. §5705.19(A) at the nominal rate of 1.2 mills for each one dollar of taxable value, which amounts to an effective rate of Twenty Three and 50/100 Dollars (\$23.50) for each \$100,000.00 of the county auditor’s appraised value, to the electors of Village of Richwood.

RESOLVED, that the tax levy will be for five (5) years and such levy will include a levy on the current year’s tax list, beginning in 2025, first due in calendar year 2026, if approved by a majority of the electors voting on the question.

RESOLVED, the question of such tax levy shall be submitted to the electors of Village of Richwood at the election to be held therein on May 6, 2025.

RESOLVED, that on or before February 3, 2025 the Fiscal Officer is hereby directed to certify to the board of elections, Union County, Ohio, a copy of the Resolution of Necessity, a copy

the certification of Estimated Revenue by the Union County Auditor, and a copy of this Resolution to Proceed, to notify the Board of Elections to cause notice of election on the question of levying the tax to be given as required by law.

RESOLVED, that it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were passed in an open meeting of this Board, and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, and in compliance with all legal requirements including Revised Code §121.22.

Donald Ridgeway seconded the motion, after discussion, the roll was called on the question of its adoption. The vote was:




