



# ANNUAL MEMBERSHIP FORM INSTRUCTIONS

For New Members signing up

between October 1<sup>st</sup> and December 31<sup>st</sup>

- 1.) The membership of New Members joining the chapter between October 1<sup>st</sup> and December 31<sup>st</sup> will be valid from the date they sign up through the end of the next calendar year.
- 2.) Because membership forms are only valid for the year printed at the top of the form, new members who join the chapter between October 1<sup>st</sup> and December 31<sup>st</sup> must fill out, sign, and return two membership forms; one for the current calendar year and one for the upcoming year.
- 3.) Biggs HOG Annual Membership Forms can be filled out electronically and then printed and signed, or you can print out the forms and fill them out by hand (please make it as legible as you can), and then sign them.
- 4.) Once the forms are completed and signed, they must be returned to the chapter's Membership Officer. There are two options for doing this:
  - a. Hand it to the Membership Officer at a Chapter Meeting (Chapter Meetings are held the second Friday of every month but December)

- 5.) Please include cash or check in the amount of \$25.00 to cover your annual membership dues, or use the PayPal link near the bottom of the Forms page on the Chapter Website and write "PayPal" on the payment section of the membership form. For new members joining between October 1<sup>st</sup> and December 31<sup>st</sup>, the \$25.00 dues fee will cover the balance of the current year and all of the upcoming year. *(Note that your membership in Biggs HOG will not activate until your dues payment is received)*
- 6.) Please note the following:
  - a. Biggs HOG membership is on a calendar year basis, valid from the date of joining or renewing until the end of the calendar year shown at the top of the membership form. All members must renew annually to retain membership. Per National HOG rules, there are no Lifetime chapter memberships.
  - b. You must be a current member of National HOG to become or remain a member of Biggs HOG. National HOG membership dues are separate from Biggs HOG dues, must be paid to National HOG, and renew on the anniversary date of your National HOG membership.
