Bloomfield Police Department Monthly Report for November 2017

This is the monthly report for the Month of November 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Tuesday, November 7th at approximately 6:28pm officers responded to a residence on Lake St. in Powers Lake for a bail jumping complaint. A 24-year-old male suspect, who had fled the scene was subsequently located, arrested and confined in the Walworth County Jail. A charge of misdemeanor bail jumping was forwarded to the Walworth County District Attorney's office.

On Wednesday, November 8th at approximately 11:03pm officers executed a traffic stop on Hwy 50 after observing a vehicle traveling on the wrong side of a divided highway. At the conclusion of the traffic stop a 32-year-old female was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for operating wrong side of a divided highway.

On Friday, November 10th at approximately 3:15pm officers responded to a report of a single vehicle crash at the intersection of Pell Lake Drive and Hwy U. At the conclusion of the investigation a 51-year-old male was issued traffic citations for unsafe lane deviation, failure to notify police of an accident and failure to yield right of way from a stop sign.

On Tuesday, November 21st at approximately 5:32pm officers responded to a report of a disorderly male subject operating a vehicle recklessly at N2023 Hwy H. It was reported the male subject had placed or thrown suspicious devices around the property. A 46-year-old male was taken into custody without further incident. Roadways and the area were closed for several hours for safety reasons while the Kenosha County Bomb Squad rendered the suspicious devices safe and evidence was collected. The male subject was confined in the Walworth County Jail. Charges of recklessly endangering safety, possession of explosives for unlawful purposes, carrying a concealed weapon, disorderly conduct and trespassing were forwarded to the Walworth County District Attorney's office.

On Friday, November 24th at approximately 6:35pm officers received a criminal damage to property complaint which occurred at Spoon Doggers on S. Lakeshore Drive. The owner reported that person(s) unknown by unknown means damaged the advertisement sign affixed to the side of the business.

During the month of November 2017 officers from the Bloomfield Police Department affected 8 arrests for warrants issued by the Bloomfield Municipal Court satisfying approximately \$2,454.00 in outstanding forfeitures.

During the month of November 2017 the Bloomfield Police Department responded to 1006 calls for service compared to 582 calls for service during the month of November 2016. During the month of November 2017 the police department affected 106 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 88 arrests during the month of November 2016.
