

**ORDINANCE OF THE COUNCIL OF THE VILLAGE OF RUSSELLS POINT,  
LOGAN COUNTY, OHIO**

**AN ORDINANCE CONFIRMING THE APPOINTMENT OF A VILLAGE FISCAL  
OFFICER, ESTABLISHING THE COMPENSATION FOR THE VILLAGE FISCAL  
OFFICER, AND DECLARING AN EMERGENCY**

**WHEREAS**, pursuant to R.C. 733.262, the Council (“Council”) of the Village of Russells Point previously passed an Ordinance combining the duties of clerk and treasurer into one appointed office known as the Village Fiscal Officer (“Fiscal Officer”); and

**WHEREAS**, R.C. 733.262(D) provides that, “[a] village fiscal officer shall be appointed by the mayor of the village, but that appointment does not become effective until it is approved by a majority vote of the village legislative authority”; and

**WHEREAS**, the Village of Russells Point has been without a fulltime Village Fiscal Officer; and

**WHEREAS**, to ensure that the Village fills the position of Fiscal Officer in a timely manner, the Mayor of the Village announced the appointment of Marc McGuire as Fiscal Officer effective February 24, 2025; and

**WHEREAS**, Council provided by prior Ordinance that compensation for the Fiscal Officer shall be established by further ordinance; and

**WHEREAS**, it is necessary and appropriate to consider the experience and qualifications of the specific person appointed by the Mayor, as well as market and other fiscal considerations, when determining compensation for the Fiscal Officer; and

**WHEREAS**, Mr. McGuire is well-qualified to hold the position of Fiscal Officer; and

**WHEREAS**, due to the current lack of a full time Fiscal Officer, it is necessary for the Village to determine Mr. McGuire’s employment status and compensation without delay;

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF RUSSELLS POINT, LOGAN COUNTY, OHIO, AT LEAST A MAJORITY THEREOF CONCURRING THAT:**

**SECTION I**

Marc McGuire is hereby appointed and confirmed as Fiscal Officer for the Village of Russells Point effective February 24, 2025.

**SECTION II**

As compensation for serving as Fiscal Officer, and in view of Mr. McGuire's specific qualifications, the Village shall pay Mr. McGuire an annual salary of \$70,000.00, payable bi-weekly in the amount of \$2,692.31. Council may change the foregoing rate of pay or other compensation for Mr. McGuire by subsequent resolution adopted from time to time. All other benefits and time off shall be provided in the manner specified by separate ordinance or in the Village's handbook, with the exception that vacation shall accrue at the maximum accrual rate of 4 weeks per years in recognition of Mr. McGuire's 10+ years in public finance. Further as Mr. McGuire is transferring from a separate governmental position, he shall be permitted to port all accrued sick time and vacation hours currently banked with the prior municipality.

Mr. McGuire's direct supervisor shall be the Mayor of the Village of Russell's Point and the position shall require a minimum of 32 hours per week.

**SECTION III:**

That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this council and that all deliberations of this Council, and any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of the Ohio Revised Code.

**SECTION VIII:**

This Ordinance is hereby found to be an emergency necessary for the public welfare because the Village of Russells Point requires the professional advice of a full time Fiscal Officer to ensure its continued stability, maintain timely and appropriate accounts, and to safeguard the fiscal integrity of the Village to protect the health, safety, and welfare of the Village and its citizens. It shall take effect and be in full force immediately upon passage.
