Gay Men's' Chorus was not a 501 c (3) organization. That information IS WRONG. Verbal apologies were made and the board president will send a letter to the director of the Chorus making him aware of the fact that the mistake and misstatement were made and we are correcting the information and that we are sorry for any problems this may have created. Motion by Bob E, 2^{nd} by Mike H that the previous meeting minutes are corrected to show that the Chorus is a 501 c (3) organization.
