Monthly Report for July 2018

This is the monthly report for the Month of July 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Tuesday, July 3rd at approximately 9:59am officers responded to a residence in the 1400 block of Highland Blvd for a criminal damage to property complaint. The complainant reported that person(s) unknown broke the rear drivers' side window of a vehicle parked in the driveway.

On Wednesday, July 4th at approximately 10:24pm officers executed a traffic stop on Poinsetta Road for a traffic violation. At the conclusion of the traffic stop a 63-year-old male was arrested then confined in the Walworth County Jail. Charges of operating a motor vehicle while intoxicated 4th offense have been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued traffic citations for operating left of center and operating without insurance.

On Saturday, July 7th at approximately 2:09pm officers responded to the 800 block of Violet Road for a reckless driving complaint. At the conclusion of the investigation a 17-year-old driver was issued a traffic citation for unreasonable/imprudent speed and a non-traffic citation for disorderly conduct with a motor vehicle. A second driver involved, a 16-year-old was issued traffic citations for unreasonable/imprudent speed, operating a motor vehicle without a valid driver's license and a non-traffic citation for disorderly conduct with a motor vehicle.

On Saturday, July 7th at approximately 8:57pm officers responded to the 800 block of Roman Lane for a fireworks violation. At the conclusion of the investigation a 62-year-old male was issued a non-traffic citation for an illegal fireworks violation.

On Thursday, July 19th at approximately 2:04pm officers responded to the Southern Stop, N1083 Hwy U for a burglary complaint. The complainant reported that person(s) unknown entered a building removing a Masterbuilt electronic smoker and released approximately 300 pheasants from their coupe. This incident remains under investigation.

On Monday, July 23rd at approximately 10:29am officers responded to the 1300 block of Fairview Road for a criminal damage to property complaint. The complainant reported that person(s) unknown damaged the front window of the residence with what appeared to have possibly been a BB gun.

On Wednesday, July 25th at approximately 8:59am officers responded to the 1400 block of Daisy Drive for a report of a domestic disturbance. At the conclusion of the investigation a 22-year-old male was issued non-traffic citations for disorderly conduct and resisting/obstructing a police officer. Charges of battery and disorderly conduct have been referred to the Walworth County District Attorney's office for a 22-year-old female who was also involved in the altercation.

On Wednesday, July 25th at approximately 4:12pm officers responded to the parking lot of Trinity Lutheran Church, W775 for a fight in progress. At the conclusion of the investigation a 21-year-old male, a 20-year-old male and an 18-year-old female were all issued non-traffic citations for disorderly conduct.

On Wednesday, July 25th at approximately 8:06pm officers received a damage to automobile complaint. A driver who had been traveling on Hwy 12 reported that in the area of Bloomfield Road she observed people standing on the overpass. The driver reported they believe someone threw something off the overpass which struck the vehicle causing minor damage to a mirror. Officers checked the area but were unable to locate anyone.

On Sunday, July 29th at approximately 8:29pm officers executed a traffic stop in the area of Geranium Road and Jasmine Road for a traffic offense. At the conclusion of the traffic stop a 21-year-old female was issued a citation fail/improper stop at a stop sign. Additionally, a 22-year-old male passenger was issued non-traffic citations for possession of marijuana and possession of drug paraphernalia.

On Monday, July 30th at approximately 11:15am officers received an illegal dumping complaint on Litchfield Road in the area of Clover Road. At the conclusion of the investigation a 70-year-old male was issued a non-traffic citation for littering after he and a female passenger were observed dropping off tires on the side of the roadway.

During the month of July 2018, the Bloomfield Police Department responded to 769 calls for service compared to 1014 calls for service during the month of July 2017. During the month of July 2018, the police department affected 162 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 9889 arrests during the month of July 2017.
