City Council Minutes

April 4th, 2016

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Pat Nathe, Dan Krueger, Shawn Duevel and Ron Doll were present.

On a motion by Ron Doll, seconded by Dan Krueger and carried the minutes from March 7th, 2016 were approved.

Fire Chief, Allen Fiedler was present and informed the Council of three medical calls last month. First Responder class is held in Melrose. Number 1 pump mac is leaking and loosing pressure, down to one reliable pump. Starting March 21st burn restriction is on. Allen also submitted a few bills that need to be paid.

Waste/Water Operator, Tom Valerius was present and informed the council that everything is running well. The City received a letter from MPCA to inform us that SIU was missing a pH level. Tom will contact MPCA and give them the pH level. Tom switched over to summer on the ponds, just using the North pond right now. Tom will be increasing the water levels for the project on April 12th. Wheels water will acid treat the lines.

Jaycee member, Ann Piotrowski was present for approval on a couple of one day, On-Sale Liquor Licenses for August 26th (Johnny Holm) 6pm-1am and October 8th (Firemen's Supper) 4pm-1am. On a motion by Shawn Duevel, seconded by Ron Doll and carried the following liquor licenses were approved.

Tom Newman's building permit is tabled until the City can find out more information about the flood plain.

On a motion by Dan Krueger, seconded by Pat Nathe, carried and approved, Steve and Judy will move a shed from New Munich Gas and Grocery to their property.

On a motion by Pat Nathe, seconded by Dan Krueger and carried the following building permits were approved, Steve and Judy Uphoff, Carrie Poepping, Justin Boecker, Pat Nathe, Belgrade Co-op, Ryan Venske and New Munich Gas and Grocery.

New Munich Hofbrau owner, Aimee Gerads was present and asked the Council if they could amend the Liquor Ordinance so the bars could hold outdoor events. The City Clerk will get options from the City Attorney and keep Aimee informed. If any changes are made the City will need to hold a public hearing.

The City is looking into a fire arms ordinance.

On a motion by Dan Krueger, seconded by Shawn Duevel and carried the Treasurer and City Clerk position to be combined was approved.
