At the Special Joint Meeting of the Grand County Council, Grand County Water Conservancy District, Grand County Special Service Water District, and Spanish Valley Water & Sewer Improvement District held 9-21-98 Resolutions were passed by all those public bodies to enter into the Interlocal Agreement to form the Grand Water & Sewer Service Agency.

The Agency will not become fully operational until January 1, 1999. In the interim GCWCD, GCSSWD, and SVW & SID will need to function as they have in the past. President Wilson requested that all members of the Agency Board (which you will remember consists of all members of the three District Boards) attend as many meetings of the individual Boards as possible. The primary work before the Agency for the remainder of 1998 will be to prepare and approve the 1999 budget. Public hearings on the tentative and final 1999 budget will need to be held. The Agency tentative and final budget hearings will be held on the same dates and times as the SVW & SID

hearings (November 10, 1998 and December 16, 1998 at 7:00 p.m. respectively). The Agency hearings will be advertised so that the public may attend and be heard.

At the 9-21-98 organizational meeting President Wilson asked that staff make recommendations to the Agency for that schedule, taking into account the discussions held during the meeting, as well as legal constraints for tax hearings and budget hearings. The proposed schedule meets the requirements of the Utah State Auditors Office for scheduling tax and budget hearings. It also avoids meetings in close proximity to Holidays. Agency Board members should remember that if a quorum of the Operating Committee is present that all Agency Board members have the opportunity to participate in those meetings. All meetings will also be public meetings. The meeting schedules may be finalized at either the 11-10-98 or 12-16-98 meeting.

During the period between now and January 1, 1999 staff will prepare a synopsis of the three District's policies and procedures so that the Agency may discuss and enact policies and procedures of its own early in 1999. Staff will also prepare an overview of the various issues and initiatives which concern or have relevance to each of the Districts so that all Agency Board members will be prepared to address those items as they become Agency issues and initiatives.
