COST \$1050 (Land Package), Air: (Kelowna, BC, YLW, On your own)

Lift Tickets, Choice of 3,4,5 or 6 (Adult or Senior), Limited to 30 people

Lodging will be 6-nights at Cahilty Lodge (Ski in Ski out), 2 Queen Beds, Refrigerator, and Microwave

Plus, Friday February 27 and Friday March 6 at a Kelowna airport hotel

Participants will enjoy a 3,4,5, or 6-day lift ticket of skiing, 6827 Ft top elevation, Vertical Drop 2937 Feet, 144 Trails including 16 Glade Areas, 10% Novice, 58% Intermediate, 32% Advanced.

Trip includes:

- ♦ 6 nights accommodation at Cahilty Lodge plus 2 nights Kelowna, BC (Pre/Post Sun Peaks)
- Round trip motorcoach transfer to/from Kelowna Hotel near airport
- ♦ All Taxes
- Optional Ski Lift Tickets, 3,4,5, or 6 day lift tickets, (Adult or Senior) or IKON Pass
- ♦ Air will be on your own

AIR INFO: You will be doing your own air, this is how things will work. Get air in Kelowna, BC on Friday February 27. A hotel will be set up near the airport for Friday arrivals. The coach will pick everyone up at the hotel Saturday mid Morning and transfer to Sun Peaks. The following Friday March 6, we will ski until 4 pm, then take the coach back to Kelowna, BC. We will have a hotel set up near the airport. You will be able to arrange early morning flights for return home. The travel time will be approximately 2 hr 15 min. Kelowna Air is being used because it is a larger airport and more flight options. Kamloops only has flights via Calgarry or Vancouver. Air routes to Kamloops require 2 stops, you can get into Kelowna with 1 stop, or Toronto non-stop.

Payments due as follows:

- 1. Initial deposit of \$500 per person to reserve space.
- 2. Second payment of \$500 per person is due September 15th
- 3. Third payment of Balance per person due November 1st
