## AFFIDAVIT FOR SEARCH WARR

## STATE OF ARKANSAS COUNTY OF LONOKE SS.

TO ANY SHERIFF, CONSTABLE OR POLICE OFFICER IN THE STATE OF ARKANSAS:

Before the Court of the County of Lonoke, State of Arkansas, the undersigned being duly sworn deposes and says that he has reason to believe that some of the evidence is located at the property described as (1) NW ¼ Section 8 of township 1 North, Range 8 West 160 Acres (2) SE ¼ Section 7 Township 1 North Range 8 West 332.42 acres (4) Southwest/Southeast South of Bayou Section 6 Township 1 North Range 8 West 332.42 acres (4) Southwest/Southeast South of Bayou Section 6 Township 1 North Range 8 West 85.29 acres, more commonly known as the Walls Farm. There now may be concealed certain property to wit: Semen, Tarps, Lotions, Pornographic Books, Magazines and VCR tapes, Explosive residue, wig and dress, and/or other illegal contraband.

The facts tending to establish the forgoing grounds for the issuance of a Search Warrant are as follows:

- A. My name is Charles Peckat (hereafter referred to as the affiant) and I am a commissioned Law Enforcement Officer serving the City of Lonoke since July 7<sup>th</sup>, 1997, I also have 21 years of Police experience with the City of North Little Rock, Arkansas. On Oct 23, 1997, a 18 year old victim, in an investigation of Rape, advised me that Charles A. Walls III called him and wanted him (Victim) to go to the Walls Farm and assist with something. The victim stated that this occurred between June 15, 1997 and July 4, 1997. The victim said that just before his 18<sup>th</sup> Birthday, he went to the Walls Farm. He said that Charles A. Walls III had a tarp laid on the ground with lotion and pornographic books. The victim stated that Charles A. Walls III performed oral sex on him while he (Walls) masturbated himself.
- B. At least one of the victims stated that he was taken to an old school bus on the Walls Farm. He said that Charles A. Walls III performed oral sex on him at the back of the bus,
- C. At least one victim has stated that Charles A. Walls III has taken him to the Farm and used explosives to blow up beaver dams. At least one assault occurred while engaging in this activity.
- D. The victims relating to this search warrant are credible and reliable. A background check does not reflect any criminal history. These victims are still in High School and at least one is actively involved in school activities. These victims have been actively involved in Scouting for years and have obtained the elite position of Eagle Scout.
- E. At least one victim has stated that he was involved in a sexual act with Charles A. Walls III, while on a tarp at the Walls Farm. This act took place sometime between June 15, 1997, and July 4, 1997.

- F. Nude photographs, pornographic books, magazines, and videos were used to excite the young victims. This type material was observed at the Farm between the dates of June 15, 1997, and July 4, 1997.
- G. At least one victim has stated that they were taken to the Farm to shoot guns. This was a method that Charles A. Walls III used to gain the trust of these young victims. At least one victim knew that Charles A. Walls III kept a gun behind his seat and felt threatened.
- H. At least one victim stated that the Walls Farm was used for Scout campouts, and sexual incidents took place on at least one of these campouts.

I therefore request that a Search and Seizure Warrant be issued for the above described property, in the County of Lonoke, State of Arkansas, and then seize any semen, tarps, lotions, pornographic books, magazines and VCR tapes, explosives residue, wig and dress, or any other item deemed as contraband. I further request that the Warrant include not only any outbuildings, as I have described, but also the vehicles on the property whether abandoned or not.
