City Council Votes to Approve Boat Rental and to Support Bowditch Bond Measure

City Council Approves Contract With Edgewater Marine to Rent Boats on the Lagoon

Parks and Recreation Director, Kevin Miller, appeared before the City Council and recommended that the Council pass a resolution approving a contract with Edgewater LLC to rent electric boats on the Lagoon. The resolution would allow Edgewater to exclusively operate a concession which provides a non-captained electric boat rental program on the Foster City lagoon. They will be allowed to park up to three boats at Leo Ryan Park near the Bocci Ball Courts. Miller explained that this location was chosen so that the views from the Rec Center and the Lagoon Room will not be blocked by the rental boats. The location where the boats will be parked is pictured here. There would be no permanent facility as the rental boats would be brought on site each day. There will be many safety procedures that Edgewater will need to



The rental location will utilize the existing cleats for up to 3 vessels next to the aluminum seawall and artificial turf between the central door and the eastern door on the water side of the recreation center. No tie-ups in front of the lagoon room windows (concrete seawall)

Up to three boats may be moored waiting for renter.

Plan Bay Area – Part 2

This article is the follow on to coverage of the “Plan Bay Area.”

In the Draft Environmental Impact Report (EIR), there is a section on Global Climate Change. It is noted that we can experience “sea level rise and increased storm surge during the latter half of the 20th century.”

It goes on to state that there are projections of a sea level rise of seven to 23 inches by the end of the century. I have listened to presentations and one in particular from the Bay Conservation and Development Commission (BCDC) suggesting that we should prepare for a sea level rise of 4 feet by the end of this century. The San Francisco Bay has 1,000 miles of shoreline and it would be a very costly task to construct levees along the shoreline of the entire Bay. I have been unable to locate where in the Plan any mitigation or the cost of constructing such a large system is addressed.

There is also a very small section in the EIR that addresses water supply. The EIR notes, “Changes in local rainfall, salt water intrusion, sea water flooding the delta, and a reduced Sierra snowpack can all threaten the Bay Area’s water supply.” The Plan has projections for San Mateo County for over 100,000 new jobs which will require about 58,000 additional housing units. Where will the water come from to supply not only existing housing



but the increased housing as well?

The water life cycle starts with snow in the winter months landing on the mountain tops. It then melts slowly during the spring and the runoff is captured in dammed valleys and reservoirs for later use. We have essentially used the snowpack as mother-nature’s reservoir. There has been a segment of our population that would rather see the elimination of dams in favor of the restoration of Open Space. However, with global warming approaching, precipitation levels should continue but in the form of rain, not snow. Snow will fall only at the higher elevations and with warmer temperatures, the snow melt will happen sooner and faster. With more water to capture and store in a shorter period of time, where will we store the water until we are ready to use it?

New Bus Information For the New School Year

Limited Bus Service Available From the San Mateo High School District

For the 2013-2014 School Year, School bus service is available to and from Aragon, Hillsdale and San Mateo High Schools from the Foster City area only. School bus service is also available to and from Peninsula High School from San Mateo, Foster City, Burlingame, Millbrae and San Bruno. If your student has an IEP through Special Education he or she may be eligible for transportation at no charge through that program. SAMTRANS Announces Route Changes That Will Impact Students For The New School Year

Following adoption of the SamTrans Service Plan in May 2013, SamTrans staff immediately began to work on implementing the changes. To ensure customers can benefit as soon as possible, some changes are occurring now in August 2013, with the balance of the changes taking place in January 2014.

Information about the changes will be provided with written material onboard buses and through announcements on the bus using the public address and electronic message systems. Another good source of information is through the SAMTRANS Facebook and Twitter accounts.

Changes That Took Effect on Aug. 11, 2013

Routes 390 and 391 will be replaced by Route ECR, which will run every 15 minutes between the Palo Alto Transit Center and the Daly City BART Station. This change will eliminate stops at the San Bruno and South San Francisco BART stations, as well as service into San Francisco. Alternative service into San Francisco for Route 391 customers is available on Route 292, Route KX (peak-hour only), Muni 14, BART and Caltrain. Route ECR currently operates on weekends every 20 minutes. This improved service has generated a ridership increase of

about 4.5 percent. Some routes that serve schools will be renumbered to make the system less confusing. Other than the route number, the service will remain the same. Information on which routes serve schools throughout the county is available at www.samtrans.com/schools.

Changes effective on Jan. 26, 2014

The changes taking place in January 2014 represent a wide range of adjustments to the rest of the SamTrans system. These include increasing how often a bus runs on some routes and realigning routes on a few routes to servicing the college of San Mateo from the Coastside and introducing two alternative service pilot projects. A few changes to note are:

Route KX will operate between Redwood City and San Bruno BART, via the San Francisco International Airport, with

service to San Francisco only offered on weekdays during the peak-hour/peak-direction.

Route 17 will serve Pacifica seven days a week. Route 120 will run more frequently on Sunday. Route 140 will be extended to serve the airport's free Airtran stop.

Route 359 will be discontinued

Route 281 will operate every 15 minutes on weekdays; service will be removed from some areas. Route 296 will run every 15 minutes on weekdays and every 30 minutes on Saturday.

Council Corner... Plan Bay Area

With the move toward Environmental Sustainability that includes water conservation, we have seen higher costs for water and that trend will probably continue. Identifying alternative water sources has been an issue we on the City Council have been watching for many years. Desalination has been identified as a possible solution and continues to be investigated for feasibility. Five of the Bay Area's largest water agencies, which includes the San Francisco Public Utilities Commission (SFPUC), are working together to determine the possibility of a regional alternative water supply. However, this endeavor is not spelled out nor does it seem to be identified in the Plan.

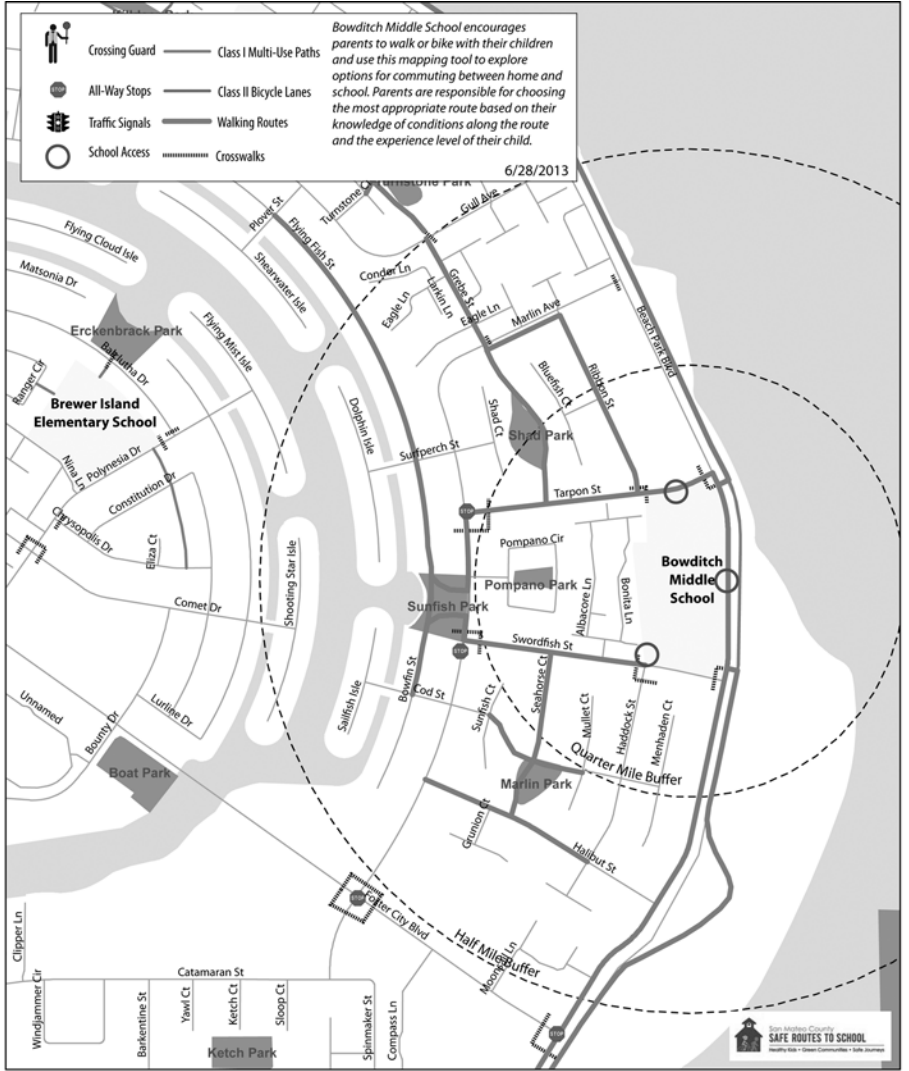
We are able to find projections on population growth that, given my personal experience with Bay Area growth and San Mateo County in particular, seem not unreasonable. The Plan is calling for new housing development to take place along the main transportation corridors and in San Mateo County that equates to El Camino Real and tracks of Caltrain.

However, I do see population growth by age groups and focusing in on the 0-24 age group, I do not see a more granular breakdown of this age group, like the 0-18 age group, the ones of school age. If the majority of the additional population

is to be focused along the transportation corridor, then how will that affect the schools? Schools already located in close proximity to the population could experience overcrowding while those farther away could be less crowded. Real estate in San Mateo County is an expensive proposition. Purchasing land and building additional schools would be a tremendous hardship to already financially strapped school districts that face paying off debt from bonds from prior years. Is there a reason that schools are not part of the Plan?

There are several other questions that would need addressing before the Plan can be successful. One of the phrases from the Plan Bay Area website contains the following phrase: "Housing and its connection to transportation and jobs is key to strong, prosperous communities." Jobs, housing, and transportation are not the only elements to a successful plan, but to go into such great detail about these three without addressing the issues I addressed above seems to be a "partial" Plan. I would think that a long range plan affecting 7 million people and 101 cities, would have addressed other important issues with as much detail.

follow. The rental boats are only allowed to operate in certain areas on the lagoon.

Miller also explained that the agreement with Edgewater Marine will run from September 1, 2013 to December 31, 2016. However, the City may cancel the contract without cause upon 30 days notice. The concession agreement requires Edgewater to pay 7% of the gross receipts to the City. The projected annual revenue for Edgewater Marine LLC for the electric boat rental concession is \$50,000. As such, the City will expect tp receive approximately \$3,500 a year. Parks and Recreation Department staff will provide City Council with a program update upon the completion of six months of operations.

The resolution passed by a 5 - 0 vote.

City Passes a Resolution Supporting the \$130 Million Bowditch Bond Issue

In an effort to relieve overcrowding, upgrade and repair classrooms, labs, libraries and other facilities, and improve technology use in the classrooms, the San Mateo Foster City School District previously approved, by a 4-1 vote, a \$130 million bond measure to be brought before voters at the November 5, 2013 General Election. The measure would cost property owners in the District approximately \$19 per \$100,000 of assessed valuation per year over the term of the bonds. As Councilman Bronitsky pointed out, a person owning a house assessed at \$1 million would pay approximately \$190 per year. The City Council, in a vote of 5 to 0, voted to support approval of the Bond Measure.

Audrey Ng both a Foster City resident and a trustee of the District spoke on behalf of supporting the bond measure. Ng mentioned that the City and the District cooperated in setting up the SCORE committee to look into the overcrowding issue and to consider solutions. Ng said that “we now have a solution, and now this is the next step.” Ng also contended that the bond measure will bring improvements so that students education will move into the 21st Century.

Councilman Kiesel asked School District

Superintendent Dr. Cindy Simms about the possibility that students from San Mateo will be brought into Foster City schools. Dr Simms explained that the question of equity has come up in assigning student from certain areas in San Mateo to the different schools within San Mateo. Simms explained that one member of the District Board has asked if this is done within San Mateo, why shouldn’t we consider moving students from San Mateo to Foster City. Simms explained that this could not happen now, as there is no room in the Foster City Schools. However, if the bond passes the district will pick up 150,000 new seats with the redesign of Bowditch and the reopening of Knowles Elementary School in San Mateo. Simms said that at that point, a discussion about such a plan would occur and another citizen committee would be needed.

During the discussion, Councilman Herb Perez stated that while he would vote to approve the resolution supporting the bond measure, many families have expressed concern to him regarding the scope and size of the new Bowditch School. Perez did say that he was not sure if it was the optimal solution for Foster City, but that he was not going to second guess the process that led to the decision.

Vice Mayor Bronitsky thanked Superintendent Simms and the School Board members for allowing the City Council to have input on the process. Bronitsky countered the arguments that the money from the bond issue should be equally spread amongst the schools in the district by pointing out that: 1) this has never been done before; and 2) that other schools have been rebuilt and improved in the past, and now it was Bowditch and Knowles’ turn to be improved. Bronitsky also spoke to the argument that Foster City should not receive more than San Mateo by pointing out that in the past San Mateo often benefitted more than Foster City with prior programs

Councilman Okamoto, who attended every SCORE meeting, mentioned that there will be a bond oversight committee to make sure that the money was spent wisely. He also explained that no funds will be spent on administrative expenses or salaries. Okamoto explained that the

Foster City Historical Fund Raiser Was a Big Success

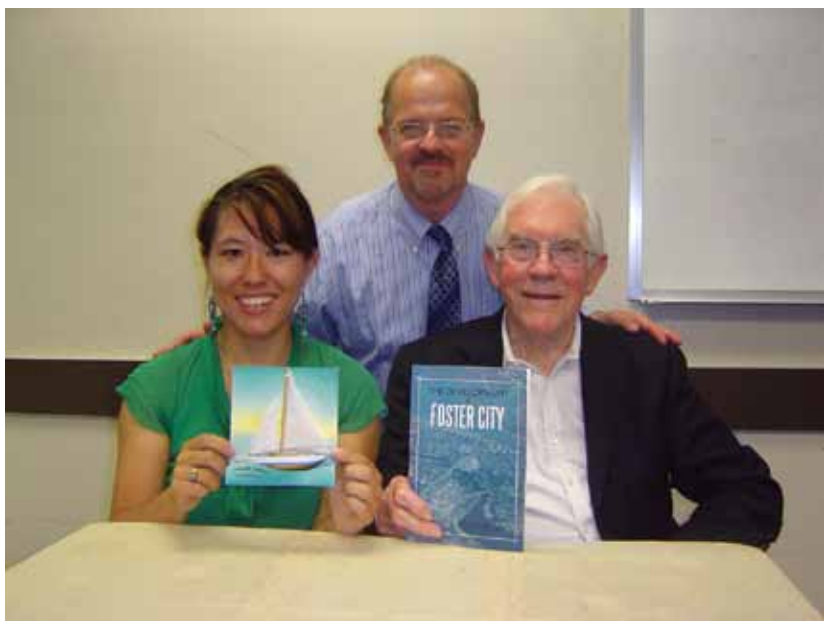

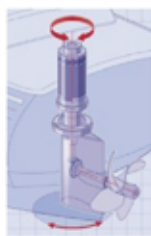

San Mateo Bridge Limo Fire Caused By Failed Suspension System

No Charges to be Brought Against Driver

On May 4, 2013, a Limousine crossing the San Mateo - Hayward Bridge burst into flames and caused the death of 5 female nurses. On Monday, the California Highway Patrol released its findings in at a joint press conference in Redwood City.

According to the CHP report, the fire was caused by a catastrophic failure of the rear suspension system. The air suspension failure allowed the spinning driveshaft to contact the floor pan, causing friction that ignited carpets and set the vehicle on fire. Investigators said one of the rear doors had the child lock engaged, and the other side of the limo was too burned for them to tell.

At the press conference, San Mateo County District Attorney Steve Wagstaffe announced that no charges will be filed against the driver. Wagstaffe said, "Some tragedies are crimes and some are not, and this one is not." However the Public Utilities Commission has announced that it is fining the limo operator \$1,500 for having more passengers than allowed.

Authorities reviewed video and photos of the fire and interviewed survivors, including the limo driver, Orville Brown. Brown said that at first, with the music in the limo turned up, he misunderstood what one of the passengers in the back of the 1999 Lincoln Town Car was saying

when she knocked on the partition window. "I thought she was asking if she could smoke," Brown said in an interview



transcript released Monday. Brown said seconds later, the women knocked again, this time screaming, "Smoke, smoke!" and "Pull over." Brown said he got out and "tried to call 911, but it was busy."

Another passenger, Grace Guardiano, said the driver was "standing out there on his phone," after stopping the limo. "He did not open the doors," Guardiano said. "I went out through the partition and called 911 from outside." Brown claimed that he helped the four survivors escape through the partition. One of the women ran around to a rear passenger door but by then the vehicle was engulfed in flames.

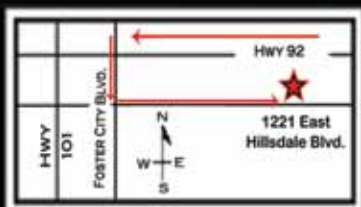
