Subj: SAE/EIA-748E Antithetical to DoDM 5000.100 TEST AND EVALUATION MASTER PLANS AND TEST AND EVALUATION STRATEGIES

Dear Hon. USD (R&E) Emil Michael:

This letter augments the Part 2 letter, dated August 23, with excerpts from DoDM 5000.100 TEST AND EVALUATION MASTER PLANS AND TEST AND EVALUATION STRATEGIES (5000.100 T&E). Draft SAE/EIA-748E is antithetical to 5000.100 T&E because of:

- 1. Its statement that systems engineering is *complementary* to earned value management (EVM) and
- 2. Its guidance that technical performance goals "may" be used to measure progress does not support the following excerpts from 5000.100:
 - DoD systems acquired via the Defense Acquisition System, pursuing any adaptive acquisition framework pathway, in accordance with DoDD 5000.01 and DoDI 5000.02.
 - Measures, metrics, and methods to evaluate the operational effectiveness of the DoD system
 with scientific rigor in an operationally representative and relevant contested, congested, and
 constrained environment including operational users, DoD system defenders, and maintainers.
 These measures, metrics, and methods will be detailed in relevant guidance and will include,
 but are not limited to:
 - Relevant technical measures that enable and derive from operational requirements, concepts of operations, or as specified in other technical specifications supported by contractor test and evaluation (CT&E), developmental test and evaluation (DT&E), and live fire test and evaluation (LFT&E).

Per draft SAE/EIA-748E, "Earned value is a direct measurement of the quantity of work accomplished." However, there are no widely accepted engineering best practices or business best practices that are correlated to or based solely on the quantity of work.

Recommendations

Please take the actions recommended on August 23. SAE/EIA-748E should remain disapproved. Obtain statutory authority. Don't end up like the prisoners in Hotel California who,

"stab it (EIA-748) with their steely knives But they just can't kill the beast"
