MATTHEW'S STORY

Matthew Walker is the son of Jonathan & Cynthia Walker of Heathrow, Florida. Matthew will be 14 years old in September. He is one of three children, Morgan 16 and Adam 11 years old. Matthew is one of approximately 40 known males in the world born with a rare neuronal migration disorder of the brain called Subcortical Band Heterotopia. This disorder is one in which the white and grey matter of the brain are disorganized causing the communication pathways of the brain to be challenged, therefore causing significant impairment in his physical and cognitive abilities. Secondary to Matthew's neurological disorder in recent years, he was diagnosed with a rare form of epilepsy known as Lennox Gastaut Syndrome causing life threatening seizures. Matthew is unable to



walk or talk and is dependent upon his family and professionals to complete his activities of daily living. The ketogenic diet and medications are administered to Matthew through a feeding tube continuously on a daily basis for the control of several different types of seizures. Matthew continues to overcome many challenges on a daily basis. The Corpus Callosotomy brain surgery Matthew underwent two years ago continues to show successful results. Although, Matthew has been averaging 90 seizures per month this is significantly below the 60 seizures per day Matthew was experiencing prior to surgery. Recently, to help Matthew with his current seizures he was prescribed Epidiolex/cannabidiol and is almost seizure free! It is likely that other medications may be omitted in time that are known to cause irritability and discomfort. Also, Gastroenterology issues prevail due to tube feeding 20 hours per day that contribute to reflux. However, changes have been made to try and help overcome this discomfort. Through the help of physical, occupational and speech therapy and Matthew's will to walk and communicate one day he is making great progress on new orthotics for his feet and Tobii Dynavox technology/ computer to help him communicate. Matthew has a new quality of life and the team of doctors and therapist have been diligent in caring for Matthew's condition with various therapies and medication regimens. Matthew will be entering the 7th grade at Millennium Middle School in the Exceptional Student Support Services of Seminole County, Florida. Due to Matthew's medical acuity at this time, Seminole County School Hospital Homebound Services will continue to be available for home visits two days per week one hour per visit. In addition, Matthew will continue to receive physical, occupational and speech therapies to help him reach his ultimate potential. The Annual Golf Tournament Fundraiser was created to assist financially for the care, special facilities and medical attention that Matthew's ongoing disabilities require.
