ORDINANCE 362

AN ORDINANCE DECLARING THE RESULTS OF THE ELECTION HELD APRIL 8, 2025, IN THE VILLAGE OF INNSBROOK, MISSOURI.

WHEREAS, the Village of Innsbrook held a general municipal election to be held in the Village for 3 Trustee positions on April 8, 2025, in accordance with State law; and

WHEREAS, on April 8, 2025, the general municipal election was held in the Village of Innsbrook and the Board of Trustees finds and declares on the face of the returns of the Judges and Clerks the results of the general municipal election; and
