3M designs and Xpel, formulates and manufactures Scotchgard Paint Protection Film Pro Series, Venture Shield, & Xpel Ultimate Films for optimum performance and durability. The 3M and Xpel companies' commitments to quality is the foundation for the warranty coverage we provide.

**Limited Warranty & Limited Remedy:**

ACP warrants that applied Paint Protection Film will be free of defects in materials and manufacture - including yellowing, bubbling or cracking - for

- 5 Years  7 Years from date of purchase.  10 Year/Full Hood

This warranty does not apply to damage caused by misuse, accident, misapplication, or ordinary wear, nor does it apply to dents or damage caused by physical impact of rocks or road debris. The warranty is provided only to the original purchaser and is not transferable. If there is a breach of warranty, then ACP Paint Protection will have an installer remove the old film and apply new Scotchgard or Xpel Paint Protection Film. ACP Paint Protection may choose to offer, on their own behalf, different or additional warranties or remedies, beyond the limited warranty and limited remedy offered by 3M or Xpel. This warranty does not apply to headlight or uncleared film.

**Making a Warranty Claim:**

TO MAKE A CLAIM UNDER THIS WARRANTY IN THE UNITED STATES, PLEASE CONTACT ACP PAINT PROTECTION TO HAVE AN INSTALLER SELECTED BY ACP PAINT PROTECTION TO HAVE YOUR PAINT PROTECTION FILM INSPECTED AND, IF YOUR CLAIM IS COVERED, ACP PAINT PROTECTION WILL HAVE THE INSTALLER PROVIDE THE STATED REMEDY.
