

# Bloomfield Police Department

## Monthly Report for June 2017

This is the monthly report for the Month of June 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Monday, June 5<sup>th</sup> at approximately 12:40pm officers received a theft complaint which occurred in the 1400 block of Moss Road. The complainant reported that person(s) unknown had taken a Simplicity Rototiller out of their yard sometime between June 2<sup>nd</sup> and June 3<sup>rd</sup>.

On Wednesday, June 7<sup>th</sup> at approximately 2:09pm officers responded to a report of a hit & run accident which had occurred in the 800 block of Daisy Drive. At the conclusion of the investigation and through the assistance of a witness a 59-year-old male from Twin Lakes was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense. Additionally, the driver was issued traffic citations for hit & run property damage, failure to report/notify police of an accident and operating a motor vehicle with a prohibited alcohol concentration.

On Monday, June 12<sup>th</sup> at approximately 11:10am officers received a theft of bicycles which occurred in the 1200 block of Clover Road. The complainant reported person(s) unknown had taken two bicycles which had been left in the yard overnight.

On Monday, June 12<sup>th</sup> at approximately 4:26pm officers received a theft of bicycles complaint which occurred in the 1400 block of Manor Terrace. The complainant reported that person(s) unknown had stolen two bicycles around spring break time earlier this year.

On Monday, June 12<sup>th</sup> at approximately 7:20pm officers responded to a report of a disorderly male subject at a residence in the 1200 block of Hwy H. At the conclusion of the investigation a 36-year-old male subject was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and bail jumping have been forwarded to the Walworth County District Attorney's office.

On Sunday, June 18<sup>th</sup> at approximately 1:44pm officers responded to a report of a motor vehicle theft which occurred in the 1200 block of White Pigeon Road. The vehicle has been recovered and returned to the vehicle owner. A male subject who had taken the vehicle remains at large and the investigation of the motor vehicle theft continues.

On Monday, June 19<sup>th</sup> at approximately 7:38pm officers responded to a bail jumping complaint which occurred in the 1200 block of Beechwood Road. At the conclusion of the investigation charges of bail jumping and theft-movable property have been forwarded to the Walworth County District Attorney's office for a 27-year-old male from Silver Lake which had fled the area prior to the officers arrival.

On Tuesday, June 20<sup>th</sup> at approximately 12:27am officers responded to a report of a moped crash in the area of Bloomfield Road and Hafs Road which had been located by a Walworth County Sheriff's Deputy on patrol. At the conclusion of the investigation a juvenile was issued non-traffic citations for possession of marijuana, possession of drug paraphernalia and curfew.

On Tuesday, June 20<sup>th</sup> at approximately 10:46am officers responded to an operating motor vehicle without owner's consent which occurred in the 1200 block of Beechwood Road. At the conclusion of the investigation a 27-year-old male from Silver Lake was arrested and confined in the Walworth County Jail. Charges of take and drive without owners consent, battery, disorderly conduct and bail jumping have been forwarded to the Walworth County District Attorney's office.

On Monday, June 26<sup>th</sup> at approximately 5:43pm officers received a theft from motor vehicle complaint which occurred in the 1300 block of Lake Geneva Hwy. The complainant reported that person(s) unknown entered their unlocked vehicle and stole several items.

On Tuesday, June 27<sup>th</sup> at approximately 11:49am officers received a theft from motor vehicle complaint in the 1800 block of Hwy 120. The complainant advised that a rear license plate had been stolen sometime during the month of June which could have occurred in Wisconsin, Illinois, Indiana or Michigan as the work vehicle had been driven in all of the states during the month of June.

On Wednesday, June 28<sup>th</sup> at approximately 3:08pm officers received a family trouble complaint which occurred in the area of Geranium Road and Daisy Drive. At the conclusion of the investigation a 42-year-old female was arrested and confined in the Walworth County Jail. Charges of operating a motor vehicle while intoxicated 4<sup>th</sup> offense w/ a minor child passenger and operating a motor vehicle with a prohibited alcohol concentration have been forwarded to the Walworth County District Attorney's office.

During the month of June 2017 the Bloomfield Police Department responded to 810 calls for service compared to 740 calls for service during the month of June 2016. During the month of June 2017 the police department affected 89 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 89 arrests during the month of June 2016.
