West District Commissioner, Kyle White has meetings with the Tri-County Health this week and will sign checks for Region D Recycling.

East District Commissioner, Chet Owen attended the Main Meeting and all will attend the NW Commissioner's meeting in Mound City this week.

Ronnie Pearl & Warren McElwain of the Maysville Endowment Committee met with the Commission to inquire about placing a plaque with name plates for historical patrons of the community.
