ORDINANCE NO. 584.

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF BONDS OF THE CIPY OF GARNETT, ANDERSON COUNTY, STATE OF KANSAS, FOR THE PURPOSE OF PURCHASING AND CONSTRUCTING WORKS IN SAID CITY FOR SUPPLYING SAID CITY AND ISSUAND INHABITANTS WITH PLECTRIC LIGHTS. TO THE AMOUNT OF FIFTEEN THOUSAND DOLLARS (\$15,000) AUTHORIZED AT A SPECIAL PLECTION DULY CALLED AND HOLD IN SAID CITY.

of the electors voting voted in favor of the proposition to authorize the Board of Commissioners of said city of Garnett, to issue the bonds of said city of Garnett to the amount of fifteen thousand dollars (\$15,000) for the purpose of providing funds with which to purchase and construct works in said city for supplying said city and its inhabitants with electric lights:

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF GAENETT, KANSAS:

Carnett, Hansas, to the aggregate amount of fifteen thousand dollars (\$15,000) be and the same are hereby authorized and ordered issued for the purpose of providing funds to purchase and construct works in the City of Garnett, Kansas, for supplying said city and its inhabitants with electric lights. Said bonds shall bear date Hovember 1, A.D.1913, shall be fifteen (15) in number, numbered from one to fifteen (1-15) inclusive, of the denomination of one thousand dollars (\$1,000) each; shall each be due and payable absolutely twenty (20) years from the date thereof, said bonds shall bear interest at the rate of five per centum (5%) per annum, payable semi-annually on the first day of May and of November in each year, which interest installments shall be evidenced by and payable upon the presentation and surrender of proper coupons attached to each bond, and both principal and interest shall be payable at the office of the State Treasurer of the State of Kansas.

SECTION 2. That the said bonds and coupons shall be substantially in the following forms, to-wit:

KNOW ALL MEN BY THESE PRESENTS, that the CITY OF GARNETT, in the County of ANDERSON and State of KANSAS, acknowledges itself to owe and for value received hereby promises to pay bearer the sum of ONE THOUSAND DOLLARS, lawful money of the United States of America, on November 1, 1933, together with interest on said sum from the date thereof until paid at the rate of five per centum (5%) per annum, payable semi-annually on the first day of

May and of Hovember, in each year, upon presentation and surrender of the interest coupons hereto attached as the installments thereof each severally become due; both principal and interest payable in lawful money of the United States of America at the Fiscal Agency of the State of Kansas, at the office of the State Treasurer, in the City of Topeka, Kansas. And for the prompt payment of the principal and interest of this bond as the installments thereof severally become due, the full faith, credit and resources of said city are irrevocably pledged.

THIS BOND is one of a series of bonds issued by the said city for the purpose of providing funds for purchasing and constructing works in said city to supply said city and its inhabitants with electric lights, authorized by more than a majority of the qualified electors of the said city at an election duly called and held therein, and in all respects in full compliance with the requirements of law including the provisions of an Act of the Legislature of the State of Kansas entitled: "AN ACT authorizing certain cities to issue bonds for natural gas, water, light and heating purposes," approved March 4, 1905, and all acts of the Legislature amendatory thereof and supplemental thereto, and the provisions of Chapters 75 and 123 of the Laws of 1913, and pursuant to the provisions of an ordinance duly passed by the Board of Commissioners of the said City. And it is hereby certified and recited that all acts, conditions and things required by the laws of the State of Kansas to be done precedent to and in the issuance of this bond have been properly done, happened and been performed in regular and due form and time as required by law, and that the total indebtedness of said city, including this bond, does not exceed any constitutional or statutory limitation.

IN TESTIMONY WHEREOF the said City of Garnett, by its Board of Commissioners, has caused its corporate seal to be hereunto affixed, and this bond to be signed by its Mayor, and attested by its City Clerk, and each of the interest coupons hereto attached to be executed either by the original or lithographed fac-simile signatures of said Mayor and Clerk this First day of Hovember, A.D. 1913.
