REGULAR MEETING - Call to Order

The regular meeting of the Board of Pilotage Commissioners was convened at 10:05 a.m. by Vice Chair Ned Kiley.

Minutes. Motion: Thompson/Adams – approve the September 21, 2017 Minutes as written – Carried.

BPC Staff Report.

- ➤ Puget Sound Pilot Captain Peter Giese officially retired on 10/13/2017. The Board thanked him for his service and wished him well in his retirement. Captain Phil Hunter was licensed as of the same date and has been actively working since licensure.
- ➤ JTC Study Update Board Chair Sheri Tonn will give a presentation about the Board of Pilotage Commissioners to the Joint Transportation Committee (JTC) on Wednesday November 15, 2017. A copy of the presentation will be available for Board review at the November 9, 2017 regular monthly meeting. The study's consultants, Spender Cohen, CAI, and Mark Gleason, Gleason & Associates, met with former Board Executive Director Peggy Larson last week. They are interested in talking with any Commissioners who are interested.
- On October 13, 2017, Sheri Tonn and Jaimie Bever participated in a call with a consultant hired by the USCG regarding pilotage tariff rate setting and pilot compensation. The consultants are conducting the study as a result of the legal action filed by the Great Lakes pilots, who are regulated by the USCG.
- ➤ Jaimie Bever attended the October 4, 2017 Puget Sound Harbor Safety Committee meeting in Everett, WA. She plans to continue to bring Board presence to those meetings going forward. Board Commissioner, Eleanor Kirtley, gave a presentation at that meeting about the organization she works for, Green Marine.

WAC 363-116-185: PILOTAGE RATES FOR THE GRAYS HARBOR PILOTAGE DISTRICT. RCW 88.16.035(1)(e) requires the Board of Pilotage Commissioners to annually fix the pilotage tariffs. Financial data used in this tariff hearing included GHPD 5-year Capital Spending Plan, the unaudited 2016 Financial Statement, and financial data as of July 31, 2017. The filed rule as proposed by the Port of Grays Harbor reflects the decrease to the Pension Charge from \$528 to \$500. No other tariff adjustments were requested. The filing was based on a request dated August 17, 2017 submitted by Mary Nelson, Director of Finance and Administration for the Port of Grays Harbor, which details their request for the rule amendment. A formal written tariff proposal was submitted on September 19, 2017. Oral and written testimony in support of the proposal was presented by Captain Mike Moore on behalf of the Pacific Merchant Shipping Association. The public hearing was closed by Vice Chair Kiley at 10:55 a.m.
