**NEW SCHOOL BUSINESS:**

The Stratton Board unanimously agreed to hold a public meeting on January 15, 2019 at 7 P.M. at the Town Office to adopt an addition to section F16 of its Tuition Payment policy by adding section 3C that states as follows:

Tuition shall only be paid to receiving schools that enroll any and all students deemed to be a resident of the District. No tuition payment shall be made to any school that limits enrollment based on special education eligibility, a student impairment or disability or race, religion, ethnicity, national origin, sexual orientation, gender identity, gender or other protected characteristic.

The Board agreed to meet on January 29, 2019 to review and approve the Warning for the Annual School Meeting.

As there was no other business, Siobhan Young motioned to adjourn the meeting and Thomas Montemagni seconded. The meeting was adjourned at 8:39 P.M.
