SYSTEM DEVELOPMENT FEE

System Development fees are one-time charges assessed against each new customer or developer proportionately, by meter-size and type, to recover a percentage of the Districts past investment in the infrastructure that currently provides the excess or peak capacity for new customer to use. System Development fees are \$_____ per connection from the schedule below.

The number of connections in this development in accordance with the preliminary plan submitted to District is _____; In the event that the final approved plans or any modification thereof during construction with the consent of District shall change this number and the amount of the System Development fee will be adjusted and any increased amount shall be payable before approval and acceptance of the extension and/or service is provided. Fees shall be reviewed and adjusted periodically to recover District costs.
