Supervisor May called the board meeting to order at 7:00 p.m. at the town hall located at 3529 Rt. 20A, Warsaw, New York.

Supervisor May opened with the Pledge of Allegiance; all were thanked for attending the meeting. [There were no questions or comments from the audience.]

Supervisor May requested a motion to approve the Meeting minutes from March 11. On a motion from Mr. Flint, seconded by Mr. Boxler, to approve the previous meeting minutes. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Highway Superintendent Report Working on plan, 5 miles oil / stone, gravel on dirt, some on Wilder road, we have been cutting brush on wilder and Krotz and waiting for them to do the pipe. Returned the paper work for CHIPS, they will pull 20% back, hoping to get \$22,000 more. The was discussion regarding CHIPS. Completed the training course Dig safely, refresher and Jeff took the entire course. The mowing tractor is ready. The record of activity NYS retirement, was discussed. 206 had an injector blow and gasket, ABS-J brake did not work - \$1200.

Town Clerk Report: Our Town website visits for March 2021 was 1632. The Towns total revenue for the month of March 2021 was \$1,099.00: \$795 for Zoning, \$189.00 for dogs, \$25.00 for DEC, \$70.00 for Registrar and \$20.00 for late fees. We had 18 dog renewals and 1 new dog license. To the general fund, \$947.38, Dogs were \$61.00, \$20.00 for late fees, \$1.38 for DEC, \$70.00 for registrar fees and \$795.00 for Zoning. We disbursed \$105.00 to Wyoming County, \$23.00 to Ag and Markets for dogs and \$23.62 to DEC. The Board discussed and resolved to order a new laptop for the Clerk, as it no longer will update to new system. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May discussed the information that Mr. Len Knaggs will be moving late summer or fall. The Board is very appreciative for all of Mr. Knaggs service to the town. Ms. Montgomery has also sold her home and maybe relocating out of state. Ms. Lisa Perez has accepted a position to train as bookkeeper. The Board will discuss compensation. Mr. Duane Christ has resigned his position on the ZBA, with regret.

Supervisor May discussed the Spectrum franchise agreement and requested a motion to hold a public hearing on May 13, 2021 at 7:30pm to discussion agreement. On a motion by Mr. Ahl, seconded by Mr. Flint to hold a public hearing on May 13, during the regular scheduled Board Meeting. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May requested a motion to approve the 2021 Highway Fund Bills: Abstract #4 Vouchers #44 through #61 totaling \$48,591.33. A motion was made by Mr. Ahl, seconded by Mr. Boxler to approve the payment of the Highway Fund bills. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May requested a motion to approve the 2021 General Funds bills: Abstract #4 Vouchers #49 through #67, totaling \$19,541.77. A motion was made by Mr. Herman, seconded by Mr. Flint to approve the payment of the General Fund bills. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried
