Problems with the Putnam County Convention Visitor Bureau

Coweta told the Audience after reading all the information that came from the Putnam County Convention & Visitor Bureau and the acting 11 member visitors Bureau board and with the action of Greencastle. Coweta feels the Town should follow suit and disbanding the current Cloverdale Appointees. (Don Gedert, Dick Wells and Rick Patel). But she also stated that she invites them to submit a letter asking to be reappointed back to the board. The issues that was stated in the Letter from Alan Yackey could be corrected to have a legally ran board. Coweta asked if anyone had comments. Gary asks how the current employees would be paid. Alan told the audiences the County Commissioner were doing and audit and was taking care of the payroll. When will the new appointees be appointed? Alan again told the audience the County commissioner was taking application and to fill those position ASAP. The Greencastle appointees are made by the Mayor and she too is accepting application at this time.

Alan stated another issue that needs to be corrected is the terms of the appointees. With Cloverdale having three appointees and Greencastle having three appointees. Do you want a 1 year 1 year and 2 year term, or a 2 year 2 year 1 year term cause Greencastle will take the opposite and the Mayor states she did not care?

Alan told the council first thing is to make a motion to disband the current appointee. Coweta ask for a motion and Don said after reading the 16 page documentation and to sum it up the County commissioner remove all there appointee to correct the problem Don Feels we should do the same to vacate and take application. Cindy 2nd the motion and the Vote was three to one to vacate the no vote was from Gary Bennington.

Now a Motion to have a stager appointee Cloverdale having a 1 year 1 year 2 year or a 2 year 2 year 1 year. Coweta wants a 1 year 1 year 2 year. Cindy wants a 1 year 1 year 2 year. Don wants a 2 year 2 year 1 year and Gary wants a 2 year 2 year 1 year having a tied vote the Clerk Treasurer broke the tie by making it a 1 year 1 year 2 year stager appointment for Cloverdale.

Cloverdale will now be asking for application from the county to fill the three vacate seats and will be discussed at the next town council meeting on May 12th 2015.

Mr. Hardwick spoke at the meeting telling the council he was on the board and had to get off because of Don Gedert and Dick Wells unprofessional in running the board not giving information to the board about financial information. He also strongly added that Mr. Patel was great and should be reappointed.

Town Manager came before the council to get approval of the decal to put on the town trucks along with numbering them. Motion to approve was made by Gary and 2nd by Don Vote was unanimous.
