THIS PRESTIGIOUS ANNUAL JURIED EXHIBIT & SALE is open to all artists residing on the Delmarva Peninsula, (MD, DE and VA), and members of Working Artists Forum. Artists who work in oil, acrylic, watercolor or pastel—either studio or plein air— may apply. Artists who have been juried into the Plein Air Easton Competition 2020 **are not eligible** to apply.

TO ENTER

All applicants must enter online at workingartistforum.com. Submission is open **February 8 – March 20, 2020**. Three digital images are required for jurying (applications with more or less will be returned unprocessed). Submit high quality images (painted within the last three years) in jpeg format (size range 1-2MB). Crop to show art only, remove background. Title each image file using initials, title of work and image number with no spaces between. Example: Jane Doe, Lovely View, #1: (jdlvelyview1.jpg). A non-refundable fee of \$35 is required at entry. Most credit cards and Paypal are accepted. All entrants will be notified (by email) April 10, 2020.

IF ACCEPTED

Each artist has an exhibit space of 6'x6' to display only original, two-dimensional, studio or plein air paintings, in acrylic, watercolor, oil or pastel. All work must be gallery framed and wired, priced to sell for \$250 or more. All artwork must have been completed within the last 3 years. Each artist will be charged a nonrefundable hanging fee of \$25 due upon acceptance. Working Artists Forum charges 30% commission for sales occurring during or as a result of Local Color.

EXHIBIT SCHEDULE

Local Color is held in the Crystal Ballroom of the Tidewater Inn in Easton, MD. Participating artists must hang their own paintings, with their own materials and hardware. Sold paintings should be replenished throughout the weekend.
