Cleaning and Disinfection Guidelines

This document is brought to you by Virox™ ProBeauty. Review your state regulations below and learn how Rejuvenate™ disinfectants will help you achieve compliance.

General Requirements*

- ◆ Establishments and schools shall have disinfectant solution, mixed according to manufacturer's directions, available for use at all times.
- ◆ Establishments shall have containers of disinfectant solution for disinfecting tools and equipment labeled "Disinfectant Solution".

Disinfecting Non-Electrical Tools*

- ◆ Before use upon a client, all non-electrical tools that can be disinfected shall be disinfected in the following manner:
 1. Remove all visible debris.
 2. Clean with soap or detergent and water.
 3. Completely dry tools with a new, clean paper towel.
 4. Then totally immerse in an EPA-registered disinfectant with demonstrated bactericidal, fungicidal, and virucidal activity, used according to manufacturer's instructions.

Disinfecting Electrical Tools*

- ◆ Clippers and other electrical tools shall be disinfected prior to each use in the following manner:
 1. Remove all visible debris and disinfect with an EPA-registered disinfectant spray or wipe with demonstrated bactericidal, fungicidal, & virucidal activity used according to manufacturer's instructions.
 2. All disinfected electrical tools shall be stored in a clean place.
 3. All soiled electrical tools, shall be placed in a container labeled "Soiled", "Dirty" or "Contaminated".

Cleaning and Disinfecting Foot Baths*

- ◆ After use upon each client, each foot bath shall be cleaned and disinfected in the following manner:
 1. All water shall be drained and the inside shall be cleaned with a clean brush, liquid soap and water.
 2. The foot basin or tub shall be rinsed with clean water.
 3. Disinfect with an EPA-registered hospital disinfectant which the label claims is a bactericide, fungicide, and virucide.
 4. Drain, rinse and wipe the basin dry with a new, clean paper towel.
 5. Record this procedure in the pedicure equipment-cleaning log.
