## 7. HANDLING AND STORAGE

**PRECAUTIONS FOR SAFE HANDLING:** Put on appropriate personal protective equipment (see Section 8). Avoid exposure - obtain special instructions before use. 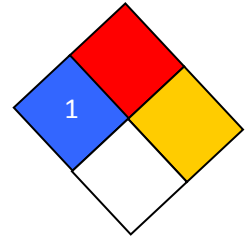
