PRIVACY STATEMENT

The National Dart Association (NDA) values your privacy. This privacy statement explains how NDA may collect and use information obtained about you from your visits to our website. This website does not collect any personally identifying information about you except when specifically and knowingly provided by you.

If when visiting the NDA website you ...

1. Read or Download Information

You can browse our website without entering any personal information and therefore remain anonymous during your visit. We may use your IP address to help us diagnose problems with our server, to administer our website, and to gather broad demographic information for aggregate use.

2. Send Us an Electronic Mail Message
