James River – Balcony Falls Take-out (Amherst County): FORVA has the VDOT permit for the entrance off Rt 501. Our next event is a meeting with the US Forest Service on Oct 14. That meeting is to learn our next steps in obtaining a Forest Service permit. Stay tuned. --- Bill Tanger, Tom Miller & Howard Kirkland

Roanoke River – Rutrough Point Access (Roanoke County): Repaired rock wall damages done by Hurricane Michael. Using rocks twice as big, the wall is now twice as strong! We planted 7 trees along the riverbank and put in a fence to protect them. Still working on planting more “live stakes”. --- Bill Tanger

Pigg River Dam Removal (Franklin County): The Pigg River runs free, except for one huge logjam! We recently removed two 250 ton logjams that caused massive erosion. --- Bill Tanger FFV: Mo Byrd, Duck Stanley, Ray Williams & Pat Williams

New River - Price Park (Montgomery County): The 50-acre park along Stroubles Creek in Montgomery County is open. Now starting work on a pedestrian bridge across Stroubles Creek. Volunteers welcome.---Randi Lemmon and Bill Tanger

Blackwater River: FORVA just bought 4 acres for an access on the Blackwater River in Franklin County. Hope to get reimbursed with a grant and turn over to the county. -- Bill Tanger

Roanoke River – Blueway (Roanoke County): FORVA is co-chair of the Roanoke River Blueway Committee. Working on improved access at the Salem Wayside location. --- Bill Tanger & FFV Roanoke Chapter

Big Otter River (Bedford County): Still working on access purchase on the Big Otter River near Rt 460. FORVA made an offer on the property of \$7,500. The seller is agreeable but must clarify some legal issues. Stay tuned.

Tinker Creek Restoration: (Roanoke City): Major restoration project on Tinker Creek in Roanoke coming up after 50,000 fish killed in 2016 due to chemical spill. Restoration includes plan to remove three dams. Waiting on the US Fish & Wildlife to award funds. ----- Bill Tanger

Blackwater River (Franklin County): Buying an acre of land at the Rt 122 crossing of the Blackwater River to provide parking for river access plus a possible camping spot.--- Bill Tanger; FFV: Pat Williams, Ray Williams; Creek Freaks of Franklin County

Blackwater River (Franklin County): Working on removing a dam on the Blackwater River. Doing early survey work starting in December. We have the funds already to go.

AW American Whitewater - Sep/Oct 2020

I have pulled an excerpt from the latest AW magazine, which features the Safety report that is done each year. We might consider having an FFV Safety Chair. ----- Bill Tanger

“Life Vests Not Worn:

Life vests are essential for safe river paddling and swimming. People who fail to wear PFDs on the river put themselves at risk. We have reports of 11 accidents that could have been prevented if the victim had been wearing a PFD, including 6 rec-kayakers, 4 rafters and an I K paddler.

Almost all of the deaths occurred in easy whitewater with only one in Class III, at Balcony Falls on the James River in Virginia. The stories are distressingly similar: a paddler flips unexpectedly after hitting a rock, turbulence, or nothing in particular and disappears underwater. The body turns up hours, and sometimes days, later.

Three of these deaths occurred on Washington’s Spokane River within a few days of each other. This section has fast current and small waves, but no real obstacles. The water is very cold. In one instance a man swam out to help two kids who had capsized a kayak. They were wearing life vests, and survived. The man was not so equipped, and drowned. Two others drowned on Oklahoma’s Illinois River, a popular float trip with a few easy rapids that was running high at 6,000 cfs.”

The Founding of FFV by REB Stewart III

Most organizations are founded to fill a need. I needed a shuttle – enough people to handle put-in and take-out duties and everything in between.

The first safety rule of American Whitewater is “NEVER PADDLE ALONE”. In addition to safety, it is great to have some good friends along on your paddling adventures.

My first whitewater was in 1948 in a wood and canvas canoe. I fell in love with this sport which took me into scenic places with lots of fish. Years later I joined the Coastal Canoeists Organization. What a wonderful club! They taught me a lot about serious whitewater paddling and exploring Central Atlantic rivers. However, I had a problem with the Coastals. I was an avid fly fisherman and the never slowed down long enough for me to fish. They raced from rapid to rapid so I found a second need for an organization – shuttlers and paddlers who loved to fish. The FFV concept began to come together. Virginia was ready for a canoeing and fishing club.

I made a list of all of my disreputable fishing, hunting and backpacking/wilderness camping buddies. I began calling them for a couple of weeks seeking interest in what I called the Float Fisherman of Virginia. (As far as I know, it was and still is the only such organization in the world).

In January of 1971 seven friends showed up at my home: The historic Harrt House at 320 Court Street in Old Town Portsmouth, VA. Only four of the eight founders continued to play a role in the early days. Three of the other four purchased coastal waterfowl properties on the Eastern Shore. The fourth friend went under cover in the State Police. I consolidated my hard core four of us who became the heart and soul of FFV.

Pete Pine, an Englishman who was a spitfire ace in the Royal Airforce in WWII. He was shot down and spent the rest of the war in Stalag Luft 3. Pete was one of the characters portrayed in the classic war movie "The Great Escape". More about him in the future articles.

Jack Albert was from Bedford. He was a great athlete and scholar who got a scholarship at W&L. He left early to serve his country and became an MP in the Air Force. Upon discharge, he accepted a job as a Virginia State Trooper. After a distinguished career, he flunked his eye exam and wound up as a legal investigator for the famous personal injury firm Banger, Bangel and Bangel. More on this legend later.

Joseph Lee Wiseman was a Southern Baptist Preacher. He was the most kind, mild mannered and ethical man I ever knew. That is why I nicknamed him "Wildcat" early on. After seminary, Joe discovered that he could make a better living as an accountant than preaching. He was a good vocalist and played a classic D-18 Martin Guitar. He could sing and yodel all of the classic songs of the iconic Jimmie Rodgers, the father of country music. More on Wildcat later.

Jack was our first VP. Wildcat was our secretary/treasurer and they elected me President. Everyday at lunch my business partner and I planned floats and strategies to grow FFV. All of a sudden it boomed. We had our shuttle and more.

Though it's been almost two years since we've had the pleasure of gathering for a good boil, I can still taste spicy corn and crawdad meat. The truth is, the Float Fishermen are a staple for the Pearson family. For our Virginia family scattered throughout Charlottesville, Stephens City, and Harrisonburg, R5 in Remington is our rally point.





SLATE RIVER PROPERTY - Address for GPS

10330 Bridgeport Road
Arvon, VA 23004

From Richmond:

Take Route 6 River Road West (from downtown that's 64 West to the Oilville exit South on 617 Oilville Road, right on 250 West Broad Street Road, Left on 632 Fairgrounds Road, right on Route 6, go West), follow to Fork Union, stay straight on Route 15 James Madison Hwy, cross the James, after roughly 1.5 mi. take a right on Route 652 and cross the Slate River. Driveway will be first left.

From Charlottesville:

Take Route 20 South through Scottsville and across the James River. Turn Left onto Route 652 (Bridgeport Road). Follow approximately 9 miles and turn right into field. If you cross the Slate river, you have gone a half mile too far

From Lynchburg:

Take Route 60 East to Route 15 (James Madison Highway)North. Turn left on Route 652 (Bridgeport road) at Arvon. Route 652 and cross the Slate River. Driveway will be first left.
