

Bloomfield Police Department

Monthly Report for September 2017

This is the monthly report for the Month of September 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, September 3rd at approximately 11:04pm officers responded to an address on Oakwood Road for a report of a hit & run accident. At the conclusion of the investigation charges of reckless endangering safety, hit & run injury, battery and disorderly conduct were forwarded to the Walworth County District Attorney's office for a 24-year-old male who fled from the scene. On Wednesday, September 6th the male driver turned himself in and was confined in the Walworth County Jail.

On Tuesday, September 5th at approximately 5:15pm officers responded to a disturbance at Friends on the Lake located on N. Lakeshore Drive. At the conclusion of the investigation charges of disorderly conduct and bail jumping have been forwarded to the Walworth County District Attorney's office for a 40-year-old male who had been involved in the disturbance.

On Tuesday, September 5th at approximately 8:07pm officers executed a traffic stop on Clover Road for a speeding violation. At the conclusion of the traffic stop a 24-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver received traffic citations for speeding and operating after revocation.

On Thursday, September 7th at approximately 8:23am officers responded to the area of Daisy Drive and Twin Lakes Road for a personal injury crash. At the conclusion of the investigation a 94-year-old female was issued a citation for failure to yield while making a left turn.

On Saturday, September 9th at approximately 11:58pm officers executed a traffic stop on Hwy 50 for operating wrong side of a divided highway. At the conclusion of the stop it was determined the 55-year-old male was not impaired and was issued a citation for the violation.

On Sunday, September 10th at approximately 12:40am officers executed a traffic stop on Hwy 12 for an improper left turn from Pell Lake Drive onto the on ramp. At the conclusion of the stop a 19-year-old male was issued traffic citations for improper left turn; operate a motor vehicle without insurance and non-traffic citation for possession of drug paraphernalia.

On Sunday, September 10th at approximately 8:24pm officers responded to a residence on Maple Road for a report of a disturbance. At the conclusion of the investigation a 33-year-old female was arrested and confined in the Walworth County Jail. Charges of disorderly conduct, criminal damage to property and resisting/obstructing a police officer have been forwarded to the Walworth County District Attorney's office.

On Wednesday, September 20th at approximately 3:50pm officers responded to Hwy H near Daisy Drive for a personal injury crash. At the conclusion of the investigation a 46-year-old male was issued citations for operating without a valid driver's license and following too closely.

On Friday, September 29th at approximately 9:43pm officers responded to a report of a reckless driver in the area of Geranium Road and Pell Lake Drive. Officers located the vehicle and executed a traffic stop. At the conclusion of the traffic stop a 21-year-old male was issued a non-traffic citation for possession of drug paraphernalia.

On Friday, September 29th at approximately 11:21pm officers executed a traffic stop on Hwy H in the area of Lake Geneva Hwy after receiving a report of a possible impaired driver. At the conclusion of the traffic stop a 30-year-old female was arrested and confined in the Walworth County Jail for operating a motor vehicle while intoxicated 2nd offense. Additionally, the driver was issued traffic citations for open intoxicants in a motor vehicle and speeding.

During the month of September 2017 the Bloomfield Police Department responded to 1025 calls for service compared to 668 calls for service during the month of September 2016. During the month of September 2017 the police department affected 112 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 95 arrests during the month of September 2016.
