Entry Fee Information:

Entry fees should not be less than \$30.00 per contestant per event and all entry fees shall be the same for all events. All entry fees are to be added to the purse. Prize money and entry fees over the minimum are to be decided by the individual rodeo committees and the SDRA Board of Directors. Gate admissions can be charged for slack and team penning that are held outside of a performance and collected in the office at time of contestant paying entry fee.
