**AN ORDINANCE AMENDING ORDINANCE NO. 2013-11 ENTITLED
"AN ORDINANCE REGULATING THE SALE OF ALCOHOLIC LIQUOURS
FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS" AND PROVIDING FOR
THE ISSUANCE OF A GOVERNMENT FACILITIES LICENSE**

BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

Section 1: Ordinance No. 2013-11, as previously amended, is further amended by the addition of the following new subparagraph (11) to paragraph (a) of Section 15:

(11) **A "Government Facilities" ("GF") license shall permit the sale of alcoholic liquor for consumption on the licensed premises and shall be granted only for an enclosed premises which is owned by a unit of local government (including the Village of Chapin), Morgan County, a school district, or special district. The fee for a GF license shall be \$250; provided, however, that the Village of Chapin shall be exempt from paying the fee.**

A class "GF" license shall permit sales for consumption on the licensed premises as follows: from 6:00 a.m. each Monday through Sunday until 1:00 a.m. on the following day.

Section 2: Ordinance No. 2013-11, as previously amended is further amended by deleting paragraph (f) of Section 15 in its entirety and replacing it with the following new paragraph (f) of Section 15:

(f) **Except for "Special Event" licenses, for any license issued on and after July 1 of any calendar year and for which a license fee is required to be paid, the license fee shall be one-half of the amount specified in this section, but there shall be no further fractional division of the license fee payable under this Ordinance. All license fees shall be payable in semiannual installments in advance on or before the first day of January and the first day of July each calendar year.**

Section 3: Ordinance No. 2013-11, as previously amended, is further amended by the addition of the following new subparagraph (2) of paragraph (l) of Section 6:

(2) **If a "GF" license has been obtained by the Village of Chapin for the sale of alcoholic liquor in accordance with the provisions of this Ordinance, then**

possession by a person, age twenty-one (21) years or older, of alcoholic liquor while inside the licensed premises shall not be unlawful.

Section 4: Ordinance No. 2013-11, as previously amended, is further amended by deleting paragraph (c) of section 18 in its entirety and replacing it with the following new paragraph (c) of section 18:

(c) **Limitation on number issued. No more than a total of five (5) Class "A", "B", "C", "D", "E", "Club", "Bowling Alley" and "BH" licenses shall be issued at any time. No more than three (3) "Special Events" licenses shall be issued for any one date. No more than two (2) GF licenses shall be issued at any one time.**

Section 5: This ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form. The Village Clerk is directed to immediately publish this ordinance in pamphlet form.




