Contract

The People for Leisure and Youth, Inc. (PLAY, Inc.) wishes to contract with you and/ or your Band to perform for the 2025 NEXT UP event on Saturday, June 21st during the time frame between 1:00- 6:00pm located at 224 W. Chapel St, Teresa Machado Plaza.

By submitting an application, the Artist/Artists have indicated they will accept a position in the lineup **if so offered**. Therefore **if offered** a position, Artists **MUST** abide by Terms(see below) gone over in contract to win Grand prize, those who do not abide will be disqualified from the competition and future competitions.

Terms

1. Lyrics cannot contain profanity, derogatory remarks, sexually explicit content or violence, those who cannot abide by these terms may be terminated by select Judges.
2. Must bring your own equipment- except Mic
3. Staff Selected judges will choose the Top 4 Finalists, Winners will be voted and determined by select judges the day of the event, after the concert.
4. 2 Stages to perform on.
5. 15 minutes for each band to play, bands will alternate from each stage giving clean up and set up time.
6. Event starts at 1:00, first band starts/concert starts at 1:30.
7. Grand Prize Winner/Winners will have the opportunity to be the opening act for final Concert In the park event as well!!
8. Originals are encouraged!! Covers are allowed as well.

PLAY, Inc. will publicize the band in all promotional materials where the NEXT UP event lineup is displayed and will have use of promotional materials provided by the band for advertising. In addition, PLAY, Inc. will offer promotional opportunities when available.

PLAY, Inc. will provide a stage*, electrical outlets, introductions and access for loading and unloading equipment.

* Sound System and additional stage equipment must be provided by Band.

Band

Band agrees to play on date assigned: **Saturday, June 21st from 1:00- 6:00pm**

Band will arrive at designated location a minimum of **1 hour** before **EVENT TIME** on scheduled date / location assigned for set up and sound check. **Band may park and unload equipment on the grass near the stage but must remove all vehicles a minimum of 20 minutes before the event starts.**

Bands/ solo artists will begin playing at designated time and will play for 15 minutes max with 15 minutes max to tear down. All cover songs must be ASCAP or BMI approved. Band must submit a play list at least 3 weeks prior to event date for select staff to go over and approve.

Band will submit information to PLAY, Inc. a 150-word maximum biography for our announcer to share during opening statements.

Band will contact PLAY, Inc. immediately if a situation arises wherein band/solo artist is unable to perform.

Now, therefore, under the terms and conditions so set forth, the parties agree to abide by this contract and are legally able to so make such agreement on behalf of respective organizations.
