Town of Stratton Selectmen's Meeting

November 08, 2021

Present: Selectmen: Chris Liller, Greg Marcucci and Kevin Robinson; and Kent Young – Clerk.

Chris Liller, as Acting Chair, called the meeting to order at 7:30pm at the Stratton Town Office. Orders were reviewed and signed.

Modifications to the Agenda: The Selectmen agreed to add the following to the agenda: 1) Consider an Access Permit application 2) change to the Fire Alarm fee notice to Lapidus and 3) Tree Removal on North Rd..

Road Crew Issues: Flooding Event of July 29, 2021: Chris Liller stated that the damaged sections of the roads have been patch-paved. He believes the applicable guard rails will be installed this week and he intends to repair the culvert across the Underwood's property between Pikes Falls Rd. and County Rd. this week, as well. Winter Hours: The Foreman stated that the Road Crew is now on winter hours and he passed around the call-in schedule for this winter. Garage Lighting: Chris Liller stated that one of the fixtures in the main garage is not working properly. As a result of a discussion with the electrician, he would like to contact Efficiency Vermont for funding to replace it with an LED fixture, along with other various light fixtures in the garage and cold storage building. The Selectmen concurred. Koeppe Access **Permit Application**: Chris Liller had looked at said application and agreed it would be acceptable with a proper culvert. The Selectmen concurred and signed the application. North Rd. Tree Removal: The Clerk stated that he had spoken with Ray Hawksley regarding various trees in the Town right-of-way on said road, which need to come down - some of which have been flagged. Chris Liller said that he will look at trees along said road. Snowmobile Road usage: The Selectmen agreed to allow said usage with no changes from the previous year -1) Stratton-Arlington Rd. from Grout Pond Rd. to the Sunderland town line, 2) Grout Pond Rd., 3) Canedy Rd., 4) Ball Farm Rd., 5) Old Town Rd. and 6) Shepardson Rd.. Greg Marcucci so moved. Kevin Robinson seconded – all concurred.

Minutes: Greg Marcucci moved to approve the Selectmen's Minutes of October 25, 2021. Kevin Robinson seconded. All concurred and the minutes were approved.

Fire Dept. fees: The Clerk stated that he had sent the letter approved at the last meeting regarding this subject, to the wrong property owner in Stratton. He produced letters of correction to that previously approved Notice – a "disregard" letter to Marc and David Lapidus and a new Fee Notice to the actual owner of 6 *Pond Rd*. – Katheryn Lapidus. The Selectmen concurred and Chris Liller signed the two letters.

Adjourn: Greg Marcucci motioned to adjourn at 7:40 p.m.. Kevin Robinson seconded. All were in favor and the meeting adjourned.
