Patel, Mgr. and Sole Member), the CPC members voted to recommend to Cordele City Commission that the request be granted to amend the zoning for all of Lots 4 and 5, Parts of Lots 1 and 3, in Block 134, on the City of Cordele's Official City Maps be amended from Office and Institutional District (OI) to Highway Commercial District (HC).

To consider an amendment to the City of Cordele's Official Zoning Map as follows: All of the area bordering on 16th Avenue from the East side of 5th Street to the West side of Fleming Road should be amended from its current zoning of Office and Institutional District (OI) to Highway Commercial District (HC).

After a thorough discussion and consideration of all comments from the CPC members, the Codes Department Staff, Cordele City Manager, Angela Redding, and comments from some area property owners, the CPC members voted to recommend to the Cordele City Commission that the Zoning amendment to the City of Cordele's Official Map all of the area bordering on 16th Avenue from the East side of 5th Street to the West side of Fleming Road should be amended from Office and Institutional District (OI) to Highway Commercial District (HC).

The Cordele Planning Commission also held a discussion and considered an amendment to the Zoning Ordinance of the City of Cordele, Georgia to allow for Loft Dwellings in the Central Business District (CBD) and to establish rules and regulations regarding such dwellings and repealing all ordinances in conflict herewith and for other purposes.

After a thorough discussion and consideration of comments, questions, etc., the Cordele Planning Commission Chairman and members agreed to further review the pros and cons of this amendment to the Zoning Ordinance at a future CPC meeting.
