



Glenwood Terrace Homeowners Association Pool Rules (Revised June 2018)

The following rules and regulations are for the protection and benefit of all members. These rules have been established to assure safe and sanitary operation of the pool facilities. Parents are requested to caution their children to observe all rules. Any failure to comply with these rules shall be considered sufficient cause for immediate suspension of pool privileges for the offending member family for a period of time to be determined by the Board of Trustees.

Pool Hours

- Opening day is Saturday before Memorial Day and will stay open until Labor Day unless extended by the Board of Trustees, from 7 a.m. to 9 p.m.
- The pool may be closed for maintenance, health conditions, weather, or any reason deemed sufficient by the Board of Trustees.
- The **LAST** person to leave the pool area is to lock the gate.

General

- Members should drive slowly and carefully in the driveway and parking area. Do not park on the paved portion.
- Leave chairs and chaises in a neat and orderly arrangement. Close umbrellas at end of the day.
- Members will not be allowed access to the pool without fully paid dues. Keys must be returned along with bond for departing members. A \$5 fee will be charged for lost keys.
- Normally there is no lifeguard on duty. Parents are responsible for the safety of their own children and each other. There is no swimming alone.
- All persons using the pool facilities do so at their own risk. The GTHA is **NOT** responsible for accidents of injury in connection with such use.
- All members and guests must sign in and sign out.
- The GTHA is **NOT** responsible for loss or damage to personal property. Do not bring valuables to the pool; there are not facilities for checking them.

Health and Safety

- **Lightning:** Evacuate pool when lightning or thunder occurs. Return to pool 20 minutes after last lightning or thunder event.
- **When the lifeguard is not on duty, there must be at least one ADULT (18 years or older) present and parents are responsible for their children. There is no swimming alone.**
- **In the event of an emergency, call 911 and wait for assistance or travel to the Emergency Room - directions are posted in the glass case.**



- **All accidents and incidents are to be recorded in the log book located at the sign in area.**
- Soap, towels, **diapers**, and street clothes are not permitted in the pool.
- **Smoking and eating are not permitted in the pool.**
- **Admission is not permitted to anyone with a cold, cough, inflamed eyes, an infection, wearing bandages, or having a communicable disease.**
- **No pets** are allowed in the pool area.
- **State Law prohibits** glass containers of any kind in the pool area.
- No running, pushing, wrestling, or causing a disturbance will be permitted in or near the pool area, particularly on or near the diving board.
- Only one person at a time is permitted on the diving board. The lifeguard has the final say regarding flips off the diving board.
- **No oversized toys or tubes or metal, ridged, or dangerous toys are permitted.**
- No water guns, splash balls, or water balloons are permitted.
- All baby toys are to be kept in the baby pool or baby pool area.
- An adult must accompany non-swimmers using swimming aids or floating toys.
- All activities must be regulated so as not to cause a public nuisance. No abusive language is permitted. No alcoholic beverages are permitted.

Guests

- Guest fees are \$5 per guest, with a maximum of 6 guests per family, and the same guests may come only 3 times per season. If a large group of guests are planned, it is considered a party and you must hire a lifeguard.
- Each member bringing guests should sign them in, releasing the GTHA from any liability. **Guests must be accompanied by an adult member who assumes responsibility for their guest's actions.**
- Guests are to be invited in moderation, and must obey these rules and regulations.
- **Children under 14 may NOT bring guests unless accompanied by an adult.**

Children's Use of the Pool

- **Persons under the age of 18 must be accompanied by an adult when no lifeguard is on duty.**
- Children 12 to 18 must be able to swim one lap of the pool and tread water for one minute, to be left when a lifeguard is on duty.
- Use of the baby pool is limited to children **under** six years of age.
- An adult **other** than the lifeguard must supervise children playing in or near the baby pool.
- Swim diapers **must** be covered by plastic pants. Diapers are not allowed in pool.
- Children 5 and under must be accompanied by an adult to the bathroom. Please try to keep the bathrooms clean.



Wi-Fi

There is free Wi-Fi available at the pool. The network name and password are displayed in the glass case just outside the pump house by the hose/shower.

Lifeguard

- For specific pool events where a lifeguard is present, the lifeguard has the jurisdiction over the pool area while on duty. He/she is responsible for his/her actions and will receive instructions from and report to the Board of Trustees, and/or appointed lifeguard manager/liaison.
- Swimming during swim lessons (by those not taking lessons) is at the discretion of the lifeguard.
